INVESTIGATOR'S SUMMARY: Offender Adenleck Johnson TDCJ No. 623028  
states that members of the "Crips" and the Mexican mafia  
STG groups are both trying to make him "ride" with their  
gangs. Offender Johnson could only ID the possible enemies mainly  
by nick names; he could only provide one offender true  
name. Offender is requesting safekeeping.

Upon further investigation it was discovered that offender  
Johnson has made similar requests in the past and that  
they have been declined at his request to UCC. This offender  
has used his homosexuality as his reason to request protection in the  
past, as he does now. Offender Bail is not a known gang member  
and the offenders identified by nick name could not be positively  
identified.

No evidence was found to corroborate offenders claims.  
This report is being submitted to JA-UCC for final decision on offender request for  
safekeeping.
