Dear Mr. Gersten:

The American Civil Liberties Union (ACLU) requests an Office of Civil Rights and Civil Liberties investigation into an inappropriate intelligence report produced by the North Central Texas Fusion System, a fusion center which receives support from the Department of Homeland Security.

The February 19, 2009 "Prevention Awareness Bulletin" describes a purported conspiracy between Muslim civil rights organizations, lobbying groups, the anti-war movement, a former U.S. Congresswoman, the U.S. Treasury Department and hip hop bands to spread tolerance in the United States, which would "provide an environment for terrorist organizations to flourish." The bulletin, which reportedly is sent to over 100 different agencies, explicitly directs law enforcement officers to monitor the activities of these groups in their areas.

In addition to slandering innocent people and organizations, this document subverts democratic processes and chills free speech and association. We ask that your office investigate how and why this document was produced, to whom it was disseminated and whether any law enforcement action was taken by any agency in response. We further ask that you review other intelligence products produced by this or any other fusion center that utilizes DHS resources or personnel to determine the scope of the problem. Please inform us of remedial action taken or to be taken by DHS to ensure that this type of inappropriate material is not produced by fusion centers in the future.
