SUBJECT: Recommendations - AR 15-6 Investigation Re: EOF - 2-506 IN - 15 May 06

1. I have reviewed the above described investigation and recommend approval of the findings and recommendations. The local national was driving a vehicle that matched the description of a suspected AIF vehicle; and he was driving suspiciously after curfew with his lights off in an area of multiple previous IED attacks. I believe this individual was engaged in AIF activities during this EOF.
2. The Soldiers correctly applied escalation of force procedures and complied with the ROE. I recommend no adverse action be taken.
3. I agree with [REDACTED] that all patrols should have an interpreter and that patrols must gather evidence and intelligence at all scenes of suspected or confirmed AIF activity.

SECTION IV - FINDINGS (para 3-10, AR 15-6)

The (investigating officer) (board), having carefully considered the evidence, finds:

At 150245MAY06 the Scout PLT "Ghost 6" element from HHC 2-506 IN, assigned to A CO 2-506 IN, mission number 2261, conducted an EOF rehearsal before going on mission (Encl 8C). At 150300MAY06 they departed FOB Falcon with 3 M1114 uparmored HMMW-Vs and 14 pax, 9 of which were vehicle crew, 5 of which were an SKT team "Rogue 6" to be inserted to engage AIF in Dora, and no interpreter (Encl 6). The crews of the M1114s were: vehicle #1 TC SGT [REDACTED] driver SSG [REDACTED] gunner SPC [REDACTED] for vehicle #2 TC 1LT [REDACTED] driver SPC [REDACTED] and Gunner SPC [REDACTED] and for vehicle #3 TC SFC [REDACTED] driver SPC [REDACTED] and gunner SPC [REDACTED]. At 150340MAY06 they emplaced the scout SKT team vic grid [REDACTED] in Muhallah 824 in the Dora area of Southern Baghdad. At 150430MAY06, during curfew hours, vic [REDACTED] vic Muhallah 824 south of Route Sonics the patrol noticed a white van with no lights on travelling in the vicinity of the "Tier I IED site" that fit the description of a vehicle that had been seen emplacing IEDs (Encl 8 A, B & E). The patrol moved to the location of the white van and which had stopped at the entrance to [REDACTED] by two small buildings and had parked with its lights off. Vehicle #1 moved in front of the white van while vehicle two moved around the other side behind it (Encl 8B, D, E, F). Vehicle #1 signaled it with vehicle lights and the vehicle siren, a green laser from the gunner, a tac light from the gunner, the TC telling the occupant to get out of the vehicle through his siren, the TC getting out and showing his weapon with intent to use, and finally the driver and TC getting out and shouting at him to get out of the vehicle in English and Arabic (Encl 8D, E, & F). The vehicle occupant turned his vehicle lights on and began fumbling for something with his hands (Encl 8F). At this point members of vehicle #1 saw it was a single military aged male and based on the circumstances the patrol felt he was a threat (Encl 8D, E, & F). The vehicle began to back up and the TC SGT [REDACTED] told the gunner to fire the NL M203 round (Encl 8E, & F). The PL LT Graves who was behind the vehicle said it began to go back and forth in a very rapid manner (Encl 8B). As the vehicle backed up around a small building and moved on to [REDACTED] to get away when SGT [REDACTED] fired two warning shots with tracers that landed in front of the vehicle, and then as the vehicle drove onto [REDACTED] to get away SGT [REDACTED] fired one disabling shot into his left front tire and then a second disabling shot into his right rear tire (Encl 8B). At this point SPC [REDACTED] the gunner on vehicle #1, stated based on all the circumstances he thought the vehicle was a threat and was either a VBIED or the driver had just emplaced an IED and would detonate it (Encl 8F). After seeing that the vehicle was not disabled by the M4 fire from the TC, he fired one burst of 6 rounds of M240B 7.62mm fire to disable the vehicle, and after the vehicle kept going he fired another 6 rounds of disabling fire from his M240B 7.62mm machinegun in the attempt to disable it (Encl 8D, E, & F). At the same time the LN vehicle was fleeing vehicle #2 was moving to the side of it to attempt to flank it from the right (Encl 8B, G). SPC [REDACTED] saw the disabling shots from vehicle gunner #1 were not slowing the vehicle so he fired 3 warning shots to the rear of the vehicle from his M240B MG followed by 3 disabling shots to the left rear tire and 3 disabling shots to the right rear tire (Encl 8G). At this point the LN vehicle slowed to a stop and vehicle #1 moved forward behind the stopped white van and vehicle #2 with the Scout PLT LDR LT [REDACTED] moved around in front of the stopped white van (Encl 8B, D, E, & F). The TC for vehicle #1 SGT [REDACTED] began telling the occupant in the white van to get out of the vehicle through the loud speaker in Arabic and English but the driver did not move (Encl 8D, E, & F). At this point SSG [REDACTED] and SGT [REDACTED] were told by the PSG SFC [REDACTED] to move up to the PL's truck to link up for a search of the vehicle (Encl 8C). The search of the vehicle found nothing suspicious and that the LN inside was dead (Encl 8B, D, & E). SPC [REDACTED] got an interpreter from a reinforcing patrol, went and got the IPs, and helped them take the LN vehicle and LN to teh A1 Dora police station (Encl 8C). At about 150900MAY06 the scout PLT returned to the FOB (Encl 8D). Based on all the facts the BN S2 CPT [REDACTED] believes the van and driver were conducting AIF activities (Encl 8A). I concur.

In view of the above findings, the (investigating officer) (board) recommends:

1. Recommend continued EOF training for all units involved in the incident.
2. Recommend every patrol have an interpreter.
3. Recommend not dismounting from an M1114 during an EOF incident until after the subject driver and passengers have come out of their vehicle for safety purposes. Use an interpreter with a external PA system to give instructions to Iraqi LNs.
4. No UCMJ for anyone involved.

Findings:

1. The Scout PLT conducted an EOF rehearsal before leaving for the SKT emplacement mission (Encl 8C)
2. The unit stopped the LN vehicle because it was in the vicinity of a Tier I IED site, fit the description of a vehicle that had been suspected of emplacing IEDs, was driving during curfew, and had its lights off (Encl 8A, B, C, D, E, & F)
3. The unit perceived that the driver had hostile intent and thought he was driving a VBIED or emplacing IEDs because he refused to listen to them and get out of the vehicle, turned lights on and was doing something with his hands they could not see, moved his vehicle rapidly back and forth, and tried to break out of the cordon (Encl 8F)
4. The unit conducted all EOF measures IAW current guidance (Encl 8D, E, & F):
 1. Used vehicle lights and siren
 2. Told the driver to get out over loud speaker in Arabic and English
 3. Flashed tac lights
 4. Shined laser
 5. Driver and TC got out and said again in Arabic and English for driver to get out of the car
 6. Showed weapons with intent to use force
 7. Gunner fired a non-lethal M203 round
 8. TC from vehicle #1 and gunner from vehicle #2 fired multiple tracer warning shots
 9. TC from vehicle #1, gunner from vehicle #1, and gunner from vehicle #2 fired disabling shots as the vehicle sped away (either the MG fire from gunner #1 or #2 became lethal and the LN was killed it cannot be determined)
5. The LN was killed by either the MG gun fire from vehicle #1 or #2 as he tried to escape the cordon. (Encl 8F & G)
6. Based on all the circumstances both mystef and the BN S2 believe the LN was conducting AIF activity and therefore the EOF and all actions taken by the soldiers were justified. (Encl 8A)

SUMMARY OF INCIDENT: At 15 0500 MAY 06, SCT/HHC/2-506 IN was returning from infiltrating a small kill team when they encountered a LN vehicle (white Asia Topic van) on the side of [REDACTED] near the Dawra Market at [REDACTED]. The van was located in a Tier 1 IED site and resembled description of a van that was previously (within two weeks) seen emplacing an IED at similar time. The US patrol moved to investigate the vehicle and establish a hasty cordon around the vehicle. The LN vehicle began to move away from the US patrol. The US patrol's lead vehicle conducted EOF procedures and shouted to stop the vehicle and flashed the vehicle several times with their flashlight and attempted to signal the vehicle to stop. The lead M1114 moved around the LN vehicle and pulled in front of the vehicle. The scouts dismounted and attempted to stop the car. The vehicle continued movement away from the lead vehicle. The gunner in the lead vehicle fired a non-lethal M203 round at 20m toward the LN vehicle, but missed. The vehicle continued movement away from the US patrol and was engaged with 4 x rounds of 5.56mm SAF aimed at the vehicle's tires to disable the vehicle. The vehicle was not disabled and continued to attempt to evade the US patrol and was engaged with 20 x rounds of 7.62mm fire into the rear of the vehicle, striking the LN driver and killing him. There was only one occupant in the vehicle. The patrol secured the site and called for assistance in securing the site. The US patrol took photographic evidence of the incident site and secured the site until relieved by 1/D/2-506 IN. 0725 1/D/2-506 has relieved SCT and is awaiting IPs.

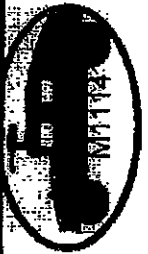

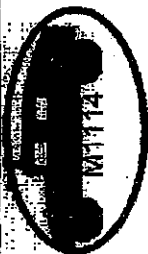

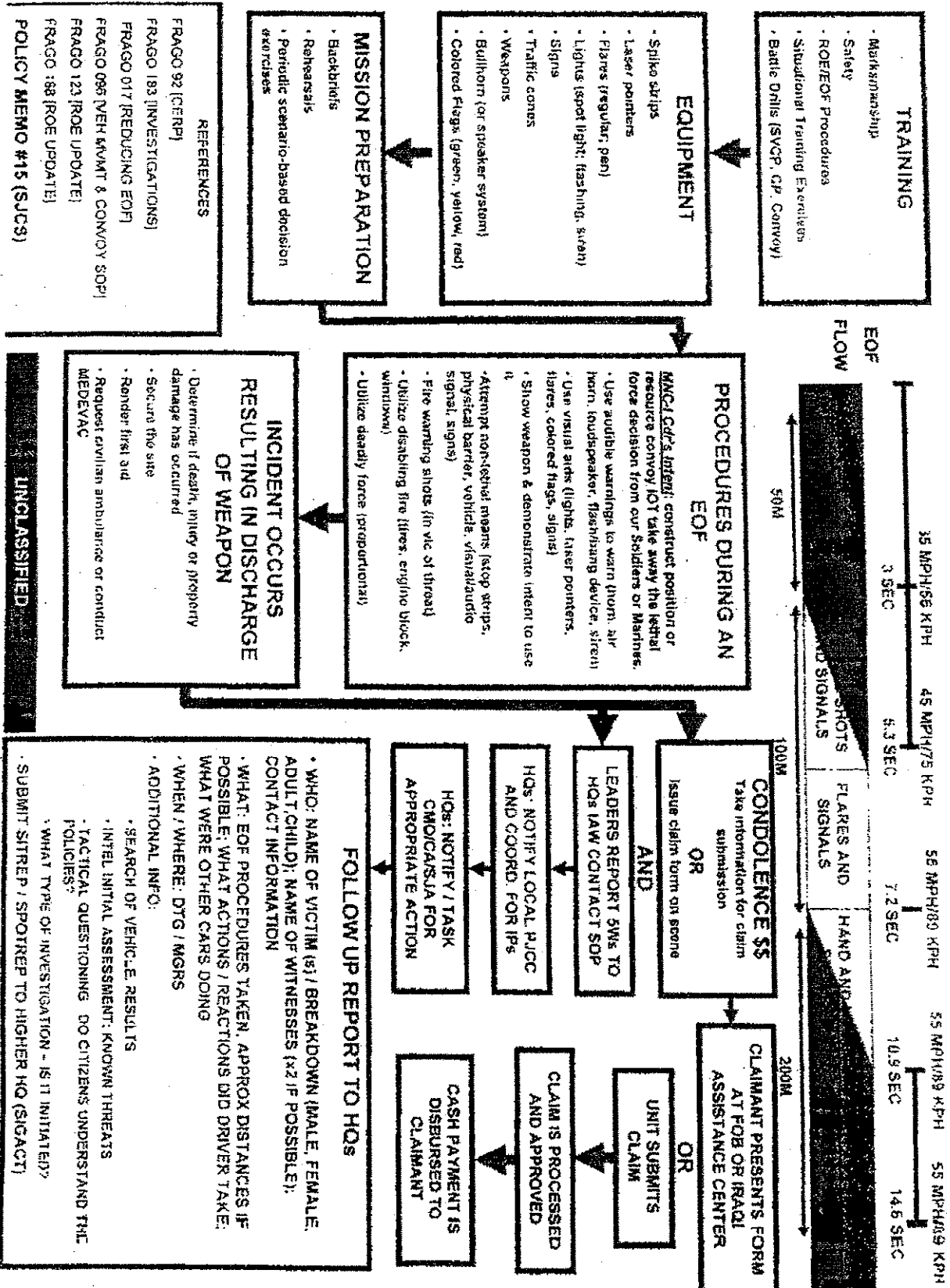

On the morning of 15 May 2006, an element from my platoon was moving into Zone 25 to emplace a small kill team for anti insurgent operations. We departed the FOB at 0300 hours in 3 M1114's. I was the patrol leader and the TC of the second vehicle in the convoy. My driver was SPC [REDACTED] and my gunner was SPC [REDACTED]. The TC of the lead vehicle was [REDACTED] the driver was [REDACTED] and the gunner was [REDACTED]. The TC of the trail vehicle was SFC [REDACTED] the driver was SPC [REDACTED] and the gunner was SPC [REDACTED].

At approximately 0340 hours, we dropped off the five additional passengers that comprised the small kill team into Muhalla 826. After inserting them into the Muhalla, we continued patrolling in the sector to provide a patrol presence until we were to be replaced by the next patrol element from A/2-506 at 0600 hours. At approximately 0430 hours, we were patrolling in Muhalla 822 heading South along the North/South running road that intersects [REDACTED] and the eastern edge of the Dora market, and my trail vehicle TC reported that he had spotted a civilian vehicle that was north of our position. My lead vehicle immediately began to conduct a three point turn to interdict the civilian vehicle. Once the lead vehicle had passed my vehicle, I instructed my driver to begin his three point turn so that we could reinforce the lead vehicle in his pursuit of the civilian vehicle. We caught up with the lead vehicle in the vicinity of [REDACTED] where the Dora Market intersects with [REDACTED]. Once we were there, I saw SGT [REDACTED] dismounted from his vehicle, and he and his gunner were both shouting and pointing their weapons at the civilian vehicle. The civilian vehicle appeared to be moving back and forth very rapidly, and then I heard warning shots fired. After I heard the warning shots, I told my driver to move to the opposite side of the civilian vehicle so that we could trap it. As I was giving my driver instructions, the gunner of the stationary lead vehicle fired two bursts towards the civilian vehicle. As we were pulling up on the median to trap the civilian vehicle, my gunner fired two bursts towards the vehicle, as well.

As the civilian vehicle was pulling away, heading East on [REDACTED], it started to slow down, then stopped against the curb. I instructed my driver to pull past the civilian vehicle to provide far side security. Once we had passed the vehicle, I stopped my HMMWV, and dismounted and pointed my weapon at the driver of the civilian vehicle while I began shouting at him to exit his vehicle. After a few moments, it was apparent that the driver was either refusing to get out of his vehicle, or that he was dead. My PSG sent SGT [REDACTED] and SSG [REDACTED] to my location after I informed him that we had to clear the vehicle. The three of us moved to the median of [REDACTED] so that we could use the embankment for cover. I pulled security on the rear of the vehicle, SSG [REDACTED] pulled security on the front of the vehicle, and SGT [REDACTED] moved to the vehicle to clear it. He checked the outside of the vehicle, looking in the windows, and reported that the driver appeared to be dead. After he checked underneath the vehicle and reported that he saw nothing suspicious, he opened the door to the vehicle to check the vital signs of the driver. After he told me that the civilian was dead, I told him to check in the windows of the vehicle again but not to touch the driver until I received more guidance from higher. I moved back to my vehicle and reported to A/2-506 that we had a dead local national with an EOB event. It was approximately 0500 hours when I sent the report to A/2-506.

SGT [REDACTED] continued his search, but I told him not to disrupt the vehicle because I wanted the scene to remain undisturbed for the investigation photographs. After a the search, SGT [REDACTED] informed me that he had found a wallet with no money, an ID card, and another slip of paper. Once it became daylight, I took pictures of the scene. I then linked up with another element and handed cordon responsibilities to him. Finally, I proceeded to the Al Dora IP station and brought a group of IP's to the scene to collect the body. After bringing the IP's to the scene, I returned with my patrol to FOB Falcon. END OF STATEMENT

On 15 May 2006, at 0330 my convoy SP from FOB Falcon to insert the Rogue 6 element. The personnel in my vehicle were myself as the driver, SGT [REDACTED] as the TC, and SPC [REDACTED] as the gunner with 2 personnel from the Rogue 6 element. My vehicle was lead with Ghost 6 in the second vehicle and Ghost 7 in the rear vehicle. At approximately 0345 the rogue 6 element was inserted. We then continued to patrol zone 25. At approximately 0430 the rear gunner spotted a white van heading north away from are convoy. The convoy then did a U-turn and pursued the vehicle. My vehicle remained the lead vehicle. We got eyes on the van and he turned so we lost visual for a brief second. As we got close to the Al Dora market area, I saw where the van turned, and so did my gunner. When I turned on to the little access road that leads to [REDACTED] everyone in the vehicle spotted the van between two buildings with the front of the van facing the road. My TC turned on the siren as I was flashing my lights and SPC [REDACTED] shined his light into the van. SGT [REDACTED] then got on the loud speaker saying, "get out of your vehicle and come here" (in Arabic). During all of this, I pulled the truck just far enough ahead of the van so my gunner had good eyes on, and if it were a VBIED, the building would give us a little cover. Then SGT [REDACTED] got out of the vehicle to get the guy out of the van, because he would not get out with him speaking over the loud speaker. I also got out to help pull security. I then heard the van pulling off at a high rate of speed. SGT [REDACTED] yelled at SPC [REDACTED] to fire a non-lethal 203 round at the van. I then started to get back into the driver seat. When the van came around the building, SGT [REDACTED] fired two warning shots in front of the van. I know this because they were tracer and the van still would not stop. At this time, I started to feel threatened. He was also yelling to stop, and so was the gunner. He then shot two disabling shots one to the rear tire and one to the front tire. The vehicle still did not stop and started to head east on [REDACTED], and that is when SPC [REDACTED] fired the M240B into the lower right rear of the vehicle. The van then came to a stop about 30-40 meters after that. SGT [REDACTED] then got back into the vehicle and we pulled forward to pick up rear security while Ghost 6 pulled up in front of the van to get far side security and Ghost 7 was to the south. SGT [REDACTED] and I then dismounted and moved up to Ghost 6's vehicle, using the low ground to the north to get there. We then decided to search the van, so I pulled security on the front of the van. I could see the driver he was laid out over the front of the seat and Ghost 6 pulled security on the rear of the van as SGT [REDACTED] went up to do the BDA. He saw nothing inside or outside the van, so he opened the driver side door to check the driver. The driver was not moving and he yelled back the driver had no pulse. After that, SGT [REDACTED] and I did a visual search on the van and did not find anything. I told the PL we find nothing and he called it up. We then set up the cordon and waited for further orders. About 60 to 90 mins later an element from Easy showed up to help out with the cordon. At around 0830 we went to the IP station to get some IP's to come out to get the body and van. We then headed back to FOB Falcon. We return around 0900.

On the morning of 15 May 2006, my platoon, scouts HHC 2-506 IN, consisting of 3 1114's were to conduct a Drop Off at the green mile in zone 25, and then a patrol of zone 25. Our SP time was 0300, I was the TC of the lead vehicle, my driver was SSG [REDACTED] and my gunner was SPC [REDACTED]. We traveled North down [REDACTED] in zone 26, on which we traveled east to mechanics area. Then, we traveled north over the bridge into zone 25, then moved to north east of the green mile in zone 25 and inserted a SKT at approximately 0340. We then continued to patrol zone 25. At 0430 we were traveling south on Dora market street when ghost 7, the TC of the trail vehicle, said that they had spotted a white van to our north. Being that it was after curfew, we turned our 3 vehicle convoy around and began to search for the white van while driving north on Dora market road. As we approached [REDACTED] I spotted the vehicle parked next to a small building. We then turned east on to [REDACTED] and blocked the vehicle, seeing that he was facing us. I turned on the siren and asked him in Arabic to get out of the van. When he did not, I got out of my 1114 and pointed my weapon at the van and yelled for him to get out of the van in English then in Arabic. At this point, he put the van in reverse and started to speed to the rear. At that time I yelled at SPC [REDACTED] to fire a sponge Non-Lethal 203 round. After the round was fired he continued to speed in reverse, and put it in drive as to go around the building and try to escape to [REDACTED] heading east. Once he was around the building in plain sight to me, I fired one warning tracer round in front of the vehicle with my M4. It impacted in the dirt right in front of his head lights. He continued to speed away and I fired another warning tracer in front of the vehicle. He then veered on to Sonics and I fired a 5.56 round into his rear right tire. He continued to speed off. I then fired another 5.56 round at his front left tire. At that time SPC [REDACTED] fired two 6 round burst from the mounted M240-B. I observed the tracers hitting the bottom right rear of the vehicle. At this point the white van began to stop and ultimately stopped on the south side of [REDACTED]. I instructed the driver to pull up about 20 meters as to cordon off the vehicle. I then got on the loud speaker and instructed the man to get out of the vehicle in Arabic and in English. He never moved. About five minutes later we received the call from ghost 7 to move up to ghost 6's vehicle which was in front of the van at this time. SSG [REDACTED] and myself moved to the north side of [REDACTED] as to get behind the cover that the embankment provided and moved up to ghost 6's vehicle. He informed us that the three of us were going to search the vehicle. Ghost 6 was to cover the rear of the vehicle and SSG [REDACTED] was to cover the front of the vehicle while I went up and searched it. I moved up and search the outside and visually cleared the inside before I opened the driver's door. Once I opened the door I searched the driver and then checked his vital signs. I saw blood on his back but no exit wound. I also observed some nominal blood coming from his nose. Once the driver was found dead I turned off the ignition and lights and began to search the vehicle. After searching the van I had found his wallet, in his right pocket. I visually observed a pack of cigarettes that stayed in his hands. His wallet contained one I.D. card one business card, one picture and one small piece of paper that seemed to be a phone number. At that time I pulled back to my vehicle and deployed cones on the east and west lanes of [REDACTED]. Some time later we moved to the IP station and picked up an IP vehicle and returned to the scene. We then left to return to the FOB Falcon. — End of Statement

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On the morning 15 May 2006, our platoon (Scouts, HHC 2/506), was attached to Alpha company 2/506 operating in sector 25. Our mission was to drop off Rogue 6 and his element into an OP on the Green Mile. Our SP time was 0300 that morning and we left the FOB with three I114's. The first truck was driven by SSG [REDACTED] TC'd by SGT [REDACTED] and gunned by me. The second truck had the Ghost 6 element, and the third truck had the Ghost 7 Element. We drove [REDACTED] road in sector 26 and crossed the Mechanics bridge into sector 25 to drop off Rogue 6. We patrolled sector 25 for approximately 30 minutes finding a suitable path and insertion point. We inserted Rogue 6 and his element at 0345 and turned around and drove out with blackout lights as not to compromise Rogue 6 immediately after insertion. Approximately 10 to 20 minutes after dropping Rogue 6 off our trail truck called up that there was a vehicle behind us moving in the opposite direction. After each of the trucks individually turned around in the street our truck sped off to catch to vehicle. The time was around 0410. As gunner I could see the Van's tail lights in front of us around 300-400 meters away. We lost sight of the van initially but I remember seeing where it had turned, and directed the driver into the area where I had last seen him. After approaching the area our vehicle slowed down. We had passed the access road and the railroad tracks and had just come up on two small buildings where we saw his vehicle parked with the lights off. His vehicle was parked facing our truck with the lights off no more than 5m away from us on the curb. He turned his lights on and started fumbling with his gears which led me to believe he was going to drive into us and either, initiate a VBIED attack, separate our convoy, or trigger an IED. We were at a tier 1 IED site on [REDACTED] I decided his vehicle was entirely too close to ours, and at the moment was threatening. SGT [REDACTED] turned the vehicle siren on and started yelling at the guy to get out of the truck, and to stop, in Arabic. I shined my green laser which I had taped to my M4M203 and I shined the Surefire Tac- light into his windshield on him so I could see his hands and his face. This is when he began to back up at a high rate of speed and I was instructed to fire the non-lethal 203 round. I did so right before the truck had backed up between the two buildings and I lost sight of him. SGT [REDACTED] got out of the vehicle after I told him I no longer had eyes on. He fired 4 rounds. When the vehicle pulled out onto [REDACTED] when I got eyes on again, and I saw it peel out and take off at an accelerated speed. At this time I watched the driver of the vehicle disobey all the verbal warnings of SGT [REDACTED] and me, and not respond to either non-lethal 203 rounds, warning shots into the road, or disabling shots into the tires. These things in culmination with his rapid rate of speed exiting the area led me to believe that he was either a VBIED, or had just emplaced an IED and was going to detonate it at our position. This is when I aimed the M240 at the lower, back half of the vehicle to disable it. I knew disabling it's rear tires and the back half of the vehicle would cause it to leak and stop. I shot a six round burst into the vehicle to disable it and paused long enough to see that it was still moving at the same speed. I fired the second six round burst and afterwards decided that the vehicle was most likely incapable of escaping. The vehicles slowed down and moved approximately 30-40m leaking fluids until it rolled into the curb going about two miles an hour. The curb was enough to stop the vehicle from moving and this is when SGT [REDACTED] began telling the driver to get out of the vehicle. This was a report the TOC received from B/1-35 AR which was not correct. The PLT that went to Al Dora IP station X-sprayed the wrong vehicle, a dark sedan, not the white minivan. 
