9. [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

ON 04MAR05, MYSELF, LT [REDACTED], SPC [REDACTED] AND SGT [REDACTED] WERE PART OF A HUMMW CREW IN A THREE VEHICLE PATROL ON ROUTE [REDACTED]. WE PATROLLED THE WESTERN SECTOR STARTING AT 1500. AT AROUND 1845, WE RECEIVED A BPT MISSION, ESTABLISH A BLOCKING POSITION AT [REDACTED], TO STOP TRAFFIC FROM LEAVING ROUTE [REDACTED] AND ENTERING THE WESTBOUND LANES OF ROUTE [REDACTED]. WE DID NOT ESTABLISH THE BLOCKING POSITION, WE WERE TOLD TO GO TO IT AROUND 1915 HRS. WE ASSUMED THE BLOCKING POSITION FROM [REDACTED] AROUND 1925. WE SET TWO OF OUR VEHICLES IN ON THE ON RAMP TO ROUTE [REDACTED]. MY VEHICLE WAS AT THE CONVERGENCE OF ROUTE [REDACTED] AND THE ON RAMP JUST PAST THE LAST JERSEY BARRIER FACING WEST WITH THE GUN ORIENTED EAST. THE OTHER VEHICLE [REDACTED], CONSISTING OF SSG [REDACTED], A DRIVER AND A GUNNER POSITIONED THEMSELVES 2 BARRIERS NORTHEAST OF US. THEIR VEHICLE WAS POSITIONED ON THE ON RAMP SO AS TO COMPLETELY BLOCK ONCOMING TRAFFIC TO ROUTE [REDACTED]. THE THIRD VEHICLE IN OUR PATROL, [REDACTED] THEN LEFT WITH THE 5 ELEMENTS. LT [REDACTED] AND MYSELF DISMOUNTED AND DID OUR 5, 10 & 25M DRILLS AND THE WHOLE ELEMENT PULLED SECURITY. BETWEEN THE TIME WE WERE SET AND THE TIME OF THE INCIDENT MORE THAN 15 VEHICLES ATTEMPTED TO ENTER ROUTE [REDACTED] FROM ROUTE [REDACTED]. ALL WERE STOPPED AND TURNED AROUND SUCCESSFULLY. THE GUNNER ON 2-7 WOULD USE A 3 MILLION CANDLE POWER SPOTLIGHT AND SHINE IT AT THE CARS AS SOON AS IT WAS APPARENT THAT THEY WERE CROSSING OUR ALERT LINE. IT SERVED TWO PURPOSES: ONE, TO PROVIDE A VISIBLE SIGNAL TO THE ONCOMING CAR, AND TWO, IT ILLUMINATED THE 2-7 VEHICLE SO THAT IT COULD BE SEEN MORE EASILY. MYSELF OR SGT [REDACTED] WOULD ALSO 'SPOT' THE WINDSHIELD OR HOOD OF THE CAR WITH A HIGH POWER GREEN LASER POINTER WHICH WE HAVE USED TO GREAT EFFECT TO STOP VEHICLES ON ROUTE [REDACTED] AT NIGHT AND DURING THE DAY. ALL VEHICLES, EVEN THOSE TRAVELLING AT HIGH SPEEDS STOPPED ALMOST IMMEDIATELY WITHOUT SKIDDING OUT OR SQUEALING TIRES, EVEN THOUGH THE ROAD WAS WET. THEY WOULD THEN TURN AROUND WITHOUT COMING CLOSE TO ENTERING OUR SAFETY ZONE OR PASSING OUR WARNING LINE.

AT APPROXIMATELY 2045, LT [REDACTED], SSG [REDACTED] AND MYSELF WERE GATHERED AROUND OUR VEHICLE DISCUSSING THE BLOCKING POSITION. I SAT IN THE REAR PASSENGER SEAT WITH THE DOOR OPEN TO CLEAN MY GLASSES. WHILE I WAS DOING THIS SSG [REDACTED] AND LT [REDACTED] BEGAN TO REACT TO SOMETHING. THEN I HEARD A BURST FROM 2-7'S 240B. I LEANED OUT OF THE HUMMWV TO LOOK AND AS I GOT FAR ENOUGH OUT, I SAW A LIGHT COLORED CAR RACING DOWN THE OFF RAMP. 2-7'S GUNNER THEN FIRED ANOTHER BURST, WHICH I SAW THE TRACERS IMPACT IN FRONT OF THE CAR. AS THE CAR CONTINUED TO TRAVEL INTO THE CONE OF FIRE THE ROUNDS IMPACTED HIGHER, HITTING THE HOOD AND THEN BLOWING OUT THE WINDOWS. THEN THE CAR DECELERATED QUICKLY AND CAME TO A STOP. SSG [REDACTED], LT [REDACTED] AND I BEGAN TO MOVE TOWARDS THE CAR WITH OUR WEAPONS RAISED. 2-7'S DRIVER DISMOUNTED AND MOVED WITH US. THE DRIVER OF THE CAR GOT OUT WITH HIS HAND RAISED, ONE OF WHICH HELD A CELL PHONE. HE YELLED AND MOTIONED FOR HIM TO COME TO US. WE SUSPECTED A VBIED AND I WANTED TO STAY AWAY FROM IT. HE BEGAN SHOUTING 'ITALIANO! ITALIANO!'. WE ASKED IF THERE WERE PASSENGERS TO WHICH HE REPLIED, 'THEY KILLED, THEY KILLED.' I STARTED TO THINK THAT THERE WAS SOMETHING WRONG WITH THIS SCENARIO, SSG [REDACTED] AND HIS DRIVER MOVED TO THE SUSPECT, AND LT [REDACTED] AND MYSELF MOVED TO THE CAR. WITH THE DRIVER SOUNDING ITALIAN AND BEING CAUCASIAN, IT NO LONGER FIT THE PROFILE FOR A VBIED. I CLEARED THE FRONT TWO SEATS WITH MY SUREFIRE, THE CAR WAS ALSO STILL WELL LIT FROM OTHER LIGHTS. THE BACKSEAT CONTAINED 2 PASSENGERS. THE LT AND MYSELF HAD MOVED UP ON THE PASSENGER SIDE OF THE CAR, WHEN I SAW THE 2 PASSENGERS BOTH APPEARED DEAD. I OPENED THE REAR DOOR AND THE MAN WAS NON-RESPONSIVE. I FELT FOR A PULSE AND AS I GOT FARTHER IN THE CAR, I NOTICED BRAIN MATTER ON THE UPHOLSTERY AND THEN A GUNSHOT WOUND TO THE TOP LEFT OF HIS HEAD THAT HAD EXPOSED A LARGE PORTION OF JAGGED BONE AND RIPPED UP BRAIN MATTER. HE STILL HAD A PULSE BUT I FELT THAT HE DID NOT HAVE LONG TO LIVE AND AT THIS TIME THE FEMALE OPENED HER EYES. I TOLD THE LT THAT HE WAS STILL ALIVE AND DESCRIBED HIS WOUND AND THEN I MOVED TO THE REAR DRIVER SIDE OF THE CAR HOPING THAT I COULD DO SOMETHING FOR THE FEMALE PASSENGER. I DIDN'T THINK I COULD HELP HIM. I LOOKED FOR WOUNDS ON HER AND DIDN'T FIND ANY. THEN I MOVED HER OUT OF THE CAR WITH HER HELP AND LAID HER ON THE GROUND. SHE SAID THAT THE LEFT SIDE OF HER SHOULDER HURT. I CUT HER OUTERGARMENTS OFF TO EXPOSE ANY WOUNDS. AFTER CHECKING HER ALL I COULD FIND WAS AN ENTRY AND EXIT WOUND ON HER UPPER LEFT SHOULDER AND SOME SMALL PUNCTURES ON HER CHEST.

I BANDAGED HER SHOULDER WOUND AND THEN SPC [REDACTED] CAME OVER AND WE TRIED TO STICK HER TWICE FOR AN IV BUT WE COULDN'T HIT A VEIN. A MEDIC THEN ARRIVED, TRIED ONCE MORE FOR AN IV BUT ALSO WAS NOT ABLE TO FIND A VEIN. HE ALSO EVALUATED HER. WE THEN LOADED HER INTO 2-7 AND THAT VEHICLE AND OURS WENT TO THE CSH HOSPITAL IN THE GREEN ZONE. WE TURNED HER OVER TO THE DOCTORS AND RETURNED TO THE SITE.

Q: HOW FAST WAS THE VEHICLE GOING?

A: I WOULD SAY ABOUT 50MPH. OTHER VEHICLES WERE COMING ALMOST AS FAST, BUT ALL STOPPED WAY FURTHER OUT.

Q: HOW WAS VISIBILITY?

A: THERE WERE STREET LIGHTS AND SOME LIGHT FROM TRAFFIC. WITH THE SPOTLIGHT IT WAS PRETTY WELL ILLUMINATED AND IN ADDITION THE NIGHT WAS CLEAR.

Q: HOW MANY SHOTS WERE FIRED?

A: I WOULD SAY THE FIRST BURST WAS THREE TO FOUR ROUNDS AND THE SECOND BURST WAS EIGHT TO TWELVE ROUNDS. I THINK I SAW ONE TRACER HIT IN FRONT OF THE CAR, TWO IN THE HOOD, AND TWO IN THE WINDOWS. IT WAS BRITISH AMMO, TRACER TO BALL RATIO WAS ABOUT ONE TO ONE. IT SEEMED AS THOUGH THE FIRE AIM WAS NOT LIFTED BUT THAT THE CAR RAN THROUGH IT.

Q: HOW MUCH, IF ANY, WAS THE TIME BETWEEN BURSTS?

A: IT ALL SEEMED TO HAPPEN VERY QUICKLY TO ME - THE WHOLE INCIDENT.

Q: HOW WAS THE CHECKPOINT MARKED?

A: GREEN LASER LIGHT, SPOTLIGHT, AND BARRIERS

Q: WHEN DID THE FIRING STOP?

A: HE STOPPED FIRING THEN THE VEHICLE SLOWED TO A STOP.

Q: WHAT IS YOUR ROE FOR CHECKPOINTS?

A: BRIEFED AROUND FEB 5 OR 6TH ON ROE WITH THE REST OF THE COMPANY. TOPICS COVERED INCLUDED GRADUATION OF FORCE, SHOUT, SHOVE, SHOW AND SHOOT. DEADLY FORCE IS AUTHORIZED TO PROTECT SELF, GOING OFF GRADUAL FORCE. HOSTILE ACT, HOSTILE INTENT, PID BEFORE FIRING. (HOSTILE ACT OR INTENTION = PID)

Q: WHEN WAS YOUR LAST BRIEFING ON ROE?

A: IT IS CONTINUOUS, LAST FORMAL BRIEFING WAS IN February.

Q: DID YOU FEEL THREATENED BY THE VEHICLES APPROACH?

A: ROGER. I THOUGHT IT WAS A VBIED. IT WASN'T UNTIL I HEARD THE ITALIAN MAN THAT I THOUGHT IT WAS SOMETHING DIFFERENT.

Q: IS THIS AREA HOSTILE?

A: ROGER. SCOUTS WERE HIT ABOUT TWO NIGHTS AGO. BEFORE THAT WE FOUND IED'S AND THERE ARE MANY ONGOING THREATS.

Q: ARE VBIED'S COMMON?

A: VERY COMMON.

Q: HAVE YOU SEEN OTHERS APPROACH LIKE THIS?

A: I'VE SEEN CARS APPROACH FAST, THEN SLAM ON THE BRAKES. I'VE NEVER SEEN A CAR COME THAT FAST, THAT CLOSE.

Q: WHAT TRAINING HAVE YOU HAD ON CHECKPOINTS?

A: WE HAD TRAINING AT FT HOOD, AT TAJI, AND ALSO COMPANY TRAINING. IN ADDITION WE HAVE HAD MORE TRAINING HERE AT CAMP [REDACTED]. THIS WAS ACTUALLY A BLOCKING POSITION.

Q: WHO DID YOU THINK WAS IN THE CAR?

A: COULDN'T SEE WHILE MOVING, I FIGURED THE OCCUPANTS WERE HOSTILE.

Q: HAVE YOU PERFORMED BLOCKING POSITIONS BEFORE?

A: ROGER, WITHOUT ANY PROBLEMS.

Q: WAS THAT VEHICLE IN A CONVOY?

A: NO, IT WAS THE ONLY VEHICLE COMING OFF THE RAMP AT THAT TIME.

Q: DID YOU KNOW A VIP WOULD BE TRAVELLING THROUGH YOUR POSITION?

A: NOT AT THAT LOCATION WHERE THE INCIDENT OCCURRED.

Q: IS THERE ANYTHING ELSE YOU THINK MAY BE IMPORTANT?

A: NO

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

AT 1843 HRS ON 4MAR05, I WAS ORDERED BY CAPTAIN [REDACTED] TO TAKE UP A BLOCKING POSITION ON THE WESTBOUND LANE OF ROUTE [REDACTED] AT [REDACTED]. UPON MY ARRIVAL CONCRETE BARRIERS WERE ALREADY IN PLACE ON THE NORTHWEST ENTRANCE RAMP OF [REDACTED]. MY VEHICLE, A27, AND LT [REDACTED] VEHICLE, [REDACTED] WERE POSITIONED FAR DOWN THE ENTRANCE RAMP TO GIVE VEHICLES APPROACHING ENOUGH TIME TO RECOGNIZE OUR PRESENCE AND RESPOND. IN ADDITION, THIS ALSO GAVE OUR SECTION MORE STAND OFF DISTANCE IN CASE OF ENEMY ACTIVITY. A27 WAS LOCATED FURTHER BACK FROM THE SECOND CONCRETE BARRIER AND LT. [REDACTED] VEHICLE WAS LOCATED BEHIND THE THIRD BARRIER. MY SECTION WAS LOCATED AT [REDACTED] FOR AWHILE AND DURING NIGHT HOURS WHEN VEHICLES APPROACHED WE ALERTED THEM TO OUR PRESENCE BY SHINING A BRIGHT SPOTLIGHT IN THEIR DIRECTION. THE SPOTLIGHT WAS PLUGGED INTO THE VEHICLES POWER SUPPLY TO ENSURE THAT THE LIGHT WAS ALWAYS BRIGHT AND VISIBLE TO MOTORISTS. THE MOTORISTS ALWAYS RESPONDED PROMPTLY AND TURNED AROUND WELL BEFORE APPROACHING THE BARRIERS. IN ADDITION TO THE SPOTLIGHT, SGT [REDACTED] FROM THE [REDACTED] VEHICLE, WAS USING A GREEN LASER POINTER, WHICH THREW A VERY VISIBLE GREEN LIGHT. AT THE DISTANCE WE WERE ALERTING DRIVERS, THE GREEN LASER PRODUCES A LARGE GREEN DOT.

AT APPROXIMATELY 2050 HRS, I DID APPROACH LT. [REDACTED] VEHICLE AND INQUIRED IF THERE WAS ANY WORD ON THE [REDACTED] BUSS. I THEN MADE THE COMMENT THAT IT MUST HAVE BEEN A HIGH LEVEL OFFICIAL FOR THEM TO CLSOE DOWN ROUTE [REDACTED] FOR SO LONG. WHILE I WAS TALKING TO LT. [REDACTED], I HEARD THE REPORT OF THE M240B ON A27 AND SNAPPED MY HEAD AROUND TO SEE A SMALL COMPACT CAR APPROACHING THE CONCRETE BARRIERS AT APPROXIMATELY 55-60 MPH. THE CAR WAS PAST THE ZONE IN WHICH WE SPOTLIGHT MOTORIST'S AND IT WAS AT THIS TIME THAT I SAW THE TRACERS FROM THE SAME M240B, WHICH WAS OPERATED BY SPC. [REDACTED] OPEN UP FOR A SECOND TIME. IT WAS AT THIS POINT THAT THE COMPACT VEHICLE SLOWED AND CAME TO A STOP. A WHITE MALE THEN STUCK HIS HAND OUT THE WINDOW, OPENED THE DRIVERS SIDE DOOR AND TOLD US HE WAS FROM THE ITALIAN EMBASSY. MYSELF, LT. [REDACTED], SGT [REDACTED] AND SPC [REDACTED] DID APPROACH THE VEHICLE WITH WEAPONS DRAWN. WE ORDERED THE DRIVER OUT OF THE CAR AND I PATTED HIM DOWN. I ASKED THE MALE IF THERE WERE ANY OTHER PERSONS IN THE CAR AND HE RESPONDED THAT THERE WERE TWO IN ADDITION TO THE FACT THAT HE HAD A WEAPON IN THE FRONT SEAT OF THE CAR.

LT. [REDACTED], SGT [REDACTED] AND SPC [REDACTED] DID FIND A WHITE MALE IN THE RIGHT REAR PASSENGER SEAT WITH A GUNSHOT WOUND TO THE HEAD AND A WHITE FEMALE IN THE LEFT REAR PASSENGER SEAT. SGT [REDACTED] AND SPC [REDACTED] DID RENDER MEDICAL AID TO THE INJURED MALE IN THE BACK SEAT AND THE FEMALE IN THE BACK SEAT. I ASCERTAINED THAT THE DRIVER ONLY HAD A GRAZING WOUND TO HIS RIGHT SHOULDER. I THEN RADIOED INTO [REDACTED], BUT MY COMMUNICATIONS WERE NOT FUNCTIONING AT RANGE DUE TO MY [REDACTED] BEING ON. IT WAS AT THIS POINT THAT LT. [REDACTED] CALLED INTO CPT [REDACTED] WITH THE SITREP AND REQUESTED AN AMBULANCE.

Q: IS IT COMMON FOR CARS TO APPROACH AT THAT SPEED?

A: NO

Q: WHY DO YOU THINK THEY WERE SPEEDING AND DID NOT STOP?

A: I GUESSED THAT THEIR ADRENALINE WAS HIGH AND THAT THEY WERE ON AN IMPORTANT MISSION. WHEN THE DRIVER GOT OUT OF THE VEHICLE HE HAD A CELL PHONE IN HIS HAND. I THINK THAT HE WAS ON THE PHONE WHILE DRIVING.

Q: WHAT TYPE OF TRAINING HAVE YOU RECEIVED REGARDING WORKING CHECKPOINTS?

A: WE RECEIVED TRAINING AT FT. HOOD AND AT THE NTC IN SEPTEMBER 2004. ONCE WE ARRIVED IN THEATRE, WE RECEIVED ADDITIONAL TRAINING AND INSTRUCTION FROM 4/5 ADA, DURING WHICH THE 4/5 ADA SHOWED US HOW THEY HAD BEEN DOING IT. WE HAVE BEEN RUNNING THESE IN [REDACTED] IRAQ AND HAVE HAD NO OTHER INCIDENTS LIKE THIS.

Q: DID YOU HAVE ANY IDEA WHO WAS IN THE VEHICLE?

A: YOU CAN'T SEE PAST THE HEADLIGHTS, I HAD NO CLUE.

Q: IS THERE ANYTHING ELSE YOU WOULD LIKE TO ADD?

A: EVERYTHING HAPPENED SO FAST, WE HAD ONLY A SPLIT SECOND TO MAKE A DECISION. YOU REALLY CAN'T SECOND GUESS YOURSELF.

Q: DESCRIBE THE MEDICAL AID YOU PROVIDED.

A: SPC [REDACTED] AND SGT [REDACTED] ATTEMPTED TO PLACE A BANDAGE ON THE MALE'S HEAD WITH THE GUNSHOT WOUND. THERE WAS EXTENSIVE TRAUMA TO HIS BRAIN AND HIS PUPILS WERE UNEVEN AND UNRESPONSIVE TO LIGHT. SGT [REDACTED] SAID THAT HE COULD FEEL A WEAK PULSE BUT THE MALE WAS NOT BREATHING. SGT [REDACTED] AND SPC [REDACTED] THEN BEGIN TO TREAT THE LADY WHO HAD A GUNSHOT WOUND TO HER RIGHT SHOULDER. At 1845 hours we received an order to block west traffic on Route [REDACTED]. At that time I was the driver of A2. Approximately 20 minutes before the tactical checkpoint as set up, we received VBIED warnings over the radio. The checkpoint was set up so that I, in the position of the driver, was facing Route [REDACTED]. My gunner, SPC [REDACTED] was facing the rear of the vehicle. He had a three million candle power light to use for signaling a warning to drivers. He flashed the light several times at the approaching vehicle and I could see the glow of the light in the cabin of the vehicle as I heard him also scream at the vehicle to stop. At this time I heard two warning shots, then a burst. I jumped out of A 27 to see a man holding an identification card, shouting repeatedly "Italian embassy". I went around him to find a man slumped over in a woman's lap and her holding her shoulder. I helped to extract the man from the vehicle and assisted in performing first aid. I relieved [REDACTED] from the turret so that he could take a moment to collect himself. After the incident occurred, we put the female in A 27 and proceeded to the CSH Hospital. On the way to the hospital, I threw the brass and the links from the turret so that it wouldn't become jammed in case I had to operate it.

2: How fast did the vehicle approach?

A: No idea. I was in the driver's seat facing the opposite direction.

Q: Time/Visibility?

A: Approximately 45 minutes to an hour after we set up.

Q: How many shots?

A: I heard 2 warning shots. [REDACTED] screamed, then there was a burst.

Q: Time between warning shots and opening up?

A: A couple of seconds. More than enough time to use the brakes.

Q: How was the CP marked?

A: Two concrete jersey barriers, but I wasn't sure what other ways the guys marked this checkpoint.

Q: How are the vehicles slowed down?

A: Searchlight flashes vehicle; yelling; hand/arm signals--usually use spotlight as soon as the can make out headlights (200-300 meters away).

Q: Why/When stop shooting?

A: It was a short, controlled burst. No one else fired.

Q: ROE?

A: Normal ROE is hand signals or spotlight, shouting, presentation of weapon, warning shot(s), then shoot to disable, then shoot to kill.

Q: Feel threatened?

A: I knew something was wrong when [REDACTED] started yelling. We had reports earlier warning us of VBIEDs and I thought that was happening.

Q: What did you suspect was happening?

A: I thought we were going to get hit with a VBIED.

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

Our patrol was directed to set up a blocking position at [REDACTED], blocking traffic coming from the North that was trying to merge onto Route [REDACTED]. My position was alternate gunner/dismount. We had been set in position and turning traffic around for a good while. Our gunner (SGT [REDACTED]) needed a break so I swapped out with him. Our vehicle was closest to Route [REDACTED]. My sector included traffic passing me on the eastbound lane of [REDACTED] also some houses and buildings NW of [REDACTED]. The other vehicle had the on-ramp where the traffic was coming from. The activity on my side was very little so if there was a vehicle approaching from the north I would point a laser light at it. I would point it into the vehicle or at the driver. The other vehicle would flash a spotlight at the traffic. This would take place about 300 meters from our position. Normally the traffic would slow down, stop, and then turn around. Anyone driving on Rt. [REDACTED] (especially at night) knows our spotlights and laser lights. We also had barriers on the road. At about 2040 there was a single vehicle traveling at a very high rate of speed from the north towards our blocking position. The other gunner and myself both picked it up right away with our lights. Him with his spotlight and I was pointing the laser at the driver and the windshield. The vehicle continued to approach us. The vehicle passed our warning line. I continued to point the laser at the windshield. The other gunner fired one burst. The vehicle kept coming at the same rate of speed. The gunner then disabled the vehicle. At this time the vehicle had made it up all the way to our barriers. The vehicle stopped and the driver got out. I started scanning my sector and pulling security. Seconds later, my vehicle commander, 2LT [REDACTED], called me on the squad's radio requesting our driver, SPC [REDACTED] who is a combat lifesaver. He quickly grabbed his bag and ran up to the vehicle. At this time I started listening to the radio and calling in information and location. I continued to scan and pull security. My vehicle commander called back and said we were going to the [REDACTED] to the CASH. That's when SPC [REDACTED] and SGT [REDACTED] came back to the vehicle. SGT [REDACTED] drove, we were the trail vehicle. We arrived at the CASH, helped the wounded female out of the vehicle and escorted her into the hospital along with her personal belongings. After our business was finished there, we returned to [REDACTED] and picked up security. I continued to pull security until we returned back to [REDACTED].

I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

My duty position is driver on vehicle A-8S. My acting Platoon Leader was LT [REDACTED]. I was guarding a blocking position at [REDACTED], Grid [REDACTED] at the off ramp of Route [REDACTED] and Irish in the west bound lane. The positions were as follows from West to East, A-27, A-8S, and I'm not sure of the other two bumper numbers. While at the position LT [REDACTED] and SGT [REDACTED] dismounted the vehicle at approximately 2055 hrs. I heard a warning shot fired by what sounded like either an M-4 or M-16, followed by the engagement of a 240B. Less than a minute later SGT [REDACTED] who was a gunner on A-8S, told me to grab my Medic bag. I am CLS qualified; the medic bag is carried standard on the vehicle in the trunk. The first time I saw the Grey car that was engaged was when I went to get the Medic bag. I approached the vehicle on the passenger side where LT [REDACTED] was located. He proceeded to tell me that the passenger in the back seat had a serious head wound but still had a pulse. When we pulled the individual out of the vehicle I grabbed a bandage and told LT [REDACTED] to make a head dressing. A few moments later the male died. At the same time SGT [REDACTED] was on the side of the vehicle with female, driver's side rear passenger. She had a wound to her left shoulder, an entrance and exit wound. He asked me to prepare an IV because he thought she was going into shock. I checked and treated for shock. LT [REDACTED] then came over to see how things were going with the female. I was attempting to administer the IV but the needles I had were too big. At the same time SGT [REDACTED] was dressing her wound. A qualified medic arrived on the scene, SPC [REDACTED]. He was then informed by me and SGT [REDACTED] of the condition of the patient. I then assisted in trying to administer an IV for the second time. We discussed bringing her to the CASH but I informed them that I was told that an ambulance was on the way. SGT [REDACTED] decided to take her to the CASH instead of wait. We put her into A-27 and proceeded to the CASH where she was admitted. We were then given instructions from LT [REDACTED] to return to the site of the investigation and await further instructions. At 0250 we moved back Camp [REDACTED] to stand down.

The following questions were asked:

MAJ [REDACTED] Q: How many vehicles were there?

SPC [REDACTED] A: One silver car.

Q: How fast was the vehicle approaching?

A: I did not see the vehicle approaching.

ON FEB 04, 2005, I WENT ON A PATROL OF ROUTE [REDACTED] WITH CPT. [REDACTED] AND MEMBERS OF THE HEADQUARTERS PLATOON OF A CO. 1ST/69TH (M). AT APPROXIMATELY 2100, ALTHOUGH I AM NOT SURE OF THE EXACT TIME, MY VEHICLE WAS INFORMED THAT THERE WERE CASUALTIES WHO NEEDED TREATMENT AT [REDACTED] (GRID COORDINATE [REDACTED]). WE THEN HEADED FOR THAT POSITION. UPON ARRIVAL I APPROACHED THE SCENE, ASSESSED AND TREATED A FEMALE WHO HAD BEEN SHOT IN THE SHOULDER. THE WOUND ITSELF WAS NOT VERY SERIOUS, HOWEVER THE CONDITION OF THE PATIENT INDICATED THAT IT WAS POSSIBLE SHE COULD SLIP INTO SHOCK, WHICH WAS MY MAIN CONCERN. SHE SEEMED A BIT RATTLED NATURALLY, HOWEVER SHE WAS RESPONSIVE BOTH PHYSICALLY AND MENTALLY. I ALSO ASSESSED A MALE WHO HAD BEEN DECLARED DEAD BEFORE MY ARRIVAL, AND VERIFIED HIS STATUS AS DEAD. I DID NOT ASSESS THE DRIVER AS I WAS TOLD THAT HE WAS NOT AN ISSUE WHICH I INTERPRETED AS NOT INJURED, HOWEVER AFTER I RETURNED FROM THE [REDACTED] I WAS TOLD THAT HE HAD A MINOR GRAZING WOUND THAT WAS TAKEN CARE OF.
