

SUBJECT: Review of AR 15-6 Investigation into the death of a Local National on 15 March 2005.

1. I have reviewed the report of proceedings of the informal AR 15-6 investigation concerning the death of a local national on 15 March 05.
2. I concur with the findings and recommendations of the investigating officer, Captain [REDACTED] 1st Battalion, 41st Infantry Regiment, and reviewed by the appointing authority, Lieutenant Colonel [REDACTED], Commander, 1st Battalion, 41st Infantry Regiment.
3. Upon reviewing the evidence in support of the report of proceedings, I conclude:
 - a. That the use of deadly force in this case was consistent with the rules of engagement (ROE).
 - b. That the unit appropriately responded with graduated force as it is articulated in the ROE, applying non-lethal force in the form of warning shots prior to escalating to deadly force in response to the perceived demonstration of hostile intent from the unidentified vehicle.



MEMORANDUM FOR Commander, 1st Battalion, 41st Infantry, Camp [REDACTED] North, Iraq

SUBJECT: Results of formal AR 15-6 investigation regarding shooting of local national woman during an engagement between Task Force soldiers and AIF.

1. On 15 March 2005, I was appointed as the AR 15-6 Investigating Officer of the engagement at vicinity [REDACTED] between 3/B/2-14 IN with 1/630 MP and AIF, on 15 March 2005, at or about 1813, which resulted in the death of one local national. My observations, conclusions, and recommendations are provided in the following format: facts, findings, and recommendations.
2. FACTS: On 15 March 2005 on or about 1801 3/B/2-14 IN had established a traffic control point on [REDACTED], vicinity [REDACTED] 400 meters south of the intersection of routes [REDACTED] and [REDACTED], with four M1114. As the platoon was pulling down TCP materials to collapse the check point, it was engaged with a 30 round burst of small arms fire. The burst came from a Styrofoam factory about 300 meters to the east, vicinity [REDACTED]. (See Exhibit 2-7) 1SG [REDACTED] (DBR 4182), HQ/B/2-14, was hit with three gunshot wounds; one to the left buttocks, bullet exited, another to the inner right thigh, bullet lodged behind right knee and a bullet fragment hit his left foot, outer (pinkie) toe. (See Exhibit 7) The platoon saw muzzle flashes from the building and the dismounted infantry on the ground began to return fire at the building. After the return volley there was a lull in fire from both friendly forces and AIF. The platoon assessed the casualty and prepared him for evacuation when fire again came from the factory. The dismounted infantry and the crew served weapons on the vehicles fired another return volley, heavier and longer this time. (See Exhibit 2, 4, and 6) The fire from either side died down once more as three M1114 from 1/630 MP arrived at the scene and offered assistance. 3/B/2-14 IN loaded up their casualty and 1LT [REDACTED] directed the evacuation vehicle to return to Camp [REDACTED] North with two additional 3/B/2-14 IN vehicles. (See Exhibit 3 and 5) 1LT [REDACTED] stayed with his remaining M1114 and the 1/630 MP's three HMMWV. 1LT [REDACTED] developed a fire and maneuver plan of attack with SGT [REDACTED] of the 1/630 MP and its patrol leader, SSG [REDACTED]. (See Exhibit 13) Two of the 1/630 MP vehicles would stay in a support by fire position, suppressing the factory, as 1LT Lynch and his M1114 with the remaining MP vehicle, with SGT [REDACTED], would move north on [REDACTED], east on [REDACTED], and south on a by-road that would allow them to flank the building from the side. (See Exhibit 1 and 6) As 1LT [REDACTED] and his two vehicles maneuvered north the SBF position engaged the building where the fire had originated from. (See Exhibit 8) Additional units radioed that they were in route to assist and two M1 tanks from C/2-70 and three M1114 from 1/463 MP moved into the area. (See Exhibit 1) As LT [REDACTED] neared the factory, he decided to wait for the second MP platoon to back up his numbers before entering the building. The tanks established blocking positions on the south bound lane of RTE Vernon, just north of the [REDACTED] interchange. The 1/463 MP M1114 moved east on Cardinals and linked up with 1LT [REDACTED] vehicle and the other MP unit's HMMWV near the factory. (See Exhibit 1) With six M1114 as a hasty cordon, 1LT [REDACTED] entered the building and began to clear it. The ad hoc unit cleared the factory room to room for about a half an hour when SGT [REDACTED] told 1LT [REDACTED] that he needed to see

something outside right away. (See Exhibit 4) SGT [REDACTED] took 1LT [REDACTED] out of the building and showed him a dead local national woman ([REDACTED]) who was laid out in the road. 1LT [REDACTED] was informed that she was a passenger from a red sedan with a male driver and had been moving north along the access road east of RTE [REDACTED] toward the 1/630 MP SBF position and the friendly units near the factory. (See Exhibit 1 and 6, 8-11, 14-15) The car had moved quickly between the SBF position and the objective area. (See Exhibit 14) A turret gunner (SGT [REDACTED]) from one of the MP vehicles in the SBF position saw this as threatening. SGT [REDACTED] first fired warning shots with his M4, and then he engaged her with his M249 when the car did not slow down. (See Exhibit 8-11, 14-15) The vehicle was struck and the LN woman was killed. 1LT [REDACTED] had not heard the engagement while he was clearing the factory. (See Exhibit 6) 1LT [REDACTED] continued clearing the building with the dismounted infantry. The building was secured about 15 minutes later, no AIF were found in the building. Elements of 3/B/2-14 IN searched the car and found no contraband. (See Exhibit 12) 1LT [REDACTED] then talked with both MP units, LTC [REDACTED], (TF 1-41 IN Battalion Commander), who had recently arrived at the scene, and the factory security guards about the engagement. 1LT [REDACTED] with LTC [REDACTED] collected information from the relatives of the killed local national woman for Solatia purposes. An LN ambulance came and moved the body. (See Exhibit 13) The three M1114 from 3/B/2-14 IN on the evacuation mission to CLN, returned to the scene to link up with the fourth vehicle. All units involved began to clear the area and return to their respective missions. 3/B/2-14 IN returned to CLN. (See Exhibit 7)

3. FINDINGS: On 15 March 2005 the death of the local national woman ([REDACTED]) was not due to fault by 1LT [REDACTED] or any member of 3/B/2-14 IN that was with him at the scene. The LN car was engaged by a soldier from the 1/630 MP under no orders or guidance from any individual from 3/B/2-14 IN. SGT [REDACTED] engaged the LN vehicle after warning shots did not slow it down or stop it, and because it was deemed as a viable threat to his unit and the units he, by situation, was working in conjunction with. The woman was in a car traveling at night, on a side road, quickly moving towards a unit that was just in contact with AIF, and refused to stop or slow down after warning shots. Additionally, the 1-69 IN in the AO just to the south of the area that the woman's car was traveling in, had, that day, been attacked by several VBIED and VCIED attacks, some resulting in Coalition casualties and deaths. Her death was a tragic accident due in part to the confusion of the situation and the fog of war.
4. RECOMMENDATIONS: In view of these findings, I do not recommend punitive action for 3/B/2-14 soldiers. I do recommend reiterating to the companies of emphasize the importance of knowing the rules of engagement criteria and the escalation of force measures. The Task Force should also make its best effort to contact the local nation family of the deceased with compensation for their loss and their damaged vehicle.

- 1826 – 1LT [REDACTED] dismounts and enters factory with a group of MP and 3/B/2-14 soldiers
- 1855 – LN car engaged
- 1859 – 1LT [REDACTED] and dismount team begin clearing second floor of factory.
- 1900 – SGT [REDACTED] from 1/630 MP comes to get 1LT [REDACTED] inside the building, tells him he needs to see something outside.

9. I, SSG [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:
At approximately 151815, Mar 05, 3d Platoon, Bco 2-14 IN, was operating a traffic control point (TCP) on Rte [REDACTED] in order to prevent vehicle born improvised explosive devices (VBIED) from entering the green zone. As we were starting to break down the TCP, we received automatic weapons fire from the east. The approximately thirty round burst walked its way up to 1SG [REDACTED], who was hit. By three rounds our dismounts returned fire and then there was a lull in fire. More hostile fire came in and our crew served and individual soldiers opened up and returned fire with what could be called a wall of lead. After a minute or so of sustained suppression, we seized out fire. The MP's came to assist us. We loaded 1SG [REDACTED] onto one of our vehicles and medivaced him to the 199th TMC on Camp [REDACTED]. Three of our four vehicles left with the 1SG while ILT [REDACTED] stayed with the MP's. After we finish with the medivac, we returned to the location of the TCP to link back up with ILT [REDACTED] and his truck crew. The hostile fire appeared to have come from a styrofoam factory to the east of our location. //End of Statement// [REDACTED]





On 15 March 05 at 1820 hrs, while conducting an escort for the 720th MP Battalion XO, we rolled up on a check point at Grid [REDACTED]. As we rolled up we were informed there was an injured soldier. We moved our vehicles to help provide cover for the unit 1-41 IN. They pointed out the building in which they received fire from. At that moment rounds were fired again from that building. I saw the muzzle flash and began to engage the building that was about 350 meters ^{East} of our grid. I fired 60 5.56 rounds and 1 M203 round. Gun fire came to a halt at that point. We continued to use the gunners in the truck to lay suppressive fire. At about 1840 1-41 IN moved the injured out of AD. At the same time SGT. [REDACTED] and his team and the rest of the 1-41 IN vehicles moved towards the building. And we secured the area. At about 1900 hrs a red sedan type vehicle was moving north along ~~ASR Force~~ a dirt road that ran next to ASR Force. At that time SGT. [REDACTED] fired a warning shot with his M4 in front of the fast moving vehicle. The vehicle did not stop or slow down they only increased their speed. [REDACTED] then fired 4 more rounds from his M4 in the direction of the vehicle. The vehicle continued to increase his speed and jerked the wheel towards the building and the area we were moving troops into. [REDACTED] then engaged the vehicle with 2 3-round burst from his M249.
