on 7APROS Mo and my Team which is made up of Spec [redacted] /Spec [redacted] and myself
[redacted] Along with Sgt [redacted] signed leader [redacted] went out to our position which is the
outpost position at [redacted] which is called the [redacted]. We headed out to relieve the
team that were there upon arrival there was 2 explosions followed by alot of smoke.
Automatic gunfire the time was about 12:30 in the afternoon. To our front there was alot
of traffic which was mixed with US Military /PSD and civilian personnel. The automatic gun-
fire came from our front we then took up a defensive position on fire facing towards
front of our position. At that time about 4 vehicles went in to see the barriers on
our left side they erupted again and we then started to advance forward. We then moved
about 30m forward and a woman and young child approached us screaming and yelling
at someone who shot like then proceeded toward online towards the individual who was
shot it was about another 80m from where we were. At that time we seen an
individual lying on the ground we continued to move forward on this path
the individuals to set up a barrier between them and the [redacted]
who had been shooting us at the same time as our movement to pull up beside the injured
person. The driver was Spec [redacted] and the PSD gunman was Spec [redacted]. Once we had secured
around Spec [redacted] who is a certified CLS drove down off the gun along with Spec [redacted]
to render first aid to the individual. At that time we pulled back to house in
ready at our location. As soon as the individual was taken away off they pulled
back towards our location and much more shelling was heard on the right of the road.
We met up with Helmut Dene who tried to tell the team in English that he was sent to
hospital. At the same time Army med arrived to do a Gordon on one of the men
the young injured man already taken to the hospital so the medical care positioned
at his little death are confirmed on with our job.
