A: I told Alpha section (C-31 & C-32) to stop the car, go

9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

While traveling south on route [REDACTED] a car merged into the convoy at a high rate of speed. The car was attempting to pass through the convoy so we conducted a snap TCP. Within three minutes of the search, shots were fired. I got down behind the vehicle being searched to orientate myself on the shots fired. I then realized the shots fired were friendly. I then heard soldiers telling people to get out of the car. Two of the three people in the car got out. At this time I was at the drivers door telling him to exit. When he did not exit the car, I told a soldier to shine light on him from the opposite side. When I could see the door I opened it to realize the driver had been struck in the side of his body with a round. I called for the medic and pulled the driver from the car and placed him on the ground. After the medic took control of the situation, I then instructed my dismount to assist. I then got SPC [REDACTED] and went to the nearest car and told them to get the police. After CPL [REDACTED] stabilized the driver, he was placed on a litter and put into C33 for evacuation. While moving north on route [REDACTED] we was blocked off by the Iraqi Police. At this time, I met the Iraqi Police on the ground and told them what had happened. The Iraqi Police took the driver of the car from my truck to the hospital.

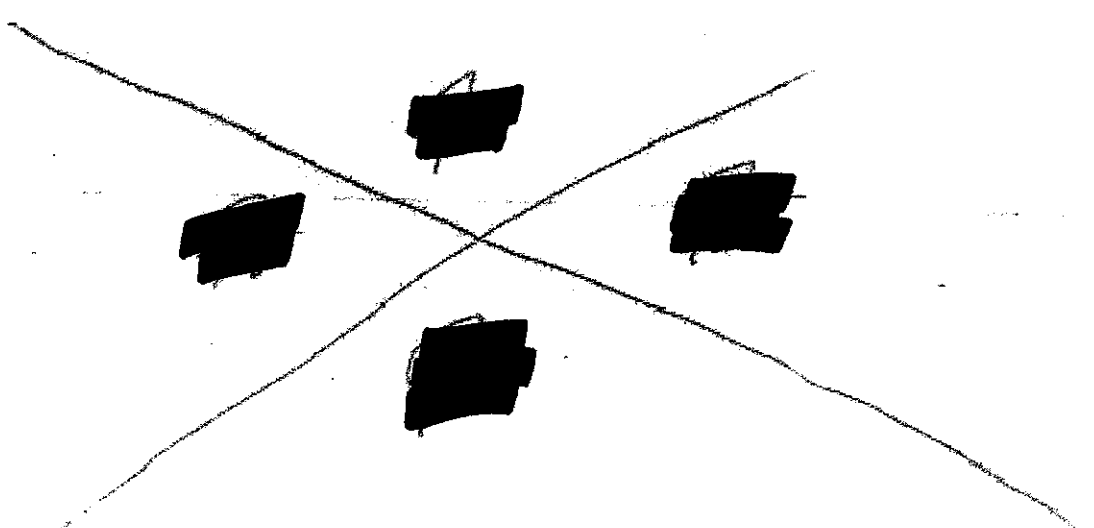
