I fired a second round into the hood and the ING Soldier, and [REDACTED] also fired more shots, I do not know how many total.  On the June 2005 on the corner of Rte. [REDACTED] and [REDACTED]
 I witnessed a white car approach our area at a high rate of speed with no intent to stop. Shouts of warning and hand and arm gestures were made to get the car to stop. The car passed another car that was obeying the coalition soldiers command at that time warning shots were fired. I was unaware of who fired the rounds b/c alot of [REDACTED] soldiers had their weapons oriented in the cars direction. As the car got closer more shots were fired, the only which I saw firing was an Iraqi soldier from under one meter from the drivers window. At that time the car came to a stop. Once we were sure that it was clear we did a search of the car, which did not find anything out of the ordinary. As we looked at the exterior of the car I observed the front passenger tire to be flat from the warning shots, and also the drivers front window was completely shattered. Also there was one single round through the front windshield. Also there appeared to a fuel leak in the rear of the car.

On 24 June 05 at 1759 hours I heard numerous rounds shot from across [REDACTED] When I turned around I visually saw a member of the Iraqi Army run up to a vehicle and it appeared that he shot a round from an AK-47 into the drivers side window. I ran across the road and began to get a sitrep on the current situation. Soldiers informed me that the car was driving at a high rate of speed and came around another car toward a military and Iraqi Army convoy. US forces fired warning shots into the ground and into the tire but the vehicle continued to proceed toward Coalition forces. Iraqi Army forces denied shooting any round but soldiers from my platoon also hear a round fire when the Iraqi Army soldier ran up to the vehicle and the local Nationals windows broke out and he was killed.

While conducting presence patrols in the [REDACTED] area, [REDACTED] was clearing the routes while traveling south bound route [REDACTED] the platoon reported hearing shots fired to the west of the patrol movement. The approximate time fire was heard was 1139 hrs. The patrol immediately halted along with the [REDACTED] IA in its corner. A person was spotted on the east side of the road on top of a three story building. The patrol immediately moved to this position at [REDACTED] to investigate if any ATF were responsible for the fire. The [REDACTED] IA accompanied the patrol/section to clear the building. The patrol along with a section from the [REDACTED] IA provided perimeter security to outside the building. While inside completing the search of the building I heard shots fired. The report broadcasted that winning shots had been fired by perimeter area to clear I exited the building and was informed that a real national was dead.

At approximately 241135JUN05, while conducting a Building Search of possible Anti Iraqi Forces on the upper floors and rooftop of a multi story building, located on the Southern side of the corner of Route [redacted] and [redacted] Road, I heard the sound of verbal warnings in Arabic along with at least 3 gunshots originating from the intersection below. I immediately moved, along with 2 Iraqi Army soldiers, including the Iraqi Army Patrol Leader, [redacted], to the Southern corner of the Rooftop, and assumed a security position in location. I then heard on my Internal Communications Radio, or [redacted], that it was warning shots from, most likely the Iraqi Army soldiers providing a Cordon of the area around the building stopping traffic. I also heard the US [redacted] state that the Iraqi soldiers were firing excessive warning shots at traffic and to get them to cease fire. I then heard that a local national was "Shot" in the head and killed by Iraqi Army soldiers in the vicinity. I immediately passed on this information to the [redacted], and explained he needed to contact his soldiers on his radio, and find out what was going on. All US and Iraqi Army soldiers then began to move from the roof of the building to the street below, in order to assess the scene of the apparent shooting of the Local National. I then overheard on my [redacted] radio that the Local National was in fact deceased from a gunshot wound to the head, and that it was caused by him not stopping his vehicle as he approached the Iraqi Army soldiers in the road from the East on [redacted]. I requested more information over the [redacted] radio as to the details of the shooting, and a unit stated that the vehicle the Local National was driving, was speeding towards an Iraqi soldier blocking the road, and appeared to be attempting to "Hit" the soldier with the vehicle. I then overheard that "All Rules of Force" and "Rules of Engagement" were followed in a correct sequence, including warning shots into the vehicle tire and hood near the engine block, prior to the final shot which killed the driver. I then requested that my Team Medic escort [redacted] to the scene, while I go to our vehicle to call the incident into our TOC.

After notifying my TOC of the incident I asked my gunner if he observed anything, which he stated he did not due to his weapon orientation, I then moved to the scene and asked my Driver, [redacted], if he witnessed anything, which he stated that a Local National was in fact killed and that he believed, based upon the sound of the gunshots, that it could very possibly be US soldiers, rather than Iraqi Army soldiers who engaged the vehicle. I moved closer to the scene, and overheard on my [redacted] that a US soldier did in fact fire at the vehicle, but it was believed that an Iraqi Army soldier fired the final, fatal shot killing the driver. I then physically looked at the vehicle and deceased driver, and observed US soldiers taking Photographs of the scene. I once again went to my vehicle in order to contact my TOC to update them on the situation. I was then told that the US soldiers were mounting up to move due to another mission, and that the Iraqi Police will be arriving at the scene momentarily. I called for my Iraqi Army soldiers to mount up as well, and the entire patrol moved away from the area. Upon arriving at the location of the patrol's next mission, I asked [redacted] if he knew if an Iraqi Army Soldier had indeed fired at the vehicle in question, to which he replied he was unsure and would attempt to find out.
