WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH

On 28 Aug 05 at approximately 1100 hrs 1st PLT C Co TF 1-156 had a dismounted OP set on the [REDACTED] at [REDACTED] overwatching [REDACTED] of RTE [REDACTED]. While we were on the road a convoy started getting ambushed about 600m from our position. The convoy being I started receiving small arms but we couldn't tell where they were coming from. After many shots were fired my team leader Sgt. [REDACTED] pointed out that the shots were coming from the median with trees, so we started laying down some suppressive fire into the trees. After the firing ceased we noticed 3 guys coming from around a bush they were getting pulled by horse so we got our tank section to stop them. After being stopped some IP's came and assisted in searching them. While searching them a secondary ambush started and mortar rounds started coming in around the IP's and our tank section.

About 5-10 min after the second ambush started myself + Cpl [REDACTED] noticed a guy in white car holding what appeared to be an RPG out of the window. So I notified Sgt. [REDACTED] of this after seeing this

he told Sgt. [REDACTED] to get the bins so that we could see better. Before Sgt. [REDACTED] could return the guy quickly got back in seat. Also I would like to add that the guy was pointing the RPG towards our tank section and I P vehicles before noticing some thing. After getting back in the vehicle it started rolling backwards so then Sgt. [REDACTED] gave the order to shot warning shots so that we could stop the vehicle. Even though we fired warning shots the vehicle began to pick up pace in reverse. So then Sgt. [REDACTED] gave the order to disable the vehicle, as we started shooting, one of us blew out the passenger back tire. Once the tire was blown the car picked up even more speed backwards. We finally were able to disable the vehicle about 250-300m south of our position. When vehicle came to stop Sgt. [REDACTED] gave command to cease fire so we did. After this we got guidance to keep all vehicles and personnel away from the vehicle. About 30 min later our bradley and tanks got there to cordon the area. Nothing else follows.

I, [REDACTED] WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

At approximately 1030hrs my section of M113 tanks moved to the [REDACTED] to investigate a possible engine leak on the H60 vehicle. Once set at the [REDACTED] at approximately 1120hrs, we heard small arms fire. [REDACTED] moved into it the [REDACTED] reported that the Iraqi forces were being ambushed north of [REDACTED] the CO2 crew requested that the C40 vehicle would not start. I then told CO2 to continue to travel silent and move ASAP. My vehicle moved out of the trail and flexed forward. The [REDACTED] or called and presented a Dodge cart that needed to be searched. We stopped and searched the cart with negative findings. We then moved north with the CO2 vehicle joining the fight at that time. We came to the [REDACTED] site and assessed the situation. The IP's suffered 2 KIA's and 1 WIA. They pointed to a field in the east. We moved to the field. The IP's pointed at and shot nothing. Shortly after, 3 mortar rounds impacted. [REDACTED] (initials)
