At approx. 0800 hrs I took over guard at ECP West, I had a convoy approach my gate requesting to exit, I called [REDACTED] and notified them that [REDACTED] requesting to leave. They told me they needed their info. SPC [REDACTED] was on the ground and relayed their info up to me. I then notified [REDACTED] they had 4 vehicles and 13 personnel. [REDACTED] then told me they were clear to leave. [REDACTED] then headed out my gate and proceeded down to [REDACTED] gate. [REDACTED] headed towards MSR [REDACTED] and before [REDACTED] even got to MSR [REDACTED] they fired off 3 warning shots to stop traffic. All but 2 vehicles stop after the shots. The 2 other vehicles kept going on. [REDACTED] proceeded on to MSR [REDACTED] and headed East. Approx. 2-3 minutes later [REDACTED] called [REDACTED] and notified them of a vehicle stopped 50 meters from the bridge in the west bound lane. We heard gunfire of two or three rounds. Myself and the other two soldiers in the tower went down because we thought that we were under fire ourselves. SGT [REDACTED] had made the comment that it sounded like a round had ricocheted in the direction of the bridge. I was on the North side of the bridge scanning my sector when I thought I heard was ^{shots} fired. I really could tell for sure that ^{shots} were fired until I heard a tower call it up. About 20 seconds later a couple of truck and one car stopped on the west side of the bridge about 40-50 meters from my position. A guy got out of the truck that was shot and started screaming. I didn't realize what really has happened till I saw the window on the rear passenger side shot out seconds later the guy grab the little child out of the truck holding her in his arms screaming "we shot her." I called it up to [REDACTED]. I saw one US convoy of Ford pickup trucks pass under the bridge about 15 minutes after the shooting. I didn't see the military convoy coming out of the gate because that wasn't my sector to be scanning. I do not know who fired what!

On 13 Sep 03 at approx. 0800 hrs I was on shift on the bridge at [REDACTED]. I heard a shot but it sounded far away. A couple of minutes later, the gunner, APO [REDACTED] told the rest of the crew that a couple of suburban vehicles had stopped just west of the bridge. The crew and I looked to the west of the bridge and saw 4 vehicles stopped. A man was screaming and was holding what appeared to be the limp body of an approx 6 year old child. I rushed to the truck to retrieve my aid bag and proceeded down the side of the hill with 3 other soldiers to treat the child. Upon getting to the bottom, I discovered that due to triple strand concertina wire. I could not get to the casualty. A Fire Troop patrol with another medic was notified and arrived shortly after I did. One of the men was screaming that the child had been shot by soldiers in a HUMV. He pointed towards the east and [REDACTED], [REDACTED] secured the scene and extracted the casualty to [REDACTED] for treatment.
