I [REDACTED] would like to make the following statement under oath.

A/1-41 IN does not have a published SOP for addressing a perceived threat. In regard to a perceived threat leaders in this company are taught and expected to act IAW doctrine, commonsense, compassion and Battle Drills. Each leader has a very prescriptive list of criteria that falls within the published ROE to ensure they are making the right decisions which knowingly affect the outcome of our actions. In this particular case, the perceived threat was continuously observed and surveyed throughout the course of the engagement. The leader on the ground decided to action his platoon against the threat through Battle Drill 1, Platoon Attack. The measures taken were immediately to deter the threat, until certain factors led to the decision to use greater force. Continuing to observe the threat, and during the maneuver, the threat increases as did the response to the threat. I see nothing wrong with the escalation of force that was used during the engagement.








Picture 1 - Eastern edge of the small canal. This picture was taken from the initial position of the local national, facing northwest. RTE [REDACTED] is visible in the background.
