I went to my Home. we have decided as Family Having break Fasting (dinner)-Ramadan- in any Restaurant, and my wife she was at her parents Home. because I was in duty For 18 days. So at 5.00 PM I passed by to pick her up From her parents house.

in [REDACTED] area. So we went to [REDACTED] Area we had purchasing some pastry and after that we back to [REDACTED] area to having dinner at [REDACTED] street. ([REDACTED] area), in any one restaurant, but my wife she refused coming down because security situation. So we took our food to go. and I did hand over this food for her through the car window and I had back to driver seat, I have all wariness as Emergency Lights on. Time was 6:30 PM so I moved my car and the street was empty from people & cars. during my movement to forward, I heard some fire shoot (only one) was very loud, causing dust in my car, and seats cushion tear down after that two vehicles were pass my vehicle. Type of it HUMMER (Humvees), which U.S. Army used. These (Hummers) drove with head light off and did fire shoot without warning. and I was look to my wife I saw her body. Then I drove my car to hospital. then she pass away.

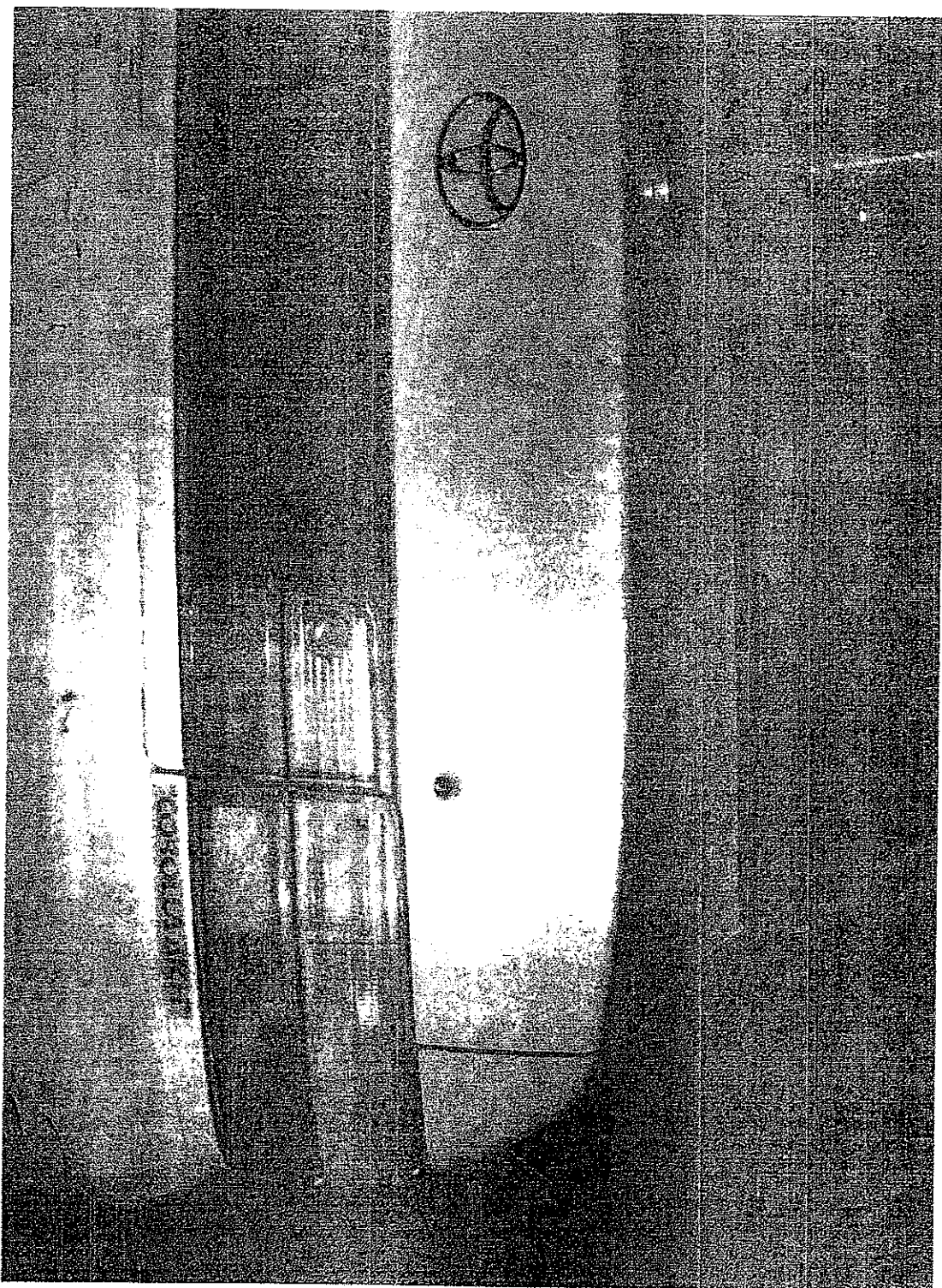

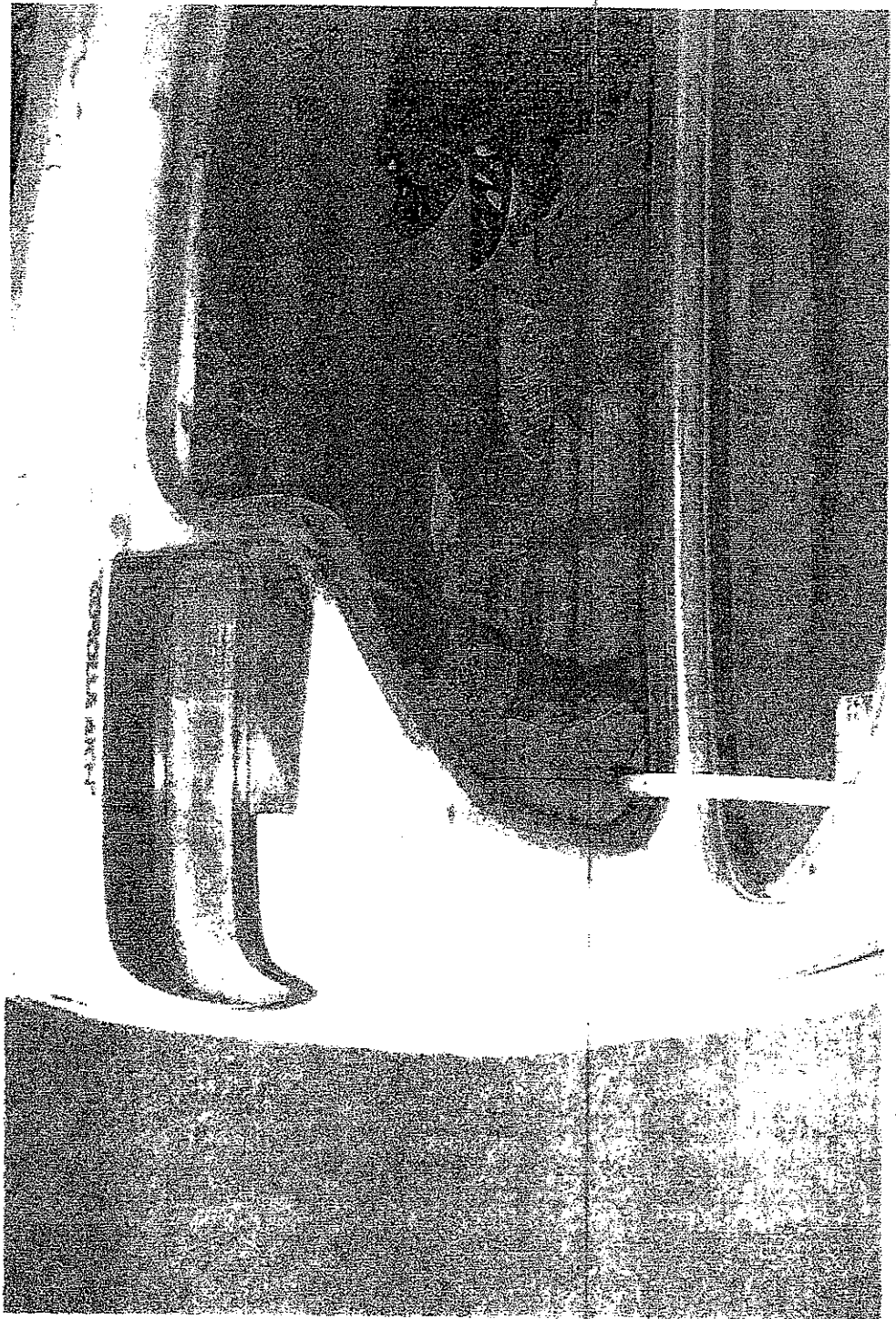

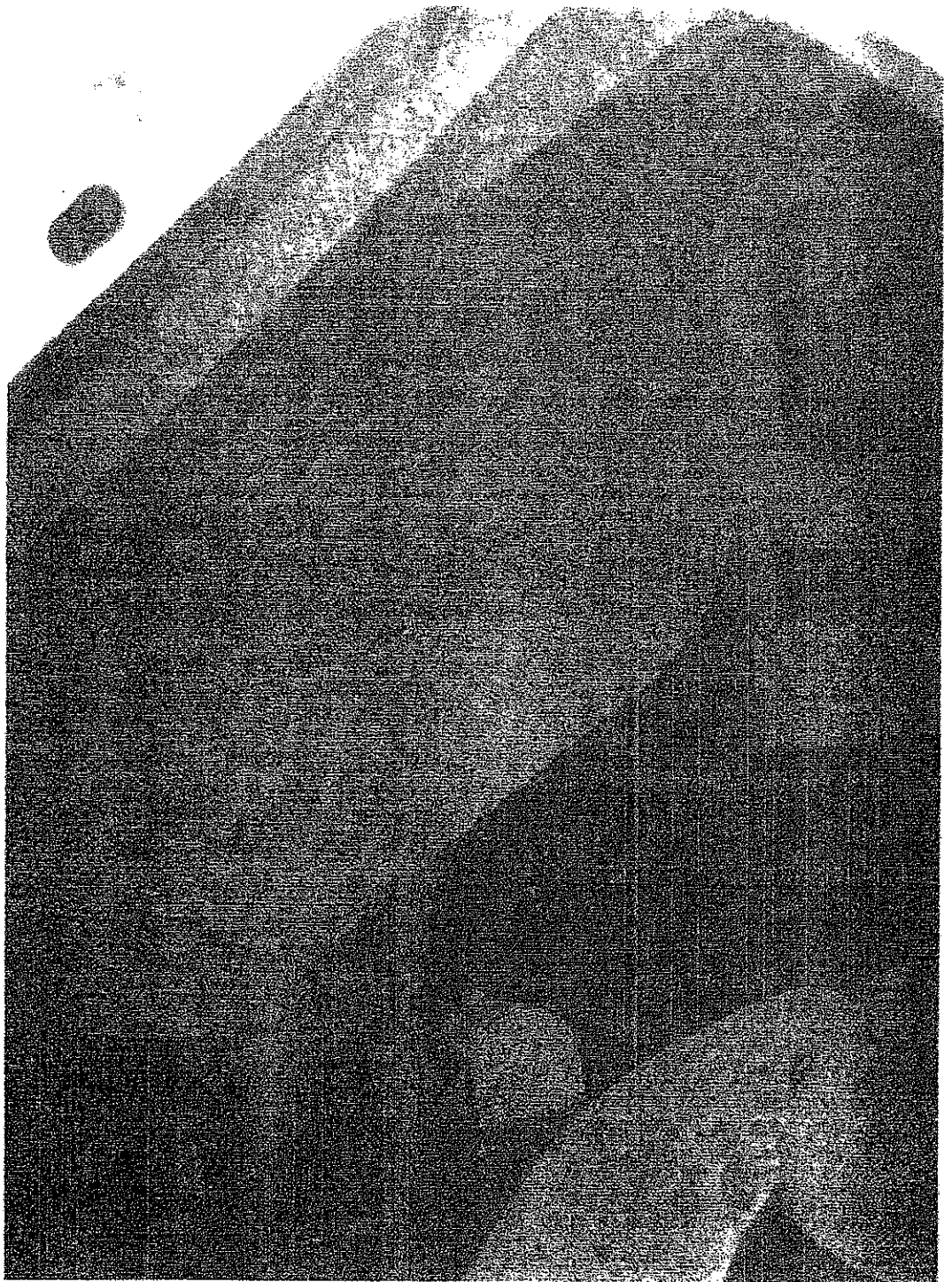
Side view of the vehicle with the antenna sticking through the bullet hole located under where the trunk door would have covered had that hole not been patched up. The Red Dots indicate entry and Exit points during it's trajectory, before stopping at the windshield.



The entry hole on the night of the incident.



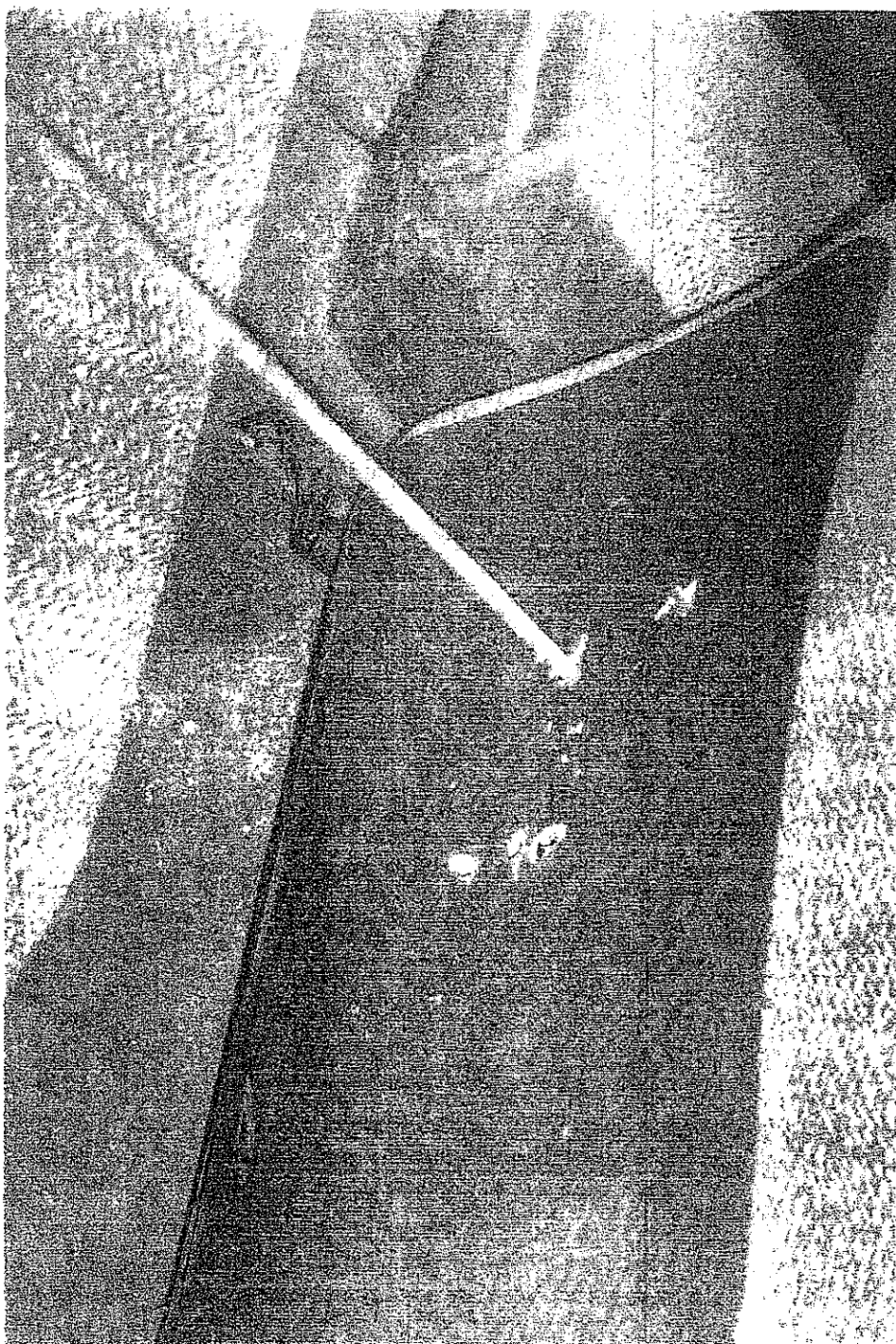
Antenna stuck through the previous bullet hole in an attempt to show the trajectory. Notice the downward trajectory as the round passed through the trunk and in towards the passenger compartment.



The continuation of the path of the round as it traveled through the back seat, through the passenger compartment, and into the back of the passenger seat where the woman was sitting. Notice some fragmentation in the back of the passenger seat as the round began to break apart and also carry bits of debris with it.

Here is a close up photograph of the trajectory of the round as it entered the passenger seat where the woman was sitting. The antenna, again, represents the path of the round.
