9. I, [REDACTED], WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On 02NOV05 at around 1000 we were given the Operations Order for a [REDACTED] mission to be conducted on 03NOV05. The Commander specifically made sure to cover ROE, and asked at the end of the brief if anyone had questions. All personnel that were on [REDACTED] were present, and none had questions about the ROE. We were then inserted around 0245 on 03NOV05. My team, team 1 was located just south of [REDACTED] A on the eastern side of MSR [REDACTED], just off of RTE [REDACTED], and consisted of SPC [REDACTED], PFC [REDACTED], and PFC [REDACTED]. I made the decision to split my four man team in twos, in order to better to cover our assigned sector. PFC [REDACTED] was with SPC [REDACTED], and PFC [REDACTED] who was the RTO, was with me. The majority of the morning was quiet in our sector, but we did hear occasional small arms fire to the west of our position. There was also an IED at around 1200 south of our position. At around 1330 I was scanning my area when I heard a single shot fired. I immediately told my RTO to notify our day [REDACTED] element that we had contact, and then I went to see what was going on, since I could hear screaming and a car engine revving. When I reached SPC [REDACTED] location I asked what had happened and he told me that a car had pulled up near his position and that he had monitored the two male occupants in the front talking and making hand gestures toward [REDACTED] and then he said one picked up a cell phone, and that was when he told me he fired. I then went to check out the vehicle and saw the driver trying to leave the area. I had not seen the passenger at that time, so I fired three warning shots with my 9mm at the ground in front of the vehicle. The vehicle then stopped and my QRF reached my position. The medic began to treat the WIA, and I went to brief the Platoon leader on what had happened. We then called in a 9 Line MEDEVAC for the WIA, and notified the ING about the KIA and car. I do not know what became of the woman who was in the back seat, or the two children she had with her.

WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On 03 Nov 05 my element was conducting sniper operations on MSR [REDACTED] south of [REDACTED] Vic. grid [REDACTED]. At around 1330 while I was scanning my area I observed a shot fired from my other sniper element in the [REDACTED]. I immediately told my RTO to call our QRF to come and assist with our operation. While I went to SPC [REDACTED] position. I then asked what had happened and he told me that he observed the car drive up to our position and conduct a short halt while the two male occupants talked and made hand gestures towards MSR [REDACTED] as well as my [REDACTED]. Once the shot was fired and I talked to SPC [REDACTED] the vehicle then tried to leave the area and I proceeded to fire three warning shots at the ground in front of the vehicle with my 9mm to get it to stop. I then went towards the vehicle and observed one male bleeding from his face. He had been hit by the other sniper element. I also heard a woman and children crying in the back seat. I did not know at the time that there was a second male occupant who was KIA in the passenger seat. I kept the vehicle stationary until my [REDACTED] QRF showed up. The medic then dismounted and gave aid to the WIA, while I explained the situation to the Platoon Leader. We then called in a 9 line MEDEVAC for the WIA, and also contacted the local ING to come pick up the KIA as well as the vehicle. I was then informed that [REDACTED] relayed that we were to displace from our [REDACTED] and be taken back to [REDACTED] by our QRF. My team was picked up at [REDACTED] and then brought back to FOB [REDACTED] where I briefed my CO on the days events.

I waited and observed this vehicle as they look like they were casing the area to set another IED, after they had pulled up to within 15 meters of my position. I continued to observe as they pointed at two old IED traps. It was obvious that they were going to set another IED, after I was certain they were about to set it up, I took the shot so they couldn't set the IED.

On Thursday Nov. 3rd 2005 at 13:30 we were on a mission between [REDACTED] and [REDACTED]. We had had reports earlier that a black sedan had and was planting IED's in our AO that morning. We also had small arms fire all around us, but was not directed toward us I believe. This particular black sedan had been driving around the area a hunch from the time the IED went off to the south of us. I then came to a stop about 15 meters from my position. I observed two males pointing and making hand jesters toward Route [REDACTED]. Then the driver pick up a cell phone and was talking in a loud voice while still making hand jesters to the passenger. I believe they were talking about where to put an IED. There was a old IED hole in the direction were they where pointing. I felt that there was no doubt that this was the target vehicle and so I engage the driver. The passenger was also hit and after that the team leader radioed QRF so not to give up our position. When the QRF arrived we (the [REDACTED] team) pulled security and later were taken to [REDACTED] for further instructions.

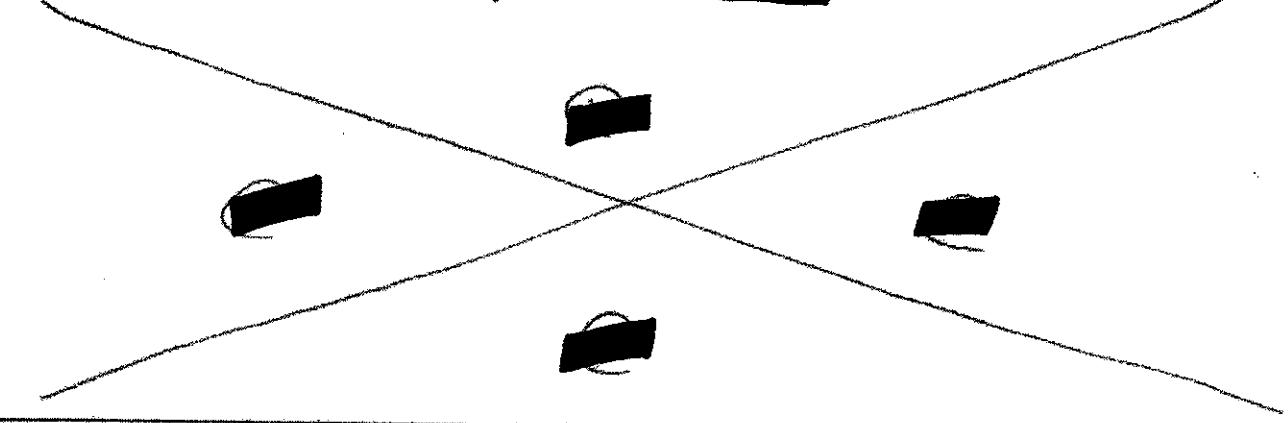

Then Team One had to be extracted since they were not in a Bldg. back to [REDACTED].

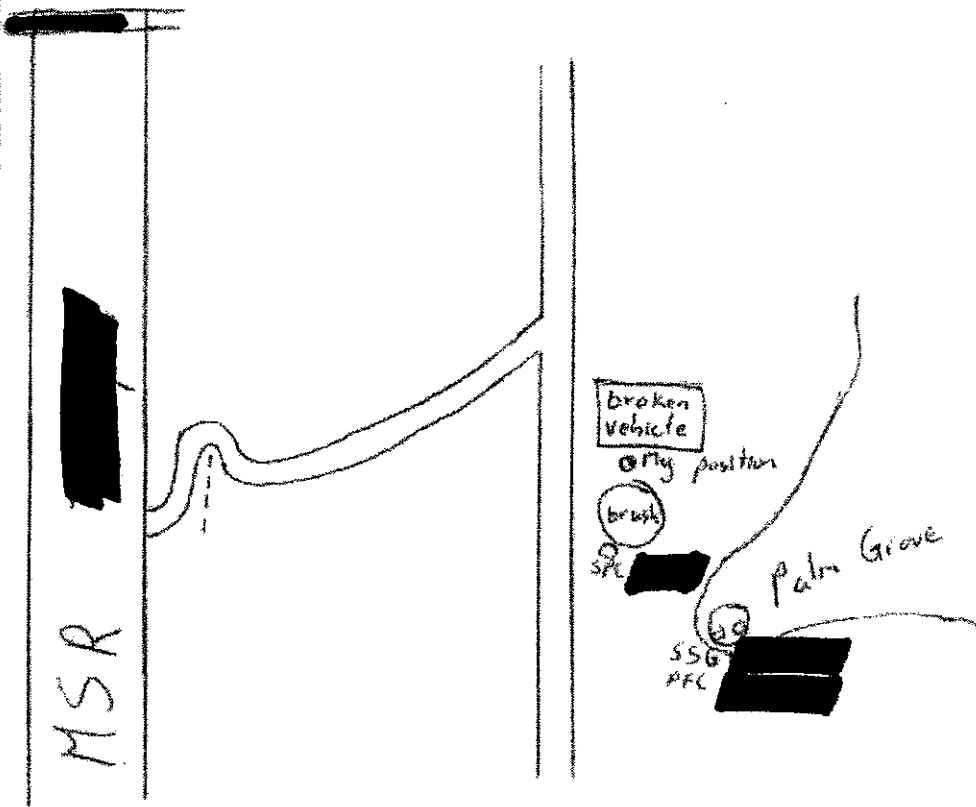
