1. The Government requests a delay in the Article 32 proceedings until at least 18 May 2005 and that the hearing in the case be scheduled for 18 May 2005. The reason for this request is that SSG Timothy Nein and SGT Leigh Ann Hester, two witnesses in the case, will be on R&R leave from 26 April 2005 until approximately 14 or 15 May 2005. Defense counsel will require at least one day on which to interview the witnesses after their return from leave in order to prepare for the hearing. The undersigned has another trial scheduled for 17 May 2005 and will be unavailable on that day.
2. SSG Nein and SGT Hester are key eye witnesses to the alleged Attempted Murder. It is important that they be able to testify in person, instead of telephonically, so that the investigating officer can assess their credibility and so that defense counsel can conduct full and complete cross examinations. Neither side will be prejudiced by a delay in the hearing until 18 May 2005. The Government has discussed the proposed date with defense counsel and there is no objection from the defense. The Government is not in danger of exceeding the 120 day speedy trial provisions of R.C.M. 707. The Government does not anticipate the need for any further delays and has confirmed that its other anticipated witnesses will be available on 18 May 2005.
3. Because this request exceeds the scope of the Article 32 Investigating Officer's authority to grant delays and is later than the deadline for the Article 32 Investigating Officer to submit his report, the request must be approved by the Commanding General, Multi-National Corps-Iraq, the appointing authority.

SUBJECT: Article 32 Investigating Officers Findings in the United States v SGT Ricky  
A. Burke

1. Based on the evidence and testimony presented to me at the Article 32 Hearing conducted on 18 May 2005 at Camp Victory Iraq, I find there are reasonable grounds to believe that Sergeant Ricky A. Burke did shoot a non threatening enemy combatant with an M4 rifle on or about 20 March 2005 in Salman Pak, Iraq.
2. It was reasonably demonstrated to me during the hearing through both testimony and the evidence presented that SGT Burke possessed the means (an M4 rifle), the motive (witness statements to the effect that SGT Burke was attempting to determine what the criteria was to kill enemy combatant prisoner and get payback), and the opportunity (guarding the enemy combatant alone) to commit the offense alleged by the Government. Based on all the testimony and evidence I reviewed, it is my opinion that SGT Burke shot a non threatening enemy combatant and that in the case of United States v. Sergeant Ricky A. Burke should go forward to a General Court Marshal.
3. One issue that was highlighted during the hearing was the testifying Soldiers general lack of understanding, knowledge, and training on treatment of enemy prisoners, Rules of Engagement (ROE), and Use of Force. Although, most Soldiers testified that they received some prisoner handling training prior to deployment in either a classroom briefing setting or a classroom briefing followed by hands on training, the majority of the Soldiers who testified seem to be uncomfortable on how they were to search and then secure enemy prisoners. Additionally, the Soldiers understanding of the ROE and Use of Force varied from the 617<sup>th</sup> Military Police Company to B Battery 1-623 Field Artillery. I do not believe any one soldier could articulate the same understanding of the ROE and use of force guidance. I recommend that additionally training be conducted for both units on prisoner handling, ROE, and use of force. I believe this additional training would benefit both organizations by helping to reduce the confusion on policies pertaining to prisoner handling, ROE, and use of force thereby assisting Soldiers to be more effective in the performance of their duties.

IO: (Said to accused counsel): This is a formal investigation into a certain charge against SGT Ricky A. Burke ordered pursuant to Article 32(b), UCMJ, by LTG John R. Vines. On 28 April 2005, I informed you of your right to be represented by civilian counsel at no expense to the United States, military counsel of your own selection if reasonably available, or military counsel detailed by the Trial Defense Services. You informed me that you desired to be represented by CPT Christopher Krafchek of detailed military counsel.

Let the record show that CPT Christopher Krafchek is here present with you.

IO: I want to remind you that my sole function as the Article 32 investigating officer in this case is to determine the truth of the matters stated in the charge. I shall also consider the form of the charge and make a recommendation concerning the disposition of the charge that has been preferred against you. I will now read to you the charge, which I have been directed to investigate.

(At this time defense counsel may waive the reading of the charge)

IO: It is as follows:

Charge (I): Violation of the Uniform Code of Military Justice, Article 80.

Specification (1): In that Sergeant Ricky Allen Burke, U.S. Army, did, at or near Salman Pak, Iraq, on or about 20 March 2005, attempt with premeditation to murder Hadi Saleh Khalid Al Ujuhishi by means of shooting him in the head with a firearm.

I will now show you the charge and specification.

(Hand the charge sheet to defense counsel and accused)

### **OPENING STATEMENTS BY INVESTIGATING OFFICER**

This is a formal investigation on certain charges against SGT Ricky A. Burke under Article 32(b), UCMJ ordered by LTG Vines. Let the record show that CPT Christopher Krafchek is here representing SGT Burke. My sole function in this investigation is to determine the truth in the matter stated in the charges and make recommendations in the disposition of the charges.

I will now read to you the charge. Violation of the UCMJ, Article 80. The specification: In that Sergeant Ricky Allen Burke, U.S. Army, did, at or near Salman Pak, Iraq; on or about 20 March, attempt with premeditation to murder Hadi Saleh Khalid Al Ujuhishi by means of shooting him in the head with a firearm.

MAJ Packer informed SGT Burke about his rights and mentioned the witnesses that he will call. SGT Burke stated that he does not want to call any other witnesses.

The following witnesses called by the Investigating Officer were sworn and testified in substance as follows:

**CPT Todd M. Linder, 617<sup>th</sup> Military Police Company, Camp Victory, Iraq, APO AE 09342**

CPT Shepherd submitted photos that were marked Prosecution Exhibits 1 to 12 as evidence.

**QUESTIONS BY INVESTIGATING OFFICER**

I arrived after the ambush at approximately 1210 and my initial position was to the south. When I got there they were not in contact anymore so I left one team to set up a cordon then I linked up to the ambush sight. In general, things have calmed down and they were initiating MEDAVAC and preparing the LZ. Everybody else was pulling security. There were still three enemy casualties when I arrived.

I am not really familiar with SGT Burke. Most of the casualties have been MEDAVACed and one detainee was left and he is not the one in question.

**DIRECT-EXAMINATION**

The initial patrol was made up SSG Nein, who is the squad leader, SGT Hester, SPC Cooper the gunner, SGT Morris, and SPC Ordunez. On the trail truck is Mack, Haynes, Rivera, and the medic. Three soldiers were wounded, it was Mack, Haynes, and Rivera. The soldiers were MEDAVACed. CPT Linder pointed to the diagram where the soldiers were MEDAVACed.

The group that I had stayed to do MSR security. We clear the grounds of IEDs and we maintain control of the AO. Anybody in the convoy from B/623d will have contact with us. I am not aware of prior animosity in B/623d. I knew two days prior to that there was a B/206 engineer that died in an ambush. We conducted an AAR after this incident. We collect the statements for documentation for Purple Hearts. I did not have any knowledge of any incident prior to the writing of those statements. Those statements pertain to the actions from combat.

I became aware of the allegations on the 23d of March. I heard that a soldier from 623d shot one of the wounded Iraqis and I asked SSG Nein about it and he told me what he knew. I asked SSG Nein if he saw the soldier pull the trigger and he said "no". All he knows is he heard a shot go off. CPT Linder said that a soldier from his unit wrote a statement about a soldier shooting one of the insurgents. I also told CPT Linder what I knew. I did not bring it out right away and I also do not want to bring discredit to what happened.

I reported the incident to LTC Stevenson, the Battalion Commander.

## CROSS-EXAMINATION

SSG Nein heard the statement a soldier made that a wounded insurgent was shot while he was walking away and he turned around. It looked to me as if it is just a "he said she said" statement. SSG Nein is in the law enforcement in a National Guard unit. All I have was one soldier's word of what he heard, not what he saw.

Since 617<sup>th</sup> is a unit outside my brigade, it is possible that they are operating with a different ROE.

## QUESTIONS BY INVESTIGATING OFFICER

We are in the outermost position where element 14A is. There was no more firing at that time. When we were by the canal, to the best of my knowledge, it was only me and SGT Hester who were there. I was approximately at ASR Detroit, by the intersection of the two canals.

I linked up with SGT Burke at this area (pointing to the location in the diagram). Nobody else was with me at this point and I never knew SGT Burke at that time. We proceeded to the trench line of the canal until we located one AIF. The AIF was lying down, still alive and conscious. I could not tell if he had any wounds at that time. At that time SGT Burke told me that he would like to shoot the AIF. I said no and that we could be able get some information from him. The AIF started to sit up using his right hand to push himself up. At that point, I still had to check on other AIFs and weapons.

SGT Burke said that we just can not leave the insurgent here and I agreed. I told him just to pull security. I did a visual inspection of the area and did not observe any weapons in that area. Walking about 50 meters away, I looked back and saw SGT Burke holding his M9 pistol. I asked SGT Burke if he was ok and he said "yes". I kept on walking away until I heard a gun shot. I was not worried about the insurgent that time if he was dead or alive. I was worried about the welfare of the whole element.

## DIRECT-EXAMINATION

The insurgent was in the trench. I did not see any AK 47s in the opposite slope where the insurgent was. The closest AK 47 was about 5 to 10 feet down the trench line. I heard SGT Burke say "its payback time." I believe he said it twice. My initial response to him was "no." The soldier who fired the shot was still at the south side of the trench when I looked back.

## CROSS-EXAMINATION

SGT Burke said that he was getting ready to help conduct security. I believe that SGT Burke did not comply with the ROE at that time. The closest weapon was about 5 to 10 feet down the trench line. I do not recall seeing anybody else in the area when I heard the shot. I was about 50 meters away from the 623d soldier (SGT Burke). I saw the insurgent fall back on his side after the shot.

One insurgent surrendered to me and I engaged about 7 more. There was no more shooting going on when I called the cease fire. I did not notice a name on SGT Burke's Kevlar. If I had flexi-cuffs with me, I would have placed them on the insurgent. I only heard one shot that time and it was coming from an M9. SGT Hester also came down to the canal.

The insurgents were well prepared to fight that day. They were heavily armed.

## REDIRECT-EXAMINATION

CPT Shepherd submitted photo of the insurgent as Prosecution Exhibit #13. SSG Nein identified the photo.

## QUESTIONS BY INVESTIGATING OFFICER

SGT Morris identified his location based on the diagram on the screen. He also pointed to the area where he saw SGT Burke fire a shot from his 9mm pistol.

I searched the AIF thoroughly and did not find anything. The insurgent was not violent and very complacent. I searched him for about 5 minutes. I did not place flexi-cuffs on him. I also did a visual search of the area (showing it on the diagram). The AIF who was shot was in the last MEDAVAC. I was about 10 feet away from the victim when I heard a shot. I saw SGT Burke standing with his M4. I heard another shot about 8 to 10 minutes after the first shot.

## DIRECT-EXAMINATION

I heard that the day before a soldier in SGT Burke's unit was killed.

I was in the MSR side when I was walking toward the insurgent. I did not see any weapons when I was walking toward the AIF. I didn't believe that the AIF was a threat to me, he was hurt. I searched him after the first shot was fired. There were no weapons within reach at that time. If there were weapons, I would've known and confiscated them.

I did not see the 623d soldier dispose of any AIF weapon. I went with the insurgent to LSA Anaconda via MEDAVAC. I noticed the features of the victim change when I saw him in the helicopter, particularly the swelling of the head.

A bullet casing was found in the area during investigation.

CPT Shepherd showed SGT Morris Prosecution Exhibit #13 for Identification.

I do not remember any American soldiers engaging with M16/M4s during the course of this engagement at the MSR site. As soon as SSG Nein and I got near the canal, I called for air support and SSG Nein called cease fire. As I went down the canal, that was the first time I heard an M4 go off at all. The second shot also sounded like an M4.

CPT Brown showed a photo to SGT Morris and he identified it as the AIF member. The wounds in the picture matched with the wounds I saw when I did a search. The wounds were not life threatening at that time.

#### CROSS-EXAMINATION

At this time, SGT Morris demonstrated how he searched the AIF using CPT Brown as an example. It took 2 minutes for him to do the search. CPT Shepherd had it noted that the conditions during the actual search were different like: SGT Morris was wearing full battle rattle, it was in a trench line, and on a slope.

I did not see SGT Burke shoot the insurgent.

SGT Morris described SGT Burke's position when he saw him after he heard a shot.

SPC Ordunez walked away with SGT Burke. I did not hear SPC Ordunez say anything to SGT Burke. I do not know if they had a conversation.

The insurgent did not have an ammo vest at that time.

SGT Morris described the scene where his group was located using the diagram on the screen.

I went back to the ambush site with CID and found a casing from an M4.

SPC Ordunez was standing right there when the second shot occurred.

**QUESTIONS BY INVESTIGATING OFFICER**

Using the diagram on the screen, SPC Ordunez pointed to his location at the battle field after the cease fire was called. He identified the sector he was covering. I was a little bit shocked because of what just happened. The soldiers were well organized during that time.

I did not hear any shot fired right after the cease fire was called but I heard shots later on coming from the canal. I do not know exactly how many shots I heard at that time. I did not see any AIF moving around at that time. I saw SSG Nein at the trench line, there was somebody else with him. I helped with the evacuation of AIF Casualties later. I flew with the second flight going to Anaconda.

**DIRECT-EXAMINATION**

SPC Ordunez left the turret and proceeded to a location he is identifying from the diagram on the screen. When I left my truck, I proceeded to SGT Rivera's truck. At that time I took some flexi-cuffs to SGT Ware who was at the orchard. I came back and walked over the north-west side of the canal. I joined up with SGT Morris and the 623d soldier.

I witnessed the 623d soldier shoot the wounded AIF. I was on this side of the canal (pointing to the diagram). SGT Morris was ahead of me. The 623d Soldier asked me "What do you do when they are still alive?" I responded you shoot them if they are hostile. Very shortly after that I heard a shot from an M4. I was approximately 5 to ten meters away from the 623d soldier and insurgent when I heard the shot. The 623d soldier had an M4 in his right hand. The 623d soldier did not say anything about the insurgent having a weapon or about to have a weapon. The AIF was lying on the bank of the canal when I heard the shot. I did not see any weapons close by the AIF. I did not think he was a threat and he was also injured.

CPT Nolten showed SPC Ordunez Prosecution Exhibit #13 for Identification.

**CROSS-EXAMINATION**

I have a full view of my sector from the turret and I saw a soldier holding his M9 pointing his pistol toward an AIF. I do not remember which hand was holding the pistol and I did not see any other weapon. I then went to the orchard and walked up toward the canal where I saw SGT Morris and SGT Burke. It took me maybe 20 minutes to get to those soldiers. When I saw the insurgent that SGT Burke shot, I walked out to SGT Morris.

SGT Burke was standing next to the insurgent before he shot him. I heard one shot for sure and I believe I heard two, they were both from the M4. The shots sounded like they both came from the M4. I do not know the time between the two shots. I told you last night that the shots were "pop-pop." SGT Burke asked me what I would do if they were still moving and I said that I would shoot them if they were still hostile. It was a matter of seconds after SGT Burke asked me

that question then I saw him shoot. I only remember seeing him shoot once. I saw the shoulder area of the body jerk after the shot. I believe that I saw SGT Burke's rank on his vest. I was at the other side of the canal and SGT Burke was directly across from me. SGT Morris was 15 to 20 meters from me. I did not see SGT Morris do a pat down search. I had full view of SGT Morris and SGT Burke all the time.

I saw the photo that CPT Nolten just showed me, I do not know where I saw it before. I talked to SGT Nein and SGT Hester before about what's going on. I did not see SGT Nein in the area when I saw the shot. I was not charged with any offenses.

I engaged with the insurgents during the time of the incident. I do not know the exact number of insurgents I engaged. I think of this incident everyday but it does not affect my job. I have a decent memory of the incident.

#### RE-DIRECT EXAMINATION

CPT Nolten asked SPC Ordunez if he has a photographic memory and he responded yes and he figure stuff all the time. I walked the trench toward SGT Rivera and later on I was with SGT Morris, the 623d soldier, and the wounded AIF insurgent. I do not know how close SGT Morris and the 623d soldier were to the insurgent, 40 to 50 meters, maybe.

#### RE-CROSS EXAMINATION

I was a little amazed at what just happened. I haven't been to Mental Health. I talked to the Chaplain after the incident.

#### QUESTIONS BY INVESTIGATING OFFICER

I met with SGT Burke and SGT Morris before they got to the insurgent. I did not see SGT Morris search the insurgent. I saw SGT Burke shoot the insurgent.

#### RE-DIRECT EXAMINATION

At this point CPT Nolten showed SPC Ordunez Prosecution Exhibit #14 for recollection purposes.

This was the statement I gave at the CID office. The 623d soldier asked me what to do if the insurgent was still moving. I wrote this statement to CID. When the 623d soldier asked me the question, he was already in the canal. I think he's referring to any of them in the area.

#### RE-CROSS EXAMINATION

CPT Krafchek asked SPC Ordunez "In your testimony, you said that you were moving with SGT Morris and SGT Burke when you came upon the insurgent then he shot him. Is that correct? Yes, sir. We walked for about 50 meters.
