



SUBJECT: Appointment as an AR 15-6 Investigating Officer.

1. Reference: AR 15-6, Procedure for Investigating Officers and Boards of Officers, 11 May 88, with Change 1, 30 Oct 96.
2. On 22 September 2004, elements of the 272d Military Police Company, 759th Military Police Battalion were involved in a Local National shooting, resulting in her death, while monitoring the Al Rasheed IPS Headquarters. There were no injuries to soldiers or damage to vehicles reported. You are directed to investigate the circumstances behind the shooting death of an Iraqi National by PFC Combs.
3. Please supply a brief description of each casualty, including 1) full name; 2) whether or not the casualty was engaged in hostile activities. You may coordinate with the CMOC on this investigation in order to obtain this information.
4. SSG Monica Carlile, Battalion Paralegal, 759th Military Police Battalion, has a packet of statements for your assistance. You are directed to go to the MNC-I, DSN 302-822-2500; Administrative Law office for an initial brief. You will formally interview all soldiers who have previously made statements in this case. You will also interview all witnesses identified as having knowledge of these events. You are authorized to investigate any issue(s) that arise during your investigation that are related to the primary purpose of your investigation.
5. During the course of your investigation, you will record all interviews on DA Form 2823 (Sworn Statement). If, during any interview, you suspect a violation of the UCMJ by the person you are interviewing, you are required to stop the interview, and advise the interviewee of their Article 31(b) rights, using a DA Form 3881 (Right Warning Waiver Certificate). You may continue to interview that person if they agree to make further statements. If they do not, terminate the interview and contact your legal advisor. If you have any questions about whether or not the person made a knowing and valid waiver, terminate the interview and contact your legal advisor. You will advise all persons being interviewed that their statements can be discovered under



MEMORANDUM FOR RECORD

SUBJECT: Local National Shooting, AR 15-6 Investigation

1. Reference: Memorandum, Appointment as an AR 15-6 Investigating Officer, 27 September 2004.
2. An investigation into the circumstances behind the shooting death of an Iraqi National by PFC Combs, James E. III is complete.
3. On 22 September 2004 at approximately 1345 PFC Combs' assigned M-4 weapon (S/N W053730) was discharged at IP station #10 (Al Babal Shikh) fatally wounding an Iraqi Local National.
4. On 27 September 2004 I was appointed as the AR 15-6 Investigating Officer, tasked with investigating the circumstances surrounding the death. I was informed that CID was working the case and was able to obtain a copy of their initial report, which is enclosed. It was in the CID report that I learned the fatally wounded local nationals' identity to be Mrs. Husaene, Babe'a'a. The CID report said she resided adjacent to IP Station #10. I was also able to obtain the original statements from SFC Pryor, SGT Duran, and PFC Combs. These statements were taken directly after returning to Camp Cuervo after the incident. (Statements Enclosed)
5. On 1 October 2004, at 0945 I responded to IP station #10. Upon arrival I was able to meet with PFC Combs' team leader SGT Duran. (Statement Enclosed) According to SGT Duran, PFC Combs was inside the bunker on the top of IP Station 10 conducting force protection duties, when PFC Combs' weapon discharged. SGT Duran said he did not actually see PFC Combs fire the rifle, but knew he had done it because PFC Combs was the only one in the tower, and he observed the dust being blown out of the bunker ports. SGT Duran said he had been checking on PFC Combs at times throughout the shift. The last time SGT Duran checked on him PFC Combs was seated in the chair weapon in lap facing out of the bunker. According to SGT Duran, PFC Combs had been briefed on the proper weapon status, handling procedures, and weapon composure, such as weapon at the low ready. SGT Duran said in his original statement that following the shot, he observed a crowd gathered in the alley. He said he observed men carry what could have been a woman or child to a vehicle and drive off.

6. I then spoke with SPC Cook (Statement Enclosed) at approximately 1015. SPC Cook verified the same account as SGT Duran. He added that he went into the bunker about 10 minutes after SGT Duran went in to make sure everything was ok. According to SPC Cook PFC Combs appeared very pale and was visibly shaking. He added that when he saw Combs' weapon Combs had one hand on the weapon and the magazine in the other as if he had just cleared it. SPC Cook said that he heard SGT Duran then ask PFC Combs where the round had gone that he had fired. SPC Cook said he observed PFC Combs wave his hand in the direction of the alley and respond "that way."

7. I next took a series of photographs which are enclosed. The photos show the bunker and the alleyway where the local national was fatally wounded. (See index for photo titles) I also created a hasty sketch not to scale of the area, and later redid it on my computer. (Sketch enclosed)

8. After reviewing the statements on 4 October 2004 I responded to Camp Cuervo to interview PFC Combs. The interview took place at approximately 1200. (Statement Enclosed) In speaking with PFC Combs I learned the true status of his weapon to be on burst. This is in contradiction with his original statement and the statement to CID. According to PFC Combs while seated in the tower prior to the discharge he heard loud yelling coming from the alley in front of him and observed a sedan pull up. He said he saw several males jump out of the vehicle and open the trunk. PFC Combs said he had been bored and was trying to stay alert playing out scenarios in his head as to what he would do if confronted with a threat. Combs said while having these thoughts he placed his weapon on burst status, possibly when he saw the males jump out of the car and open the trunk quickly. PFC Combs told me he then decided the threat was no longer there and lowered his weapon failing to place the selector switch back on safe. PFC Combs said a short time following he raised his weapon again to scan his lane and accidentally discharged the weapon.

9. Conclusion. PFC Combs was negligent in his duties while conducting force protection at the IP station. His weapon should have been on safe unless he had identified a threat and was responding in accordance with the ROE for theater. PFC Combs also should not have had his finger in the trigger well, or on the trigger of the weapon unless he was ready to fire the weapon. This is what caused the round to be discharged fatally wounding Mrs. Husaene.

10. Recommendations. Recommend that no action be taken against the unit leadership. That PFC Combs is negligent in his duties and appropriate action should be taken. The family of Mrs. Husaene should be compensated for their loss.

SECTION IV - FINDINGS (para 3-10, AR 15-6)

The *(investigating officer) (board)*, having carefully considered the evidence, finds:

That PFC James E. Combs was present at IP station #10 on 22 September 2004, at approximately 1345 when a round was discharged from a weapon fatally wounding an Iraqi Local National.

That PFC Combs was pulling force protection duty on the roof of IP station #10 at the time of the incident.

PFC Combs was seated in the tower on the roof of the station facing the alley where the local national was fatally wounded.

That PFC Combs was holding his assigned weapon (M-4 S/N W053730), at the time of the discharge.

That the weapon was loaded, magazine inserted, round chambered, at the time of the discharge.

That the weapon selector switch was not on safe, but positioned on burst at the time of the discharge.

PFC Combs had the weapon pointed out of the bunker firing port toward the area where the local national was fatally wounded.

PFC Combs accidentally discharged a round from his assigned weapon that struck an Iraqi Local National, fatally wounding her.

That a functions check had been done by PFC Combs the previous night on his assigned weapon and it was functional.

That a functions check had been done by SGT Duran his team leader after the discharge upon return to Camp Cuervo, and the weapon was functional.

That PFC Combs had been briefed on the current ROE for the theater, and was checked by his team leader last about 10 minutes before the incident occurred.

That PFC Combs had been briefed by SGT Duran, on the posture of the weapon, and it was to be maintained at the low ready unless a threat is perceived.

That PFC Combs had identified a possible threat when he heard yelling from the alley close to where the local national was struck, and observed several local national males exit a vehicle and open a trunk.

That PFC Combs then raised his weapon, and placed it on burst, in order to be ready.

PFC Combs determined the local nationals not to be a threat, and then lowered his weapon forgetting to place the selector switch on safe.

That PFC Combs raised his weapon again with the weapon in a burst status, finger in the trigger well, on the trigger, and accidentally fired one round in the area of the alley where the local national was fatally wounded.

That the fatally wounded local national was identified as Husaene, Babe'a; female; residing in Al Nahada; adjacent to station #10




Sgt Duran stated everyone was good. I left the training room where myself, Sgt. Imley, the IPA, and our interpreter w/around 7 Iraqi Policemen were located. I immediately made my way to the roof top where I found Sgt Duran, Cook, and Combs located together in the guard shack overlooking Main St. and Wild. Combs said the shot came from his weapon, but he said his weapon was on safe. Cook OR Sgt Duran, I can not remember which. Said they were outside the guard shack and had only heard the round go off. Sgt. Duran and Combs were looking for the brass from the round that was discharged. I had noticed the 2 IPs on the roof top had left the roof after pointing at a crowd of about 15 to 20 Iraqi civilians formed up outside the station walls near the intersection. I went down to the second floor and

Q: In referring to your previous written statement what did you say to PFC Combs after the discharge and what was his res

A: I knew Combs had fired the round, because of the dust blown out of the bunker firing ports. I went in and observed PFC Combs was seated facing the alley that runs parallel to Main St. I asked Combs what he had fired at? Combs responded It went off, it was on safe! I asked him where the weapon was pointed? Combs replied somewhere toward the alley.

Q: Did you conduct a function check on the PFC Combs' weapon?

A: Yes I did. I personally performed one when we returned to Camp Cuervo and the safety worked, and the weapon was functional. Just something else to add, I personally make sure that we rotate our rounds so that the current round is not chambered over and over again causing the primer to slightly dent making it more susceptible to discharge. I can guarantee that his weapon was functioning properly.

I saw he had his weapon with one hand on it and had his magazine in the other, as if he had just cleared his weapon. I heard SGT Duran ask where the round had gone that he had fired. He told SGT Duran over there waving his hand in the general direction of the alley. It was soon after this I heard the IPs saying that a woman had been shot. I want to say that during that time there was about double the traffic and people as right now.

Q: When the above incident occurred how was PFC Combs seated in the tower?

A: I know that 10 minutes before he was in there with his weapon across his lap.

Q: So the weapon was not at the low ready or pointed outside the window?

A: No when I saw him 10 minutes prior it was on his lap.




