SECTION IV - FINDINGS (para 3-10, AR 15-6)

The (investigating officer) (board) , having careful , considered the evidence, finds:

1. On 09 OCT 2006 I was appointed the AR 15-6 Investigation Officer (IO) for the accidental death of one Afghan child during a direct and indirect fire engagement with enemy forces. This incident occurred on 08 October 2006 as 2nd PLT/A Troop conducted a patrol near Agasi village -- approximately 3km east of the Kamdesh PRT, Kamdesh District, Nuristan Province. I have conducted a thorough investigation of the circumstances surrounding this accident. My observations, conclusions, and recommendations are provided in the following format: facts, findings, and recommendations.

2. On 08 OCT 06 at 404z, 4x US vehicles from 2/A/3-71 Cavalry carrying 16x US soldiers and one interpreter left the Kamdesh PRT for a local patrol to conduct a bridge assessment. After completing the bridge assessment, the convoy continued further east in order to find a suitable location to turn the convoy around and return to base. During this phase of the mission, one of the vehicles malfunctioned with a broken gear box. The platoon conducted a maintenance halt a (b)(2)High. The platoon halted at this location for 60 minutes when they started to receive incoming RPG rounds and small arms fire. At 0545z, the 4x vehicles from 2/A/3-71 were engaged by 5-10 enemy fighters from the south with RPGs and SAF. A total of 6x RPG rounds impacted near the convoy, almost simultaneously landing in between the vehicles. 2/A returned fire with their vehicle weapons systems and personal weapons which included M16s, three 240B machine guns, and one MK.19. The gunners engaged specific targets of enemy fighters hiding behind rock walls. The patrol leader, SSG(b)(3), (b)(6) called his forward observer to conduct call for fire missions as he identified groups of fighters moving along the ridgeline. 3-71 CAV 120mm section at the Kamdesh PRT fired a total of 29x rounds of 120mm at grids (b)(2)High and (b)(2)High. The exchange of fire during the contact lasted for approximately 4 minutes. About 15 minutes after the firing ended, the broken vehicle was successfully towed to another truck and the entire convoy began their movement back to the Kamdesh PRT. During this time, (b)(2)High and the (b)(2)High team on OP Warheit both confirmed PID of three personnel seeking cover underneath rocks at grid (b)(2)High. These pax were most likely the enemy RPG team seeking to exfil south back into eastern Kamdesh.

(b)(2)High, (b)(3), (b)(6)

4. A few hours after the TIC was declared over, the Kamdesh PRT interpreters began receiving (b)(2)High that referenced a young boy was killed by the US forces. At 1100z 08 OCT 06, this report was later confirmed by the Kamdesh District police chief, (b)(6). (b)(6) reported to the A Troop Commander, CPT (b)(3), (b)(6), that a (b)(6) year old boy named (b)(6) was killed during the morning's fight. He reported that Rahmatullah had stepped outside of his home during the ambush when was killed by a shell fragment. (b)(6) also reported freely that this attack was planned and executed by Al Qaeda and HiG insurgents. A Troop Commander, CPT (b)(3), (b)(6) sent messages out to the surrounding village elders to come to the PRT on 09 OCT so that he could formally express his condolences and discuss reparations. On 09 OCT, CPT (b)(3), (b)(6) conducted two separate 'shuras' (meetings) with different members of the Kamdesh village leadership. The locals firmly understood the reason for this tragedy and blamed the enemy for the boy's death, not Coalition Forces. The locals expressed regret over the loss of a child, but did not place the any blame on the US Soldiers. On the contrary, the locals stated that the US Soldiers were simply doing their job. On 10 OCT 06, these same sentiments were reflected once again by the boy's family who came to the Kamdesh PRT to meet with CPT (b)(3), (b)(6) at his request. They admitted that enemy fighters are exploiting their farmlands and villages for their own nefarious purposes. The family, likewise, blamed the HiG and Al Qaeda for the death of their child, not US forces.

5. Based on the family's description of the boy's fatal wound, it was a result of either the 120mm mortar fire missions or the 2/A/3-71 MK.19 weapons systems. After conducting an interview with the patrol leader, SSG3, (b) he reported that his MK.19 gunner did not observe any structures anywhere along the ridgeline that he was firing.

6. From all the evidence presented it is clear that A Troop acted correctly during this engagement. They were acting in self-defense when they were fired at from multiple ambush fighting positions from an enemy force on higher ground all around them. The platoon's gunners engaged specific targets and did not report observing any non-combatants or structures while they were engaging their targets. The mortar fire mission was conducted by observers from multiple platforms and locations. The initial observer, SPC (b)(3), (b)(6) was the on the ground with 2nd Platoon during the TIC. He reported seeing 3 personnel moving along the ridge line from the same area in which they had just received RPG fire and small arms fire. When these personnel became concealed due to foliage, he passed their grid to observers on OP Warheight. OP Warheight and the (b)(2)High ISO of 3-71 CAV both confirmed that 3 personnel seeking cover underneath a rock. The OP Warheight)(2)High team served as the observers for these fire missions. At no time did they observe a civilian structure in vicinity of the target area. The preponderance of evidence including previous reporting, the aggressive tactics of the enemy that had ambushed the US platoon, and the reporting of observed fires during the entire TIC, clearly confirms that this was an accidental death. Based on my investigation, I find the death of this child, though tragic and accidental, was completely accidental and unavoidable in this case. A Troop has paid the family restitution in the amount of (b)(6)

SUBJECT: Appointment of Investigating Officer – Non-combatant Casualties

1. You are hereby appointed as investigating officer pursuant to Army Regulation (AR) 15-6 to conduct an informal investigation into the suspected death of a non-combatant by indirect fire during an engagement on 8 October 2006 near Kamdesh, Afghanistan.
2. Statements should be sworn if possible, using DA Form 2823 or Dari/Pashto equivalents. Your authority to administer oaths is the Uniform Code of Military Justice, Article 136(b)(4). If in the course of your investigation you come to suspect that an individual may have committed a violation of the Uniform Code of Military Justice or federal law, you must advise them of their rights under the Uniform Code of Military Justice, Article 31(b), or the Fifth Amendment as appropriate. Use DA Form 3881 for this purpose. Additionally, you may have to provide certain witnesses with Privacy Act statements before soliciting personal information. If you suspect misconduct by someone who outranks you, stop your investigation and seek guidance. Your legal advisor can assist you with these matters.
3. Your investigation should include interviews of all relevant parties that have information about the conduct of fires and procedures. Your investigation should also include interviews of all relevant parties that have information about the identity of non-combatant personnel killed or injured, the extent of injuries, as well as any property damage. Your findings must be supported by a preponderance of the evidence, and your recommendations must be legally consistent with the findings. Submit your findings and recommendations on a DA Form 1574. Your recommendations should include actions to be taken to correct deficiencies, to compensate victims, or to address any misconduct.
4. Prior to beginning your investigation, you will contact the TF Spartan CJA, MAJ (b)(3), (b)(6), at DSN (b)(2)High for an initial briefing and to obtain a guidance packet.
5. This investigation constitutes your primary duty until completed. It will take precedence over all other duties. Submit your report to the appointing authority within ten (10) days.

I, (b)(3), (b)(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

2nd PLT A TRP SP'd From Kamdesh PRT on or around 0400 Z on 08 Oct 2006 to investigate drill holes and damage to a bridge that lead to the PRT on the (b)(2)High We accomplished our mission with photographers and information we gathered on what we thought had happened. Soon after completion of mission we moved forward close to around 300 to 400 meters to the next turn around point where Pv(3), (b) Victor happened to have steering gear box issues and the victor became NMC. As 2 trucks (b)(2)High moved back to the PRT to secure the necessary parts required to fix the vehicle enabling it to be towed back to the PRT. We had 360 degree security with the 2 victors remanding and I had established two TRP's located about 300 meters from our position to the south. I put them in locations of somewhat level terrain and as far as possible to any houses that appeared to be there in terms of the map. Shortly after the 2 victors returned from the PRT we were engaged by RPG fire. Due to auditory exclusion I heard the first one detonate and nothing from that point on until I got on the radio. I knew they were firing at us from the right side of the draw near the second TRP I had placed there. As soon as I got on the radio I called to (b)(2)High and had him do a FFE mission on TGT (b)(2)Hig 4 rounds. As soon as the rounds hit I had suppressed the enemy enough to where they either stopped firing or fired far less shots then before. In order for me to ensure I killed the enemy I walked those rounds up the best path that appeared to be the refill route of that ambush site. I fired around 10 to 15 rounds with minor adjustments onto the enemy. after the firing ceased (b)(2)High took control of the mortars in order to action on 3 to 4 dismounts he had located hiding near and under a rock. After 100% accountability of personnel we began our push back to the PRT. It was a slow deliberate move back due to towing a victor. All that was still in effect after RTB was we had 2 A10's and one (b)(2)Hig on station being controlled by (b)(2)Hig and (b)(2)High
