CCIR Event: Escalation of Force reported by: 5-7CAV/1 BCT-3ID as follows: At 020830DEC2005 an EOF was initiated by a 32nd SIG BN convoy on a white truck in the Salah Ad Din province on (b)(2)High 6km southeast of Balad vic (b)(2)High As the convoy headed north, it came up on a white truck traveling ahead of the convoy and moving slowly. The lead military vehicle waved the truck off the road. As the convoy passed, the truck re-entered the convoy at a high rate of speed, aiming straight at the lead vehicle. The gunner of the lead vehicle fired 4 x .50 cal rounds at the ground near the truck which ricocheted up into the truck. The LN driver was killed. The passenger was uninjured. The 32nd SIG BN convoy continued movement to FOB Paliwoda without stopping. The EOF was not reported until the convoy reached FOB Paliwoda. The convoy did not check in with TF 5-7 when they entered the TF 5-7 battle space. Elements of TF 5-7 and the IP responded to the site to investigate. The IP recovered the body of the LN.

MEMORANDUM OF OPINION

SUBJECT: Claim of (b)(6) , 07-I41-375

- 1. Identifying Data:** (b)(6)
- 2. Date and place the incident occurred giving rise to the claim:** The claim occurred on December 2, 2005 in Balad, Iraq.
- 3. Amount of claim and date it was filed:** Claimant filed a claim for \$26,150 on 26 February 2007.
- 4. Jurisdiction:** This request is presented for consideration under the provisions of the Foreign Claims Act, 10 USC Section 2734, as implemented by Chapter 10, Army Regulation 27-20. This claim was properly filed in a timely manner.
- 5. Facts:** Claimant alleges his brother was driving a pick up truck on highway when a coalition forces ("CF") convoy shot and killed his brother near Balad. This also caused significant damage to his brother's truck. The Claimant's brother was driving the truck and pulled over to the side of the road as the convoy passed. The truck re-entered the convoy at a high rate of speed and headed straight for the lead vehicle. The CF then conducted escalation of force procedures and killed the Claimant's brother. Claimant provided a death certificate, court documents, a car registration card, a legal expert estimate, and witness statements.
- 6. Opinion:** A search of all available resources revealed the incident occurred. Due to the actions of the driver, U.S. Servicemembers properly engaged the vehicle. Consequently, U.S. Servicemembers did not commit a negligent or wrongful act and thus the U.S. is not liable. Alternatively, DA PAM 27-162, paragraph 10-3 states claims arising "directly or indirectly" from combat activities of the U.S. Armed Forces are not payable. AR 27-20 defines combat activities as, "Activities resulting directly or indirectly from action by the enemy, or by the U.S. Armed Forces engaged in armed conflict, or in immediate preparation for impending armed conflict." Here the damage was caused by combat activities. As a result, the claim is not compensable under the FCA.


