MEMORANDUM OF OPINION

SUBJECT: Claim of [REDACTED] (b)(6) 08-IH4-T009

1. Claimants name and address: [REDACTED] (b)(6) Kirkuk, Iraq.
2. Incident date and place the incident occurred giving rise to the claim: Incident occurred on 12 October 2007 in Kirkuk, Iraq.
3. Amount of claim and filing date: Claimant filed a claim in the amount of \$1.00 on 12 October 2007.
4. Chapter the claim was considered under and a brief description of the incident or of the issues raised by the claimant on reconsideration: Foreign Claims Act and Chapter 10, AR 27-20; claim filed for property damage.
5. Facts:
 - a. [REDACTED] (b)(6) claims that his son was shot by Coalition Forces while they engaged potential Unknown Enemy forces that had detonated an Improvised Explosive Device. [REDACTED] (b)(6) [REDACTED] (b)(6) was killed during this incident.
 - b. There were sworn statements, a story board, and pictures included in the submitted claim.
 - c. The incident was verified by the unit.
6. Opinion:
 - a. In order to form a basis for a claim under the FCA, the incident must occur outside of the United States and arise from either non-combat activities of the U.S. Armed Forces or by negligent or wrongful acts of military members or civilian employees of the Armed Forces.
 - b. There is insufficient evidence to suggest that this incident arose out of the negligence and/or wrongful acts of the United States Armed Forces. Any appeal must be submitted within 30 days.

, WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On 12 October 2007 at 0700 I along with 1SG (3), b and Third Platoon Delta Company departed the Forward Operating Base Warrior. At approximately 0720 on (b)(2) High the convoy encountered an IED. The first vehicle (D31) was struck by the IED on the left side of the vehicle. As soon as the IED went off I called up a contact report to our company TOC and let them know that we would have casualties. As I was calling the report the next two trucks (D36 and D35) started firing. I called D36 and asked what they were shooting at. D36 said they were shooting a man in black that was behind a bunker and was trying to exfil the site. After this report I ordered a cease fire. As soon as I ordered a cease fire the gunners stopped firing. We then started our CASEVAC procedures. After casualties were taken back to FOB Warrior and QRF arrived on scene I took dismounts out to clear the bunkers and ID the body that the scout weapons team located. I was surprised to find the body of a (b)(6) year old boy with a white shirt because all the reports I had received from my personnel were of a man in black. I found a local boy nearby and asked him to go get the Muktar of the village. The Muktar of the village came and we informed him of the deceased boy and asked if he could get the mother and others to help claim the body. The mother claimed the body and 4-5 others helped get the body back to the village. I then handed the IED site over to B26 (QRF patrol leader) and returned to FOB Warrior.

AT 0800 we left FOB Warrior out of gate 5.

Approximately 10 minutes later my first truck (D31) hit a pressure wire and 2 mortar rounds on (b)(2) High My gunner (D36) said he had PID on two individuals behind a bunker in the prone and after the IED exploded both began to run in opposite directions. I gave the order to engage an individual wearing a black dark colored robe. Once that individual went down I called cease fire because we did not have any PID on other targets. We then received aid from D35 and H6. I tried to help provide aid to D31's gunner (CPL (b)(3), b(6)) who had received shrapnel to his lower left back. Simultaneously, D35 started to take SPL (b)(3), b(6) who was injured to

received injuries to his face to EMEDS. After applying aid to CPL (b)(3), b(6) I applied aid to SPC (b)(3), b(6) who received shrapnel to his left forearm. I then tried to talk Avenger II onto the individuals we engaged. After several moments I told H6 (CPT (b)(3), b(6)) I needed to CASEVAC CPL (b)(3), b(6) and SPC (b)(3), b(6) to EMEDS. H6 took control of my patrol and it then went immediately to EMEDS.

We also tried to get PVT (b)(3), b(6) out of D31 but the truck was already on fire, and then the (b)(2)High rounds began to go off so we had to move ourselves and our casualties to cover.

Furthermore, I gave the go-ahead to engage the target because for some reason today there was no one out of their houses which they usually are moving about. Also, the target we engaged

Was approximately [redacted] to my 9 o'clock, hiding behind a bunker in an open field; and once the IED exploded the target started to run. The IED blast was not that big so the individual running could not have felt he was in any danger.

I, 1SG (b)(3), b(6), WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On the morning of 12 October 2007 at 0700 I along with CPT (b)(3), b(6) and Third Platoon Delta Company led by 1LT (b)(3), b(6) departed the Forward Operating Base Warrior. At approximately 0730 and (b)(2)High from the FOB the convoy encountered an IED along the route. The Vehicle in the lead was struck with the full force of the blast as it traveled under the powerlines that crossed the road.

On seeing the blast I started looking for a trigger man on the left side of the road. I saw a man dressed in black stand up and run away. The man was several hundred meters south of the convoy and road. The man was engaged with small arms fire from two vehicles at which time I saw the man fall or kneel down.

After the man went down a signal to cease fire was passed back from the commanders vehicle.

After the cease fire my vehicle went forward to assess the situation. Once forward my vehicle stopped beside the lead vehicle where SGT (b)(3), b(6) was trying to get the other wounded soldiers out of the burning vehicle. The vehicle was on fire due to the fuel leaking out of the vehicle and the fuel cans strapped to its rear. Within two or three minutes all Soldiers were removed from the vehicle except PVT (b)(3), b(6) PVT (b)(3), b(6) door was jammed from the explosion. We tried to extinguish the fire with fire extinguishers and dirt until the fire became too hot and the fumes too noxious to breath. Once ammunition in the vehicle started cooking off we had to stop and move a safe distance away. PVT (b)(3), b(6) was deceased in the right rear seat due to the massive head trauma incurred in the IED blast.

Once fire rescue arrived some 30 minutes later the fire was extinguished and cooled off then PVT (b)(3), b(6) remains were removed and placed in a recovery container and brought back to FOB Warrior.

It was told to me that there was a body on the field adjacent to the road and in close proximity to the path the man in black used. I did not see this person at any time during the event. *nothing follows*

Narrative:

While exiting Gate 5 of FOB WARRIOR KIRKUK 3/D/2-22 IN was struck by an IED. During the incident the HHC commander reported that a LN wearing black clothing had been seen fleeing the immediate area and was engaged with small arms fire.

Four soldiers were due to unmount and get clear of the truck however, one casualty was reported trapped in the burning vehicle and was unable to be freed. One WIA was immediately CASEVAC'd to FOB WARRIOR EMEDS. The QRF arrived at [redacted] (2) and CASEVAC'd two casualties to EMEDS. During the immediate follow up the QRF moved to secure the position of the LN seen wearing black; upon arrival they found one LN KIA that did not fit the original description. The LN KIA was a [redacted] (b)(6) year old boy.

SHADOW then reported following the individual wearing black into a house. At 0957 the IP arrived to help secure and search the area under the command and control of 2/B/2-22 IN. Prior to the cordon going into position, shadow observed an individual in black clothing fleeing the house.

1/B/2-22 IN pursued the individual but did not capture him. By 1005 the cordon was set and the search began; nothing significant was found. The FIDO results were negative in the house. Follow up reporting from the HHC Commander indicates that five minutes prior to the IED detonation a [redacted] (2) H was seen in the area the IED detonated.


A relative of the Multtar [REDACTED] b)(6) informed 1/B/2-22 that a five minutes prior to the IED detonation a [REDACTED] (2) H was seen in the area that the IED detonated. This is similar to the story that the HHC Commander received when talking to the villagers after the detonation. 1/B/2-22 pursued a [REDACTED] (2) H and caught up [REDACTED] (2) H near the PJCC believing that [REDACTED] (2) H might be the one that emplaced the IED. The SWT guided 1/B/2-22 IN onto the vehicle. The vehicle turned out to be a [REDACTED] (2) H with a family [REDACTED] (2) H. The family was not connected with the events in any way. 




