The claim packet contained credible evidence of damage caused by US forces not involved in combat operations.

3. Authority. The Foreign Claims Act (10 U.S.C. § 2732) is the authority for AP 77-3, Chapter 10.

4. Action. Settle this claim in the amount of \$1,500.00
