At 210436dSEP06, A/1-35 AR (TF 1-6) detained (3) suspected AIF while conducting a targeted raid IVO (b)(2)High north of Ramadi. Based on information from (2) separate sources, A/1-35 AR conducted raids targeting (b)(6) who is a suspected financier, and (b)(6) who is suspected of constructing and emplacing IEDs. The unit searched the target houses and detained (3) individuals, (2) of which are believed to be the targets. During the conduct of raid, the assault force encountered a locked exterior door and conducted a ballistic breach, (b)(2)High (2) civilians inside the building were hit by pellets from the shotgun breach – (1) civilian female was killed and (1) civilian male child was wounded. The female was struck in the head and the young boy received a wound to the leg. Unit medics provided immediate care to the child, who was subsequently evacuated to C/MED at Camp Ramadi for further treatment. When the child was released from C/MED, the unit returned him to his family and collected necessary information for condolence payments. The detainees were transported to Camp Blue Diamond for further questioning by THT. The unit will initiate a 15-6 investigation. There were no CF injuries or damage to equipment.
