accordance with the statute.
5. **Facts:** U.S. gunfire caused the deaths of the men listed above.
6. **Opinion:** In accordance with AR 27-20, paragraph 10-3, claims arising directly or indirectly
from combat activities of the U.S. Armed Forces are not payable under the provision of the
Foreign Claims Act.
7. **Recommendation:** For the reasons stated above, this claim must be denied payment under
the provisions of the Foreign Claims Act.



