4. DESCRIPTION: A local national, (b)(6) was driving in the vicinity of Route Irish. As a taxi driver, he had two passengers (names unknown) in the vehicle with him. At approximately 211315May05, an insurgent vehicle fired across traffic upon a Coalition Forces convoy, seriously injuring one US soldier. Coalition Forces returned fire at the insurgents, and during the engagement, this vehicle was struck by several bullets. As a result, (b)(6) (b)(6) was killed and his vehicle was damaged.

5. JUSTIFICATION: By making this condolence payment, MNF ensures the family and community recognize the MNFs' sympathy for the unfortunate occurrence. Support will positively influence both the community and local Iraqi leaders.

SECTION IV - FINDINGS (para 3-10, AR 15-6)

The Investigating officer (board), having carefully considered the evidence, finds:

That on 21 May 2005, an IED was discovered on (b)(2)High by a patrol of B/2-156 IN. Once the IED was discovered, B/2-156 IN called for EOD to report to the site and detonate the IED. A/1088 EN under the command of SFC (b)(3), (b)(6) escorted EOD to the site. Outer security was established by B/2-156 IN. Once arriving at the IED site, A/1088 EN coordinated with CPT (b)(3), (b)(6) (OIC on the ground). Adjustments were made to the Outer Cordon and EOD moved in to disarm or blow the IED. The area began to receive mortar fire close to the location of the inner and outer cordon of the IED site. Next, soldiers of A/1088 noticed a white car traveling back and forth (East-West) on the Service Road, north of (b)(2)High. A/1088 EN soldiers contacted B/1-156 IN (CPT (b)(3), (b)(6)) about this suspicious activity. CPT (b)(3), (b)(6) repositioned a M1114 in the median of the road to observe (and possibly react) to this threat. The white car passes again, and the soldiers in the M1114 began chase of this vehicle moving East on the Service Road of (b)(2)High. Once the chase began 2 additional events occurred; 1) a Green sedan pulled between 2 buildings facing the soldiers of both A/1088 and B/1-156 IN and began to fire - hitting SGT (b)(3), (b)(6) in the neck (seriously injuring him). 2) Two additional vehicles pulled close to the firing vehicle. Some occupants of both of these vehicles exited the vehicles and ran toward the building behind the firing vehicle. At this point, soldiers of A/1088 EN began to return fire on the Green sedan. B/2-156 IN did not have a clear shot to the Green LN sedan (Shooter). The statements of SGT (b)(3), (b)(6) 2LT (b)(3), (b)(6), SPC (b)(3), (b)(6) SPC (b)(3), (b)(6) and SGT (b)(3), (b)(6) of A/1088 EN (Exhibit III) verify this series of events. During this exchange of fire, the 2 other Local National vehicles were hit - killing one passenger and injuring two others. It is very important to note that both LN vehicles were hit both by fire from A/1088 and the Green LN vehicle (Shooter). It is impossible to determine who actually shot the LNs in question due to bullet damage to both sides of the vehicle. SGT (b)(3), (b)(6) was MEDEVAC'ed via air. The 3 Local Nationals that were hit were attended by B/2-156 IN personnel and Iraqi Police, who escorted the injured to the LN hospital. It is evident through my interviews of the soldiers involved from A/1088 EN and CPT (b)(3), (b)(6) (Exhibit IV) of B/2-156 IN that proper ROE, policies and guidelines were established when setting the cordon (inner and outer) when establishing the IED recovery site. It is also my findings that A/1088 EN acted IAW established and published ROE when returning fire. It is unfortunate that 2 LN vehicles were caught in the middle of this fire - but this fire was necessary as the units has taken causalities and absolutely had the need to defend themselves. Furthermore, as stated previously, there was bullet damage on both sides of the damaged 2 LN vehicles making it impossible to determine who actually injured the occupants and damaged the vehicles. A series of sketches of this incident are included (Exhibit V).



On the 21st of May of 2005, we were attacked with mortars and were on the receiving end of small arms fire/machine gun fire. We, being Charlie team of 2nd Platoon of A Co 1088 ENGR BN. We were on an EOD mission. I, SGT (b)(3), (b)(6) was a gunner for the rear gun truck. After we arrived on site we were attacked by mortars. Two mortars were fired right over our heads. Afterwards, my comrads and I noticed suspicious activity from the local nationals. SGT (b)(3), (b)(6) SPC (b)(3), (b)(6), and CPL (b)(3), (b)(6) who were all passengers in the rear gun truck, were dismounted at the time. They noticed a two door white car that kept making the block over and over again. The white car was reported to higher. The outer cordon waited for the car to pass back so that they can go after it. The white car passed back. The gun truck waiting for it took off to go after it. Once they got on the street in front of our position, three cars pulled up real close to them. I then aimed at the car (orange and white car) that was closest to the friendlies. The car didn't back up. We then received gun fire from the very same alley the car was stopped in front of. I could hear the rounds land close to me, so I got down. I then stood up and returned fire with my M-16 A-4. I engaged the very same car I was aimed at before I got down, who I believed to be the trigger men. SGT (b)(3), (b)(6) was shot SPC (b)(3), (b)(6) dragged SGT (b)(3), (b)(6) to cover in back of my gun truck. A Medevac was called.

While on an EOD escort mission, we noticed a white 2 door car with a dent in the driver side rear quarterpanel that had passed our location three times earlier. We coordinated with 1/69th, who was our outer cordon security, to provide a chase vehicle if the car appeared again. The car appeared and we informed the chase vehicle of its location. They proceeded north from (b)(2)High to the northside service road and turned east on said road. When they passed the first alley after the turn, I heard automatic weapons fire coming from the north and bullet impacts near my feet. I was standing to the west of (b)(2)High and took cover on the southside of the same vehicle. I saw dust and smoke coming from the alley and returned suppressive fire down the alley. I fired approximately twenty rounds, looked to my right and saw SGT (b)(3), (b)(6) lying on his back. I yelled for SPC (b)(3), (b)(6) to recover SGT (b)(3), (b)(6). He proceeded to recover SGT (b)(3), (b)(6) by pulling him from SGT (b)(3), (b)(6) right shoulder and I pulled SGT (b)(3), (b)(6) by the left arm. We pulled SGT (b)(3), (b)(6) behind (b)(2)High and I yelled at SPC (b)(3), (b)(6) to get my aid bag out of (b)(2)High. When I looked at SGT (b)(3), (b)(6) SPC (b)(3), (b)(6) was attending to him. I asked where SGT (b)(3), (b)(6) was hit and SPC (b)(3), (b)(6) told me in the neck. I uncovered the wound and applied direct pressure with my right hand while SPC (b)(3), (b)(6) procured a kerlix roll to bandage the wound. SPC (b)(3), (b)(6) then began an IV in the Left antecubital space of SGT (b)(3), (b)(6) and I instructed SPC (b)(3), (b)(6) to provide direct pressure on the wound. I instructed SPC (b)(3), (b)(6) to prepare an IV bag while I prepped SGT (b)(3), (b)(6) right arm for an IV. I initiated an 18g IV in the Right antecubital space of SGT (b)(3), (b)(6) and received the line from SPC (b)(3), (b)(6). The vein blew when I connected the bag and I initiated another IV in the same location, one vein distal. I secured the site with tape and secured SPC (b)(3), (b)(6) site also. I then instructed SPC (b)(3), (b)(6) to begin cutting away SGT (b)(3), (b)(6) clothing to check for further injuries to his torso and upper body. We log rolled SGT (b)(3), (b)(6) onto a litter, secured his C-spine with three aid bags, and taped his head down onto the stretcher. We removed his boots and exposed his legs for further evaluation and secured his hands and legs to the litter. (b)(2)High had been called and landed approximately 30 seconds after we completed primary treatment. SPC (b)(3), (b)(6) held direct pressure on my instruction the entire time and I briefed the dustoff medics on the neck wound and the treatment rendered. (b)(2)High departed moments later and I policed up SGT (b)(3), (b)(6) weapon and ACH, turning said items over to the A CO TOC when we arrived back after mission completion. Nothing else follows. , WANT TO MAKE THE FOLLOWING STATEMENT UNDER OATH:

On 21 May 2005 at approximately 1100 hours I encountered an IED with my patrol of 3 each M114s. The IED was located between (b)(2)High and (b)(2)H on the westbound lane on the south shoulder of the road. I called TF 1-69 TOC and sent a request for EOD to come and respond. I set up an outer cordon to facilitate EOD in an inner cordon with 3 each M114s and 1 M2A2 Bradley Fighting Vehicle. The three M114's were in the west bound lane about 150 meters east of the IED site. I positioned the M2A2 in the northern median between the west bound lane and the northern service road of (b)(2)High. EOD escort called me at approximately 1230 hours and let me know they were on the way on my company FM net. I guided them to my location by giving them a description of a "orange jersey barrier" at my location between CP 540 and 541. EOD along with EOD escort arrived at my location traveling east in the westbound lane of (b)(2)High. I linked up with the NCOIC, SFC (3), (b)(6) and place him inside of my outer cordon. I gave EOD a description of the IED and they launched their robot. After initial investigation and a charge of DET CORD the IED was 2 pipe cylinders, a battery and a Motorola radio. EOD said they would do a controlled DET. I warned SFC (3), (b)(6) about the enemy activity that we had received in this area with small arms and RPG fire from the north and recommended to him to watch the north. I additionally described to him a TTP that AIF was using in the area is a look out vehicle who would drive by and conduct ISR. I told him to let me know if he sees the same vehicle making several passes on the northern service road. At approximately 1240 hours 2 rounds of 60 MM mortar fires were observed impacting on the southern median of (b)(2)High. I ordered everyone to button up and hold in place so that EOD could continue their mission. I had planned on moving to the east if rounds were "walked" in our direction. There were no additional impacts of indirect fire during the incident. As EOD was preparing the demolition charge, I was informed of a white sedan with a dent on the fender making several passes. I instructed my 2nd PLT, 1st Squad Leader, SGT (3), (b)(6) to prepare for a "pounce." (b)(2)High (b)(2)High SFC (3), (b)(6) cleared the air space through the A/1088th EN TOC for the controlled detonation and EOD finalized their preparations for the charge, when SGT (3), (b)(6) postured his vehicle to the north of the A/1088 inner cordon oriented on the northern service road to intercept the AIF scout. At approximately 1310 EOD detonated the first charge and it was a "dud." They began preparing a second charge when the white sedan made a third pass on the northern service road. As the car made its third pass, SGT (3), (b)(6) moved across the northern median and turned east on the northern service road. At 1315 when he moved past the first north/south road adjacent to (b)(2)High "Road" I witnessed a burst of automatic machine gun fire from an RPK machine gun from the road SGT (3), (b)(6) just passed. Most of the rounds from the machine gun fire impacted the northern median to the north of A/1088's inner cordon and rounds ricocheted in different directions. This was evident by the tracer rounds used by AIF. At this time I aimed my M-4 at the north/south road and used the door of my M114 to shield me. I could not identify a target nor could any soldiers in my unit. As soon as the enemy opened fire A/1088 fired back at the insurgents with 240 B and M-4/M-16 direct fires. I radioed to my TF TOC that I was in direct fire contact. I noticed two local national vehicles traveling west along the northern service road and drove into the cross fire between A/1088th and the insurgents. The two LN cars were a gray 4 door sedan and a orange and white sedan. The gray car was in the lead with three occupants, 2 adult males and 1 male teenager. The second vehicle, the orange and white sedan, contained two adult males. During the ensuing firefight, I saw the occupants of both cars and attempt to exit the area by low crawling. SGT (3), (b)(6) dismounted his vehicle with two soldiers in order to maneuver on the insurgent's vehicle to their north. I ordered a seize fire when I saw SGT (3), (b)(6) dismount. SGT (3), (b)(6) moved back west to the north/south road where the insurgents fired and peered around the corner. He then moved around the corner and could not locate the vehicle in question. He did identify the vehicle as a green sedan, BMW. I then called for a casualty assessment and my units reported no injuries or damage. I then asked who fired, and none of my units fired. I saw the local nationals in the vehicles, who did not dismount, were injured so I moved my vehicle to the incident site and directed my medic to assess the casualties. The assessment came as 1 adult male LN KIA, 1 male teenager LN litter urgent, and 1 LN adult male litter routine from the gray sedan. The orange and white sedan occupants sustained no injuries. I looked at the injured and they had wounds to both sides of the body, the KIA had wounds on the side of the body facing A/1088. I looked at the vehicles caught in the cross fire and noticed entrance holes and exit holes from the north and the south. Clearly, it was the "wrong place at the wrong time" for the gray sedan and orange and white sedan. I requested IPs and an ambulance to transport the wounded as I conducted my investigation. While I was waiting for the ambulance and IPs I noticed an air MEDEVAC helicopter landing or (b)(2)High in the vicinity of A/1088. It was at that time I discovered that they had casualties. IPs arrived on scene as well as the ambulance to evacuate the LNs. I (3)(b)(6)ck to my position of the outer cordon and EOD detonated the second detonation successfully. I thanked SFC (3), (b)(6) and wished him well for the soldier that was wounded in the firefight. At approximately 1420 A/1088th and EOD left the site and I continued my mission of route security and route clearance on (b)(2)High





Slide 2: White LN sedan begins to move back/forth on Service Road (Suspicious). C/2-156 IN repositions vehicle to cover Service Road
