McNeill to talk about the publicly releasable information related to the Commander's Inquiry he ordered into the deaths of two detainees, [REDACTED] and [REDACTED] at the Bagram Collection Point in December 2002. It is likely the general will remember the incident. One of the detainees, [REDACTED] was found dead in his cell, hanging from the ceiling by his arms, his body badly bruised. Officers familiar with Gen. McNeill's inquiry and the CID report said [REDACTED] had been hanging in that position "for days." LTC [REDACTED], the army pathologist who conducted the autopsy classified the death as a homicide and at least four MI interrogators and MP soldiers were titled for abuse.
