have outstanding local warrants and were arrested by the Denver Police Department at the conclusion of the interviews.

Lead 3 to locate and interview persons at other addresses in Denver was partially successful in that six individuals were contacted at 1065 Lipan Street, but they refused to identify themselves or consent to an interview. Investigation confirmed that this is the current location of Food Not Bombs and Derailer Bicycle Collective. A subsequent newspaper article confirmed that one of the residents at such address is

No contacts were made at 1435 Lipan Street as such residence was vacant and under renovation. No contacts were attempted at Breakdown Book Collective and Community Space, 1409 Ogden Street, as the purpose of the interviews was served by the contacts made at the two residences.
