INVESTIGATION ESTABLISHED ON 29 APRIL 2004, MR. SUDHAIL WAS INVOLVED IN AN ATTACK AGAINST ELEMENTS OF THE 1ST MARINE EXPEDITIONARY FORCE, IN THE FALLUJAH, IRAQ AREA AND WAS WOUNDED DURING THE ATTACK. HE WAS SUBSEQUENTLY EVACUATED TO THE MEDICAL TREATMENT FACILITY LOCATED AT THE BAGHDAD CENTRAL CONFINEMENT FACILITY, ABU GHRAIB, IRAQ FOR TREATMENT.

ON 21 MAY 2004, MR. SUDHAIL WAS TRANSFERRED TO THE 31ST CSH, WHERE HE SUBSEQUENTLY DIED ON 24 MAY 04, MR. SUDHAIL WAS PRONOUNCED DEAD BY DR. (CPT) (NFI).
