(U) ~~(S/NF)~~ [redacted] was then asked if he had ever discussed WMD issues regarding Iraq with [redacted] [redacted] emphatically stated no. He said he had discussed the issue with previous interviewers. He stated he told interviewers that it was his view that the United States step beyond its jurisdiction by attacking Iraq without U N approval. Furthermore, he stated that it was also his opinion that if Saddam Hussein had WMD, he would have definitely used it against the U.S. [redacted]
