[Redacted] was then asked if he had heard of UBL, KSM, Al Qaeda, [Redacted] appeared uncomfortable with this line of questioning and continued to deny any knowledge of the above. When reminded that he had been shown a video of the 09/11/2001 terror attacks that explained the relevance of UBL, KSM and Al Qaeda, [Redacted] said he had first heard of these matters from his interrogators. When reminded that writer had posed this exact question to him just one week prior, [Redacted] appeared confused and stated he was losing his mind while in custody. [Redacted] went on to state that all he can think of is his family and returning home to them. [Redacted] then stated if the writer went to his village of [Redacted] the writer would be moved to tears by the desperate situation there. When told it was difficult to believe no one ever discussed UBL whether in his home village or while in custody at Bagram, [Redacted] stated no one is allowed to speak inside the BCP and therefore none of his fellow PUC's discuss terrorism or terrorist activities.
