In response to Department of Defense (DoD), Criminal Investigative Task Force (CITF), Request for Assistance (RFA) [Redacted] the Federal Bureau of Investigation (FBI) is providing the following letterhead memorandum (LHM) for dissemination to [Redacted] for use in the prosecution of captioned [Redacted] detainee.

On [Redacted] the agents captioned below interviewed [Redacted] (hereafter referred to as [Redacted]) provided the following information

[Redacted] was at the Qala-e-Jangi prison facility during the prison uprising against the US Forces, but advised that he did not fight against the US Forces [Redacted] remembered 2 American prisoners. The first American was sitting behind him in a separate line, [Redacted] did not know the name of this individual and was not able to describe this individual. [Redacted] stated that the individual shouted that he was an American and spoke English, however the guards would severely beat anyone who spoke, so nobody answered him. [Redacted] advised that he has not seen this individual since the uprising.

[Redacted] immediately identified Photograph [Redacted] as the man which sat next to him in the prison, although he did not know his name. [Redacted] advised that he remembered the American because he was the only white prisoner that he really saw during his stay, and because he was seated next to this individual during the prison uprising. [Redacted] advised that he was inside of a basement during the uprising, and he didn't remember much from the uprising except gunfire and darkness

that [redacted] told them that only the people that spoke [redacted] would be let out, so nobody admitted to speaking English (or any other languages). The taller of the two Americans was over six foot tall, "older" with lite colored hair, wearing civilian clothes. [redacted] observed this American speaking with [redacted] The other American was less than 6 feet tall and carried an AK-47 machine gun. During the prison riot, [redacted] observed the Americans returning fire at the Uzbek soldiers
