Synopsis: (U) To report results of Mosque outreach conducted with [redacted] of the Seaside Mosque, on 02/18/2005.

Details: (U) On 02/18/2005, the writer and SA [redacted] (the FBI) met with several members of the [redacted] of the Seaside Mosque, located at 825 Hamilton Street, Seaside, California, telephone number 831/644-8332, concerning the FBI's ongoing contact with all Mosques and Islamic Community Centers in the FBI's San Francisco territory for the purposes of community outreach. [redacted] was primarily represented by [redacted] telephone number [redacted].

(U) The dialogue included ascertaining if [redacted] or anyone associated with their Mosque has been the victim of a hate crime, to provide them with the contact information for the above mentioned FBI SA's and to establish a relationship in which relevant issues could be discussed. [redacted] advised that all was well within the community at present. [redacted] further advised that he had no concerns regarding hate crimes or bias incident in the community. [redacted] expressed some frustration with delays during airline travel, but advised that he understood the reasons why such delays occurred.
