22 Defendants have recently filed a Motion to Compel Production of Unredacted
23 Documents (ECF No. 38) and Motion to Expedite (ECF No. 40). The styled Motion to
24 Compel seeks reconsideration of a ruling made by the court after an extensive hearing on
25 September 29, 2016, and memorialized in the written Order of October 4, 2016. The
26 Motion to Expedite seeks an expedited hearing because the Government's document
27 production is currently underway. The Motion (ECF No. 40, p. 3) states the Government
28 opposes the Motion to Compel and Motion to Expedite.

1 The Motion to Compel was filed on October 28, 2016. Pursuant to Local Rule
2 7.1(b), the Government would ordinarily have 14-days to respond, or until November 11,
3 2016. The Motion to Expedite seeks a hearing with oral argument on November 9, 2016,
4 or as soon thereafter as the court's schedule allows.

5 **IT IS HEREBY ORDERED:**

6 1. The Motion to Expedite (ECF No. 40) is **GRANTED IN PART** and **DENIED**
7 **IN PART**.

8 2. The Government shall file a Response to the Motion to Compel (ECF No. 38)
9 no later than **November 9, 2016**.

10 3. Defendants' Reply brief, if any, shall be filed no later than **November 15, 2016**.
11 The court will determine after submission of the briefs if oral argument is warranted. If
12 the court determines oral argument would be beneficial, it will set a hearing, otherwise
13 the Motion will be deemed submitted as of November 15, 2016.

14 **IT IS SO ORDERED.** The Clerk is hereby directed to enter this Order and
15 furnish copies to counsel.
