Dear Senator Feinstein

We, the undersigned organizations and individuals, write to express our concern and opposition to a bill you introduced with Senator Jeff Sessions (R-AL), known as "The Passport and Travel Document Fraud Prevention Act" (S. 524). This bill would expand the types of passport and document-related offenses that constitute an "aggravated felony." It would impose unduly harsh penalties on immigrant workers, victims of domestic violence, and American citizen family members.

S. 524 would make the use of any false document to gain entry into the U.S. an "aggravated felony," regardless of whether *any* prison sentence is imposed. The harsh consequences of an "aggravated felony" conviction include mandatory detention, permanent deportation, and ineligibility for any type of relief. Other offenses that would be considered "aggravated felonies" under this amendment include false statements in an application for a passport or travel document regardless of whether any prison term is imposed; using, attempting to use, or furnishing a passport or travel document that was secured in any way by a false statement, regardless of whether any prison term is imposed; among others.

Consider the case of Yuko, a lawful permanent resident that worked as a *sous chef* in New York City and lived with her three U.S. citizen children. Ten years ago, Yuko borrowed her neighbor's passport to enter the U.S. because she was desperate to leave her abusive husband. While Yuko pled guilty to entering the U.S. on a false name, she spent no time in jail. Or consider the case of Rosa, a Mexican woman who is a victim of domestic violence and who used a false name to obtain a passport to seek refuge with her cousin in the U.S. Under S. 524, their convictions would automatically be considered aggravated felonies, subjecting them to deportation, detention, and ineligibility for any kind of relief.

While recent bill modifications were made to address certain refugees, they do not go far enough to protect all vulnerable populations, such as crime victims, victims of trafficking, and victims of domestic violence. Under this bill, such groups who fit under the broad newly expanded "aggravated felony" definition would be ineligible for removal relief or other protections.

We urge you to reconsider your support for this bill.
