It is also requested that [redacted] be advised that if further examination of original documents or evidence is necessary, it can be arranged at an appropriate location. (S)

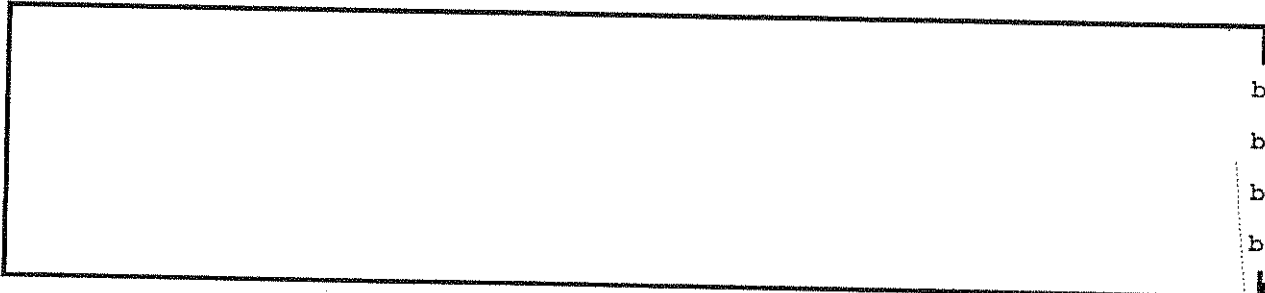
