On 11 Jul 04, this office reopened this investigation based on MR. providing a statement detailing he was assaulted by a black male.

Investigation established that SFC metables did not commit the offense of Assault, as initially alleged. Mr. Frelated he was never struck by SFC metables, or any white males and a thorough investigation established that SFC did not assault any detainees. 676-516-5

Further investigation established Mr. was not assaulted by any guards while detained at Camp Bucca, Iraq.


