





All related they were at home when American forces raided the house, 0200, 24 Dec 03, in Slaikh Alrabee Neighborhood, Baghdad, IZ. American

Forces broke the front door and threw distracting devices in the house. After entering the house all the occupants' hands were tied behind their backs. All the women in the house were tied to the stairs in the house and the men were taken to the kitchen and they were all hooded or blind folded. The detainees alleged the house was ransacked and approximately \$80,000.00 US dollars and \$30,000,000.00 Iraqi dinner were stolen. In addition to the money all the gold in the house and women's jewelry were stolen and the Americans broke all the windows in the vehicles and the furniture in the residence. Detainee related he was hit in the head with a wooden by object when they stormed the house and was cut and almost knocked unconscious. Detainee stated he was hit in the head as well and knocked to the ground. When he was dragged into one of the HMMWV's he was kicked in the head. During the raid no one spoke to the Iraqi's and the house was inspected without anyone going with them. All the men were taken from the house to Ruthwania Palace. After they arrived at the Palace they were thrown to the ground and their hands were untied and replaced with handcuffs, which were put on very tight. Detainee related his father was with him; however, his father was in poor medical condition and was taken to an unknown hospital. He related he has not heard about his father nor does he know what his current condition is. While at the Palace they were forced to kneel on the ground (stones) with their faces on the ground for four days and nights. When it was dark they were taken inside the palace and placed in the same position on the concrete floor. All the detainees stated they were hooded the entire time and were unable to see. Further, they were not fed and were not allowed to sleep, during those four days. When some of the detainees asked what they had done, they were kicked and punched on the head and back. Detainee hit so hard he lost consciousness. During those four days at the palace the Americans released stated he was dogs on them; however, the dogs only bit their clothing and never caused any physical injuries. also related that at one point he was being interrogated and the interrogator lifted up his hood and insulted him by threatening to shave his head and beard and make him wear woman's clothing. The interrogator also stated he was going to have sexual relations with the Detainees mother. He described the interrogator as a white male with blond hair and a blond mustache, about 35 years old, with blue green eyes, about six foot tall and of muscular build, he was wearing an army DCU cap. Detained related he did not know if the interrogator physically assaulted him because he was hooded, except for the time when he was insulted by the interrogator. Detainee related he lost feeling in his right hand because the handcuffs were to tight while he was at the Palace and he was kicked very hard in the right thigh. All the detainees related they were punched and kicked several times while at the palace. They also related the abuse stopped after they left the palace and they have all been treated very well since arriving at Abu Ghruyeb. They were asked as to why they had so much money in the residence, which they replied they are a wealthy family as they are in the transportation business with many

She was taken to Kurkurk, where no abuse happened; however, she was later taken to a detention facility on BIAP, where a doctor checked her out. While at BIAP she was forced to stand against a wall for long periods of time, she subsequently fainted because she had not had any food for two or three days. She was later interrogated and she was accused of lying and she was placed in a dark room with loud noises from a stereo being played (the noises sounded like people screaming and crying). An unknown black female, US Solider guard came and threw her around the room from one wall to the other until she fainted. The female stripped her down to her bra and underwear and brought her out so the men would laugh at her. The male interrogator told her he was the devil and he and the black female made her crawl around on her hands and knees for hours. The female would hit her with a long stick when ever she would slow down while crawling. The male guards would all laugh at her and the female would pour cold water on her as she crawled. The guards brought in her nephew and took off all of his clothes and made her and her nephew look at each other. The female guard exposed the detainee's breast and forced her nephew to look at her. The female continued to beat her while a male beat her nephew. They were again ordered to crawl on the floor and the female pulled her hair, to the point it took her breath away and slammed her head against a wall. If she tried to sleep the female would pour water in her ears to wake her up. The female beat her with a plastic chair until the chair broke. The detainee stated she had a plastic sliver in her foot, that she was not allowed to take out, which subsequently caused an infection in her foot. She was placed back in a small room with no lights and was given her clothes back after the clothes were soaked in water. At night when she tried to sleep they would come in and wake her up and not allow her to fall asleep and she was forced to stand. She was not allowed to use the bathroom and if she asked the female would beat her. The detainee stated there was a nice guard who allowed her to see a doctor who looked at her foot and gave her slippers to wear. She stated she saw the doctor at 0400 in the morning and the doctor pulled out the sliver. The doctor checked up on her two days later and changed the dressings on her foot. The detainee stated she was in the cell for five days until she was transferred to a better place. She was taken to Abu prison where she received medical treatment for her injuries and given medication and she stated she has been treated very well at Abu prison. Detainee stated she believed she was going to be released soon and did not want this investigation to slow that process. Detainee provided a written statement. (See statements)



would like to make the following statement pertaining to the investigation of detainee abuse at Abu Ghraib Prison. I personally have not seen any detainee abused by anyone where I work, the screening section but have seen detainee's brought to our section that have been abused at other locations. Once our section sees or hears of such actions we immediately report that to our supervisor and take the detainee to the Aid Station to report incident. In late December 2003 or early Jan. 2004 I received a packet on 2 males that were supposedly connected to Fedayeen through their sister packet I was to fill out a screening sheet with the detainee and determine whether they I picked up the first detainee and brought him to the screening room where the detainee

was very upset emotionally and shaking begging me not to harm him that he would admit breato anything I wanted him to I don't remember the detainees name but know that he was 2 brothers. I would screen a few days I later. The interpreter, Tried to calm him down before conducting the screening. The detainee started telling us how he and his other brothers and sisters went to "The Palace" to turn themselves in because they were wanted for questioning by C.F. Once they got there they were detained and were tortured by an ex-I.P. by the name of was working with the C.F. at the palace. He stated that while being questioned, would beat him and at one point he actually raped him with a bottle trying to get him to confess to supporting Fedayeen. The detainee also stated that his one brother was beaten to death. I immediately went and reported to my supervisor was being told. We took the detainee to the Aid Station to have detainee checked out and continued to record everything he told us. We wrote information on the screening sheet and sent the screening sheet to higher command. I have attached the screening sheets I obtained while screening 4 Jan. 2004.

I don't recall which of the detainee's made the following statements but I do recall while asking the detainee's if there were Americans present while they were being beaten one of the males stated that he saw a tattoo of an American Flag on one mans arm and one of the other detainee's stated that they saw a "black man" present while they were While talking to

she mentioned that her one brother was beaten to death and when I asked her how she knew he was beaten to death she said they brought him into her cell and threw him on top of her. She stated that she knew by the way he felt that he was threaten to have them placed in Coalition Forces custody if they wouldn't give him , would threaten to beat them or money.

This incident-was the first time that I heard of 676-3,66-3 but we have heard on several occasions from other detainee's I have made the following statement to the best of my knowledge do to the time that has past since the screenings that I took. I would like to further state that when ever I was told of any possible allegations of abuse I would immediately report it to my supervisor and record all information given to me on screening sheet that was forwarded to the higher

NDRS On Dec 22, 2003, my brother while they were eating in Aladhameya area, and on Dec.23, 2003 they came to our residence, I mean my home resided in Aljamaa and they inspected my home and my company (Ashtar Co. for commercial agencies) which is near by my home. The doors and the furniture were broken at 4:00 at the morning and they did not find anything in my home, and at morning of Dec.24, 2003. I went to the American forces to inquire about my brother and the reasons of my home's inspection which is not in Aladhameya, because I live in Aljamaa neighborhood, and they told me to bring the rest of my brothers and come at 3:00 after noon, and I went back and brought my brothers and coording to the appointment and they said that they would interrogate them for a short time, an they asked me to come at 7:00 PM and after I took my dinner I went at 7.00 PM, and I was interrogated by one of the American individuals I don't know his name. After ten minutes of my interrogation I was arrested in Aladhameya Palace and my hands were tied and I was hooded and sit on a wooden chair, and after almost two hours they brought my sister and I heard her crying and we stayed on the chairs until the second day. and at the third day, at 12: 00 at noon they took us to the interrogation place in the Palace hooded and hand tied, and they took off our shoes and stand us against the wall for seven hours. During that period I was inspected from the guy named seven times in an attracting attention and impudent way. During that period I heard many sounds screaming loudly, and I tried to remove the cover off my head and I saw a group of kids. was one of them and they tried to insert a bottle in their rectum, then I fainted, and the American guy came and carried me towards the wall then I was taken for and Iraqi person his name is a room. There was an American person, who I met at he beginning, and he told me that he is a and I was entered in judge or the Military ruler here and he has the authority to do any thing against us, and he didn't that I gave them money I said to him that I am not a member in the government or Baath party. told me that my brothers hit the Americans and so he hit me on my face twice, then he brought witnesses I do not know any one of them except to my brothers to hit the Americans, and I tried to defend myself, so the Military ruler said that I and one of his assistants to witness that I gave money don't have the right to talk and he slapped me on my face twice and I was taken back to the room again with my sister. At night they threw my brother who looked like dead, and he was bleeding from his hands and legs and he was naked. and his shirt was up and his pants was down, and after a while, the Americans took him and we did not know where did they take him. At the morning of the third day they took us in a bus (18) passengers and they said you will be poisoned in that bus, and we stayed for more than three days, and we did not identify the day and the night. All the kinds of physiological and physical torture were practiced against us . They turned up loud stereos and frightful music and they were banging the bus with a stick, and they did not allowed us to sleep, and when I asked them to go to the bathroom, one of the American persons tied my hands which resulted in dislocated shoulder. All the time we stayed in the Palace, they did not allowed us to eat. After these precautions, they transferred us to Police Academy, and after seven days, they transferred us to Abu Ghrayb prison on Jan.4, 2004

I want to bring to your attention about that issue. The Iraqi people were happy when the Americans came to Iraq and we enjoyed our freedom, as the corrupted regime of Saddam was to act as friends of US forces. These old groups, who were grown up on looting as a result of between the Iraqi people and the Coalition forces. 

They left and after a while I did not send the translator to him because the translator refused, and said to me ignore him, he is disreputable, and you have nothing against you. I went to my neighbors and asked them why Palace, and they said that they gave him money out he started to blackmail us, and I said to them that he asked me for money and they said, ignore him, but after a while he came to our house again and he broke our doors and he stole some dollars from our pocket money and they started shooting in our door, and they said who is shooting against us near your house? But no one shot them, and it was an excuse to capture me, and they took me to the old security building at larly jorces and we went down to a place underground . and is my sister- and I said to him, yes, and he said to me, where is the money? and your sister is with you I said ic him release me and I will send the money to you, he said . I can not do that but I will leave you , and he left me with three police men who started beating me and I did not why from 1:00 to 5:00 at the morning and at the morning they took me from Jarly to Aladhameya Palace and my hand tied to my back and my eyes blinded, and I was standing until 4:00 PM, and I was not allowed to sit down. An American soldier came and untied me and removed my hood and brought me a chair and started interrogating me about persons I do not know, and he said to me, do you have money, and I told him that my husband's salary is little and my children in the college and we have difficulties in paying their school fees. and he said to my that he will see my husband and if these information are true he would release me. At 12:00, they sent me to Jarly forces and I found my husband is waiting me and he took me back home, and I did not get out of my home for a long time, and at Dec 23, 2003.

TRANSLATION OF STATEMENT PROVIDED BY DETAINEE

On Dec 24, 2003, corresponding to Wednesday, we went to the Palace in Aladhameya with our sister because she told us that the Americans wanted us for an explanation. Virtually me and my sister and my brother entered, and one of the Americans at the gate stopped us and inspected me and told me to stay there and after a short period he hooded me and tied my hands to my back and put me in a vehicle which went for a very little distance, and there was an frage translator, who told me that there was a short stair and he put me on the ground and after almost one hour I heard my brother's voice sitting beside me, then the same American person who was at the gate, came and asked me some questions, and once he said to me, you are fedace and other time he said, you are resistant, and I said to him; I swore to god I don't know what do you mean by these questions, then he said to me, if you do not talk I will not help you. I said to him I swore to god. I swore to god. I do not know what do you mean, then he returned me back to the same place then, a person who talks Arabic came and asked me if I smoke cigarettes and I said : yes, then he push all the cigarette in my mouth, and he told me that I would go to a place where they will beat you and do whatever they want with you , I said to him : why? We did not hurt you but he did not talk to me. After several hours they put us in a vehicle and it went for a short distance and they took me with my brother and put us in a place and put our faces against a wall, then a person came and took me to another place near by, and removed my hood and said to me: did you recognize me?, and I said; no, he said to me, you will know who am I and when he remove my hood I saw a person wearing American uniform and a person wearing olive clothes, and the person who said to me "did You know me said" to me: you are rich, how did you get that wealth? I was surprised by that question and said to him that my brother in law-is a rich man and not us and suddenly they hit my head and legs and my nose, and he said to me we have witnesses against you, and I said to him, bring these witnesses but when they went to bring the witnesses this person who is called

hit me while facing me, and two persons hit me on my back and I did not recognize them, and when they brought the first witness they removed my hood and said to me, do you know that person I said to them; yes he is from the people of our area and I just say hi to him when I see him, and they asked him; what do you know about the he said to them, while when I see him. and they asked him: what do you know about there was a scar of blood on my mouth, that used to bring weapons, and I said to him: where do! bring these weapons, but he did not answer, then they drag him from his shirt, and brought another witness and told him to talk about the said! heard, and when he said! heard, they hit him and pull him outside, then they brought another person and said to him : what do you know about . he said to them that has a car and he is looking for Then me and said to me, why you were looking for me, then they kicked me more than ten times, and said to me: you son of a dog, and kicked said to that person: you can go, without hurting him and they were joking with him. They brought another person and they said to him: talk, what do you know about looking at me and his eyes were hitting and there was blood on his face, and he said you work against the Americans, and I said to him. I know why did you say that, and I understood that this

person wanted to hurt us. He took me to another place and said to me: do you want to see your on the floor half naked at the lower part, so I put a cover on his naked part and I wept because blood was on his feet and his hands, and there were some persons behind my brother and they me where do you put the money? I said to him, what money? I swore to god that my brother you, then he said that an American interrogator would come and I would extract from you what I that the interrogator would ask you and you answer, and I said to him that I would answer every guestion, and the god knows that I am truthful in every word I am going to say, it was the day

of hell to me, specially they did not ask me except one question; are you resistant?, I said : no, I swore to god I do not understand what do you mean then they put me on the ground on my back and hit me with a strong solid tool (iron tool), and they turn me over on the other side and hit me on my kidney from both sides, and I was screaming loudly, and I said: I will say what do you want me to say and they put water in my nose and they strangled me, and the water was between my nose and my mouth, and I woke up to see the torture again, and they ripped off my dignity by force, when they put a solid tool between my thighs, and I was screaming and begging them and said. I will say to you whatever you want me to say, but it was if no use, but that what happened and I was bleeding from inside and my tears in my eyes. They were not satisfied with that, because they started torturing me next day more than what have done before, and my honor brothers I stayed two days or more without food or water to drink because I was tied to my back against a wall and there was a nail fixed in it, and my eyes was closed. and they were hitting me each time they walked beside me. The other torture was through using a material (is called Balayes, it means Gelatin) and they pulled my dick specially the balls, and I swore to god how painful that was, and that was unbearable, and I was medically treated by an American doctor and he was accompanied with another doctor and a translator, and the translator said to me do you want food or water because I was in a bad shape and my pulse was weak, and the doctors said to the translator they have not to beat that person because his pulse is too weak. They did not care, and that person took me to a place where there was a stair and he said to me. I will ask you for the last time, where do your sister put the money, and I said : I swore to god I don't know, then he beat me and threw me from that high place, and he said to me while he was putting hi foot on my rear back; I will fuck your sisters in front of you if you did not talk, and my answer to him was that I do not know, and my brothers, there were many persons who had the same torture and more and he was the person who killed my who tortured my protiner too much and tortured my sisters more and more. Me and my friends want medical check and you have their names and that the money is the reason of our existence in that place.

Do you have any intelligence that Iraqi's are being told what to say and do about abuse, to be let free, false allegations, etc. ?

Yes. We have received numerous reporting that AIF personnel are receiving training on anti-interrogation techniques, and to claim abuse after detainment in order to reduce or diminish their sentences. One of our interpreters has even overheard a group of detainee's discussing how, "when we get to the airfield, just tell them you said what you said because you were beaten and they'll let us go." USSF has also learned that there is a lawyer in the Sadr City area who is giving briefings on how to claim abuse and make false allegations. I don't remember his name however.

Do you know and one of the largest AIF leaders/supporters in the Adhamiyah area of Baghdad. I the Saddam Hussein family.

What can you tell us about that family? That family is alleging that one of their brothers was killed while at this palace during interrogations and the body was thrown into a room with the family. Do you know anything about any sexual abuse of female or male detainees? No.

I was not involved in the transfer of but I do know that he was transported in the trunk of a civilian vehicle during hours of daylight for security purposes in order to protect him as well as ODA members. He was transported from here to Taji, which is approximately a 25 minute drive.



He stated he was captured about 15 Dec 03 in the area of Ishaki, Balad, Iraq, by US forces. He remembers the and He was transported to Samara. He said from the time of his capture until he arrived at Samara, he was not abused. He said when he arrived at the place in Samara; he was put in a room with "stinky stuff" and called a "bad man" by the US Forces. He stayed in this room for 2-3 days and then they put him in a hole in the ground with other detainees for a couple of days. After this, he said several uniformed US soldiers pulled him from the hole and threatened to shoot him. They then took him to a room and sat him on box with wires attached. He felt heat coming from the box and his body was hurting. He remembers an interpreter with a Kurdish slang. They then put bag on his head and dragged him to a vehicle. They took him to a place they referred to as a "septic tank" and left him for a couple of days. Then he was taken to the Police station in Samara. He said he knows this because the interpreter told him. He said at no time did any Iraqi Police abuse him. He said while he was at the police station he was kicked and punched by one US soldier specifically. He does not remember anything about him. He said one person said, "Don't tell me about torture, you haven't seen torture yet." They then stripped him naked and sprayed him with cold water. They then left him and ordered him to wash his clothes. He was taken to his cell still naked. The next day he was hooded and taken to another part of the building. His hood was removed. He said a tall, thin, white male in uniform, with no facial hair and longer blond hair began to interrogate him. He said the interpreter was an average size Iraqi man. He said two more soldiers held him in the chair and pulled his head back. He said he became


