



THE INFORMATION IN THIS REPORT IS BASED UPON AN ALLEGATION OR PRELIMINARY INVESTIGATION AND MAY BE CHANGED PRIOR TO THE COMPLETION OF THE INVESTIGATION.

THIS INVESTIGATION WAS INITIATED UPON NOTIFICATION FROM HQ, U.S. ARMY CRIMINAL INVESTIGATION COMMAND WHO RECEIVED INFORMATION FROM THE INSPECTOR GENERAL'S OFFICE THAT SFC HHC, 2/325TH AIRBORNE INFANTRY REGIMENT (AIR), FOR BRAGG, NC 28310 (FBNC), WITNESSED A DETAINEE BEING ABUSED BY PFC WHILE DEPLOYED TO IRAQ.

PRELIMINARY INVESTIGATION REVEALED THAT WHILE ON A SEARCH FOR WEAPONS MISSION OF A BAGHDAD WAREHOUSE, PFC PLATOON ENCOUNTERED APPROXIMATELY 5 SECURITY GUARDS WITH WEAPONS WHO WERE PERFORMING SECURITY ON THE WAREHOUSE. THE PLATOON SECURED THE FIVE GUARDS, ENTERED THE BUILDING AND SECURED THE WAREHOUSE FACILITY, WHICH WAS TO ALLEGEDLY HELD A WEAPONS CACHE. THE PLATOON THEN ESCORTED THE FIVE SECURITY GUARDS OUTSIDE TO A MORE SECURE ENVIRONMENT ACCORDING TO SOP. WHILE OUTSIDE, THE GUARDS WERE ORDERED TO TAKE A KNEE OR SIT DOWN AND BE QUIET. ONE SECURITY GUARD BEGAN TO GET LOUD AND AGGRESSIVE IN ARABIC, CAME TO HIS FEET AND SPIT ON PFC THEN RESPONDED WITH A RIGHT BACK HAND STRIKE TO THE TOP OF THE GUARDS HEAD.  - Civilians from crimes that are likely to cause death or serious bodily harm, such as murder or rape
 - Designated civilians and/or property, such as personnel of the Red Cross/Crescent, UN, and US/UN supported organizations.
- 3. Treat all civilians and their property with respect and dignity. Do not seize civilian property, including vehicles, unless you have the permission of a company level commander and you give a receipt to the property's owner.
- Detain civilians if they interfere with mission accomplishment or if required for self-defense.
- 5. CENTCOM General Order No. 1A remains in effect. Looting and the taking of war trophies are prohibited.

REMEMBER

- Attack enemy forces and military targets.
- Spare civilians and civilian property, if possible.
- · Conduct yourself with dignity and honor.
- Comply with the Law of War. If you see a violation, report it.

These ROE will remain in effect until your commander orders you to transition to post-hostilities ROE.
