Lead Vehicle saw White 4 door Sedan approaching convoy towards front of convoy headed east. Vehicle contained two male LN. at 120m waved paddle with stop sign. At 100m M203 smoke round fired. Following smoke round, vehicle increased in speed. At 60m one 5.56mm round fired to disable vehicle. Round hit front engine compartment. Vehicle did not stop. At 50m one 5.56mm round fired to disable hit front engine compartment. Vehicle did not stop. At 40m one 5.56mm round fired at windshield to disable driver. Vehicle stopped. Buffalo containing medic moved to location of the LN vehicle. Medic assessed as Critical. Air Medevac called to 1-502 TOC. Medevac denied by 1-502. SIC moved to [REDACTED]. At 0955 LN declared DOA by B/1-502 medic at [REDACTED]. No pictures taken on site during incident because ground Medevac was priority. SIC returned to EOF site to take pictures after declared DOA. The LN vehicle was not present. A LN was present and said to SIC team that the uninjured occupant of the vehicle had called a wrecker and took the vehicle to their residence. SIC took photos of site. 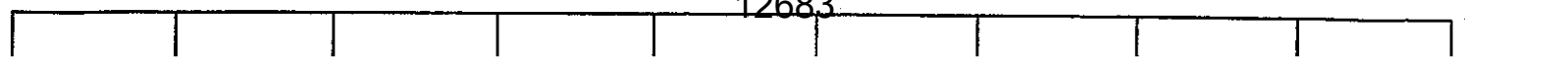

On 22 Apr 2006, at around 0930, I began treatment of an Iraqi national with a gunshot wound to the face. The round hit the windshield of the vehicle, entered the national through the mouth, exited through his jaw about 1/2 an inch to the left of the entrance wound. And hit the rear passenger side window. When I had gotten to the national, he was unconscious, eyes open and not moving. I checked for a pulse and felt a strong one. I took him out the vehicle and began trying to position him so the blood would not go to the back of his throat. I had decided that he needed medical treatment immediately and needed to get to an actual facility. My security had brought me a litter, we got him on and put him on an AG-31. We headed for [REDACTED] as I continued to check his pulse to make sure he wasn't dead. I continued to check for a pulse until we reached [REDACTED], then I had begun to prepare to get out. When we got there, ~~the~~ myself and three other soldiers did a 4-man litter carry into the medical Treatment facility. We set him on the litter stand and handed the national to the medics

While traveling west on [REDACTED] at 0935 at grid [REDACTED] I was the TC for the lead vehicle (RG-31) A22. My gunner and I spotted a white four door vehicle heading towards the convoy. Due to the possible VBIED threat that was briefed on the convoy brief I decided to turn all traffic around. at around 120m my gunner used hand and arm signals, and the paddle, my driver [REDACTED] used the horn, the victor did not comply and continued to travel towards the convoy. i had my driver stop. At about 100m [REDACTED] fired a 40mm smoke round, the vehicle speed up towards us. At 60m [REDACTED] fired one round of 5.56 into the front right tire, the vehicle did not stop. At 50m [REDACTED] fired another round this time hitting the engine compartment, still no compliance from the white victor. At about 40m [REDACTED] fire one round into the passenger windshield, the round hit the driver, the vehicle came to a stop. the passenger dismounted and moved the victor of the road. I had my driver move up to asses the vehicle. I saw that the driver was hit, and in bad shape. I called the buffalo forward with the medic. [REDACTED] made the assessment that the civilian need immediate med vac. Ground med vac was organized and the patient was placed in my vehicle in a litter. We headed to [REDACTED] At the FOB a medic from 1-502 declared the civilian deceased. A decision was made to return to the site and take pictures of the site. When we arrived the vehicle had been moved, I took pictures of the locations and we returned to [REDACTED]. At the FOB the passenger of the vehicle meet us on the front gate, I got all his info and asked of the location of the white car, he had his nephew show us the location. We secured the civilian and headed for the house, and had some family members bring the vehicle to our location. [REDACTED] dismounted and took pictures of the damage. We returned to the FOB were we received the pictures of the deceased. We continued mission, sweeping [REDACTED], [REDACTED] and [REDACTED] to FOB Striker

The Events that Transpired on the morning of the 23<sup>rd</sup> were as follows. A white vehicle approached us from the front of our convoy along [REDACTED]. The Gunner in the lead truck [REDACTED], began waiving off the car using hand and arm signals. He also had the driver honk the horn and he yelled stop! The vehicle continued along its course so he used an M203 smoke (red) round. He fired the round to the south side of the road. The vehicle actually stopped but sped back up; he then utilized his M-4 and fired disabling shots into the driver's side tire and then the engine (total of two shots). Still the vehicle persisted to approach the convoy. His next shot was to the windshield on the driver's side. This proved to be a fatal shot to the face of the driver.

Immediately the TC [REDACTED] called back to me and informed me that a Local National had been shot and was severely injured. I (convoy commander) directed the medic to begin work on the injured LN. The medic informed me that he needed medevac. I directed the PSG [REDACTED] to call in medevac while I notified 1<sup>st</sup> BN, 502<sup>nd</sup> IN Regiment. They would not respond to me, and [REDACTED] informed me that we needed to take this LN to [REDACTED] for Medevac.
