MEMORANDUM OF OPINION

SUBJECT: Claim of [REDACTED], 6-IR8-760

1. **Identifying Data:** [REDACTED], Ad Duluyiah, Iraq
2. **Date and place the incident occurred giving rise to the claim:** The claim occurred on 19 March 2006, in Ad Duluyiah, Iraq.
3. **Amount of claim and date it was filed:** Claimant filed a claim for \$15,000 on 21 May 2006.
4. **Jurisdiction:** This request is presented for consideration under the provisions of the Foreign Claims Act, 10 USC Section 2734, as implemented by Chapter 10, Army Regulation 27-20. This claim was filed in a timely manner.
5. **Facts:** The Claimant alleges CF raided his home and killed his father, mother and brother. The Claimant provided witness statements, photographs, death certificates, and a legal expert opinion to substantiate the claim. A SIGACTS investigation revealed no activity similar to the Claimant's description of events.
6. **Opinion:** There is no record of any unit conducting a raid in that area on 19 March 2006. Further, a raid constitutes combat activity. This claim is not compensable under the FCA.
7. **Recommendation:** The claim is denied.

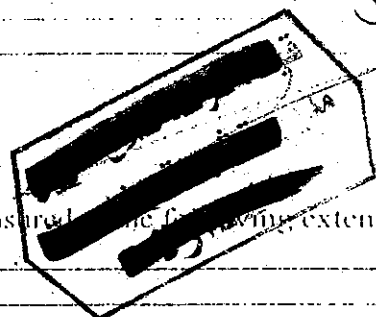
