ON 2006 02 08, AT ABOUT 1650, I WAS DRIVING NORTH ON ROUTE [REDACTED], IN THE LEAD VEHICLE, A HUMMVEE, OF A S05C552(C) TWO VEHICLE CONVOY, WITH A BRADLEY BEHIND US, WHEN WE WERE HIT BY AN IED. WE DROVE OUT OF THE BLAST ZONE, ABOUT 300 METERS NORTH OF WHERE WE WERE HIT, WHEN I HEARD THE BRADLEY COMMANDER CALL UP TO CONFIRM THERE WERE NO FRIENDLY DISMOUNTS ON THE GROUND AND TO REQUEST PERMISSION TO ENGAGE TWO INDIVIDUALS RUNNING FROM THE DIRECTION OF IED BLAST. THE PLATOON LEADER, SFC. [REDACTED] GAVE PERMISSION TO ENGAGE, SO BRADLEY GUNNER FIRED SOME ROUNDS OFF IN DIRECTION OF SUSPECTS. OUR HUMMVEE, ALONG WITH ANOTHER, HEADED TO WHERE TARGETS WERE ENGAGED; UPON DISMOUNTING, AN INJURED CIVILIAN FEMALE WAS DISCOVERED.
