Q: What was your duty position and mission on the night of 4 MAR?

A: I was the driver of D44, one of the two lead vehicles in 1st FLT. I was in the lead vehicle, with SGT [REDACTED] (gunner). Our mission was to enforce curfew. My vehicle (D44) and SFC [REDACTED] vehicle were on far security, ahead of a dismount sqd.

Q: Were you on a static site security mission; like a TCP?

A: No. we were constantly moving. Every time the dismounts caught up with us we moved. It was like bounding overwatch.

Q: Where were you when the incident happened?

A: Outside my vehicle, next to the left front fender, pulling security to the left-front side.

Q: Did you see the incident happen?

A: I did not see the vehicle approach, or the initial firing. I ~~was~~ turned around and saw the last couple of shots. The vehicle had already stopped.

Q: Did any vehicles approach your own vehicle?

A: There were a few vehicles in the distance. Every time they approached, I flashed my TAC lite, and they turned away. End of Statement

A: There was very little traffic. No vehicles came near us. Several personnel approached us from an alleyway, but they turned away when my gunner and me flashed our Tac-Lites at them.
