MEMORANDUM OF OPINION

SUBJECT: Claim of [REDACTED], 06-IO6-0291

1. Claimants name and address: [REDACTED], Amsha Village, Kirkuk, Iraq.
2. Incident date and place the incident occurred giving rise to the claim: Incident occurred on 29 June 2005, at Debis Suburb, Kirkuk, Iraq.
3. Amount of claim and filing date: Claimant filed a claim in the amount of \$6,000.00 on 22 February 2006.
4. Chapter the claim was considered under and a brief description of the incident or of the issues raised by the claimant on reconsideration: Foreign Claims Act and Chapter 10, AR 27-20; claim filed for the death of claimant's father and damages to vehicle.
5. Facts:
 - a. [REDACTED] claims that on 29 June 2005, Coalition Forces shot and killed his father and destroyed the vehicle.
 - b. Coalition Forces did in fact kill [REDACTED]. The unit was acting in accordance with the Rules Of Engagement at the time of the incident.
 - c. The claimant's mother, [REDACTED] received a good will payment of \$1365 on 29 August 2005. The payment was for both damages and the wrongful death of her husband.
6. Opinion:
 - a. In order to form a basis for a claim under the FCA, the incident in question must have arisen outside the United States. In addition, the incident must be caused by either non-combat activities of the United States Armed Forces or by negligent or wrongful acts of military members or civilian employees of the Armed Forces.

b. There is insufficient evidence to suggest that this incident arose out of the negligence and/or wrongful acts of the United States Armed Forces. This incident is a direct result of combat operations. Any appeal must be submitted within 30 days.

7. Action: This claim is not payable under the FCA for the above mentioned reasons. Consequently this claim for \$6,000.00 is denied.
