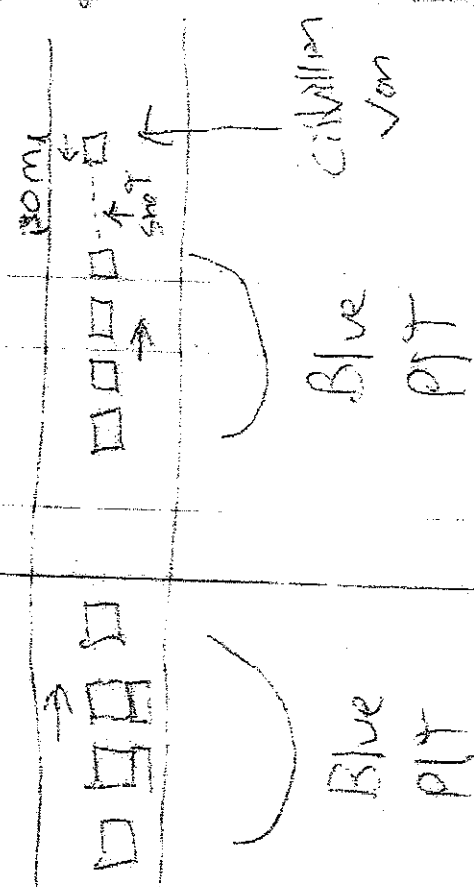

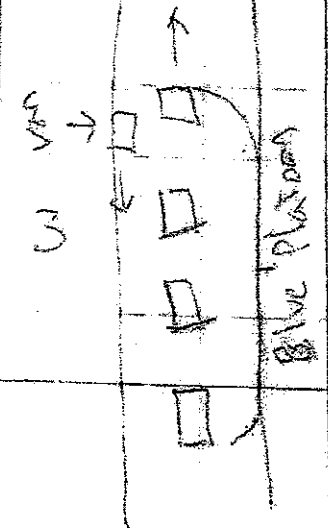

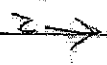

After that a convoy escorted me to [REDACTED] police station. There was a convoy and several people around the place of the incident and they all saw the shooting with their own eyes.

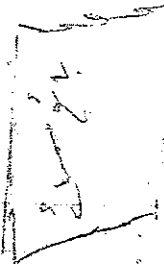

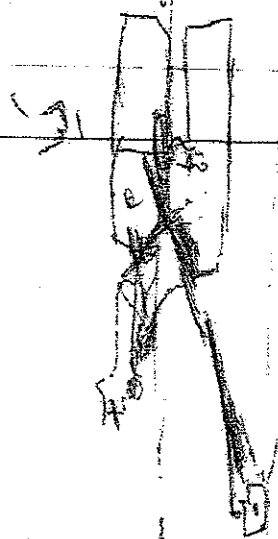

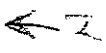

LINE 6: SUMMARY: At 2005 an IZ male entered the [REDACTED] IP station and reported that a U.S. wheeled patrol shot at his vehicle on RTE [REDACTED] at approximately 1900 hrs. The civilian vehicle was traveling west on ASR [REDACTED] and the U.S. patrol was traveling east. After the shooting all personnel ran from the vehicle. Another IZ that witnessed the shooting approached the van and noticed that the driver of the vehicle showed no signs of life. The witness claimed that the driver was killed from a gunshot wound. The witness did not know who the man was, and went to the [REDACTED] IP station to report the incident. The IPs at the Taji station escorted the witness and the remains to the [REDACTED] IP station. B/1-115th, collocated at the IP Station, learned of the incident and reported the information to the TF TOC. All units that were traveling along ASR [REDACTED] between 1830-2030, to include 70th EN, were questioned regarding warning shots and escalation of force. Upon further investigation, 2/A/2-70 reported that they had fired warning shots at a minivan while traveling east on ASR [REDACTED] enroute to Camp [REDACTED]. The TC XO is currently conducting an AR 15-6 investigation at the [REDACTED] IP station.

UPDATE:

On 21AUG05 O/A 1900, 3/A/2-70 was conducting a patrol east on ASR [REDACTED] [REDACTED]. The patrol was 4 x M1114s. The crew of A32 (lead vehicle of the patrol) encountered a civilian blue minivan approaching the patrol from the west, traveling in the center of the road towards the patrol at 150 meters. The gunner of A32, identified an oncoming vehicle in the center of the road traveling at a high rate of speed. At 100 meters he attempted to slow the vehicle and have it yield by utilizing hand and arm signals. The crew observed no change in the vehicle's speed or its position in the center towards the northeast) in an attempt to cause the operator of the van slow and pull off the road. The crew observed no change in vehicle speed or position. The driver of A32, recognizing that the minivan is not slowing, and concerned over a possible VBIED attack, applied his brakes to reduce his rate of speed. At 30 to 50 meters the gunner of A32 fired one aimed disabling shot at the grill. The minivan immediately slowed and pulled off the

road. The crew and follow-on crews of the patrol observed no unusual activity and continued their mission without further incident.

Additional information: The platoon/patrol had recently completed ROE refresher training and conducted an ROE vignette as part of the pre-patrol brief and preparation. The platoon had recently been attacked by a VCIED along RTE [REDACTED] on 12AUG. The platoon did not report the EOF until the LNs reported the event at the SAB IP Station. AR 15-6 investigation continues.
