

3. LOCATION OF INCIDENT OR DAMAGE: Yousifiyah area, Baghdad
4. DESCRIPTION: While traveling in the Yousifiyah area of Baghdad, a U.S. convoy received fire from Anti-Iraqi Forces. When they returned fire, the claimant's (g)(q) was near the area and was shot. The victim was taken to the 86th Combat Support Hospital, where he was pronounced dead at 081825JAN05.
5. JUSTIFICATION: By making this condolence payment, MNF ensures the family and community recognize the MNFs' sympathy for the unfortunate loss. Support will positively influence both the community and local Iraqi leaders.
