Freeman, M.D. Dr. Edmund Griley and Dr. John Dunlop both died. The Reverend Milton H. Cole, Jr. and Laurie Konwith left Guam many years ago, after this case was complete and all appeals exhausted, and I have not had any contact with either of them since they left. The Guam Society of Obstetricians & Gynecologists is no longer in existence. The Guam Nurses Association ("GNA") is no longer represented by me or the ACLU and they should be dropped from this action pursuant to Fed.R.Civ.P. 21.
