### **DECLARATION OF RACHEL MILNE**

- I, Rachel Milne, do hereby declare as follows:
- 1. I am over the age of eighteen and am competent to testify as to all the matters set forth in this declaration and would so testify if called upon to do so.
- 2. I have personal knowledge of the matters set forth in this declaration. My personal knowledge is based upon my observations and personal participation in the events described below.
- 3. I currently serve as the Director of the Office of Homeless Solutions ("OHS") for the City of Phoenix. I have served in that capacity since October 2022.
- 4. In my capacity as Director, I am responsible for, among other things, implementing the City's Strategies to Address Homelessness Plan; executing measures that create additional shelter capacity in the region; working in partnership with other municipalities and government entities to address and end homelessness in the region; and providing overall administration and program direction to OHS, including staff supervision, budget, and financial management of programs.
- 5. OHS and the City are undertaking numerous efforts to expand services to and ultimately house unsheltered individuals. Many such efforts have already been identified in the City's Response and accompanying Declarations and elsewhere.
- 6. Among many other efforts, over the next two years, the City plans to add 760 beds to existing emergency shelters and temporary housing facilities. This is in addition to the 592 beds the City has already added this year. This City is also actively seeking additional properties and other opportunities to provide shelter and housing for people experiencing

homelessness. Much of the focus is on those individuals who are unsheltered around the Human Services Campus ("HSC").

- 7. The City has also started planning and opening its own shelters, all of which will include extensive outreach to nearby neighbors and businesses and will consist of closed campuses with no walk-up services; street outreach teams that will transport new clients on a referral basis only; and smaller, more regionalized shelters (*i.e.*, not all located in the area that Plaintiffs refer to as "the Zone").
- 8. The funds approved so far by the City Council for these and other projects/services totals approximately \$107 million, many millions of which have already been expended.
- 9. These City and OHS efforts belie the allegations in the Complaint and supporting documents that the City is utilizing insufficient resources to homelessness solutions and intentionally diverting unsheltered persons to "the Zone" to remove them from other parts of the City.
- 10. As noted elsewhere, the City has established a plan to resume thorough cleanings of the area in question ("Enhanced Cleanups") on December 16, 2022. [See Declaration of Scott Hall, ¶¶ 23-25] A necessary part of the Enhanced Cleanups is providing individuals with adequate notice of when the Enhanced Cleanups will occur, which the City has always done and will continue to do, so that they can collect and temporarily remove their personal property. [See id., ¶¶ 8-10, 25]
- 11. Based on the City's past experience with Enhanced Cleanups and based on my general familiarity with the area in question, it is virtually certain that at least some personal property will be left behind during Enhanced Cleanups.

- 12. As part of the Enhanced Cleanups, the City has established a plan for the retrieval, storage, and disposal of abandoned property. [Attachment 1, HSC Enhanced Clean Up Abandoned Property Procedure (the "Abandoned Property Procedure")]. The Abandoned Property Procedure was offered as part of the record in *Freddy Brown et al. v. City of Phoenix*, Maricopa County Sup. Ct. Case No. CV2022-010439.
- 13. The Abandoned Property Procedure sets forth what the City intends to do with property that appears to be "abandoned," which the City defines as property that is left unattended for more than 1 hour after the street is closed for Enhanced Cleanups. [See id.] In summary, the Abandoned Property Procedure involves at least the following:
  - Wrapping abandoned property with caution tape and tagging the items, including logging the location of the abandoned items.
  - Providing notice on the property itself that if not claimed, the property will be removed from the site within 7 days, as well as a procedure for notifying the HSC that the property is in fact not abandoned.
  - If not claimed after 7 days, abandoned property will be removed and taken by
    HSC staff and stored in a closed and locked storage container for 30 days.

    Individuals can access their property with HSC staff during business hours, 7 days a week.
  - If abandoned property is unclaimed after 30 days, it will be disposed of. HSC staff will retain any vital documents, records, or identification for a period of one year.
- 14. In total, individuals will have 37 days to retrieve abandoned property. For 7 of those days, the property will remain on the street itself, exactly where it was left in the first place.

15. The City does not intend to indiscriminately dispose of personal property as part of the Enhanced Cleanups. Rather, the City is committed to ensuring, wherever possible, that individuals are afforded the opportunity to remove their personal property and retrieve personal property left behind, to the greatest extent reasonably possible. The claim that the City intends to deprive people of their property indiscriminately and unconstitutionally is simply unfounded.

Pursuant to 28 U.S.C. § 1746, I, Rachel Milne declare under perjury, that the foregoing is true and correct.

# ATTACHMENT 1

# HSC Enhanced Clean Up Abandoned Property Procedure

#### **HSC Homeless Outreach Team Clean Up Day Duties:**

- Ask people camping in designated area (within the street closure area) to move belongings, direct them to the designated staging area
- Assist individuals with disabilities or otherwise unable to move their own belongings utilizing trucks or other tools necessary. Help get the individuals and their belongings to the designated staging area.
- After the cleanup concludes, assist individuals in need as they move their belongings back
- Provide water to individuals in the heat
- Manage ABANDONDED PROPERTY outlined below.

#### **HCS Outreach Team Abandoned Property Procedure:**

- 1. Identify property that is unattended/abandoned. Property is considered to be abandoned when there is not an individual present for more than one hour as the street is closed for enhanced deep cleaning.
- 2. Abandoned property will be clearly wrapped with caution tape and a tag/flyer will be secured on the property. HSC staff will log the location of the abandoned property.
  - a. The tag/flyer will state that the property has been considered abandoned and will be removed from the site in seven days (exact date will be displayed).
  - b. The tag/flyer will direct the owner of the property to go to the Brian Garcia Welcome Center to notify HSC staff that the belongings are NOT abandoned
- 3. After the property has been wrapped in caution tape and 'tagged' for 7 days and remains unclaimed, the property will be removed by HSC Outreach Staff and stored in a closed, locked, storage container for an additional 30 days.
  - a. HSC staff will take pictures and create a detailed inventory of items that are moved from to the storage container.
  - b. HSC staff will retrieve items from storage container if/when a credible claim for the property is made.
    - i. Prescription drugs will only be released to a person with identification matching the prescription information on the packaging.
- 4. If owner of property has not claimed property after 30 days, HSC will dispose of property.

## **DECLARATION OF SCOTT HALL**

- I, Scott Hall, do hereby declare as follows:
- 1. I am over the age of eighteen and am competent to testify as to all the matters set forth in this declaration and would so testify if called upon to do so.
- 2. I have personal knowledge of the matters set forth in this declaration. My personal knowledge is based upon my observations and personal participation in the events described below.
- 3. I currently serve as the Deputy Director of the City of Phoenix's Office of Homeless Solutions. I have served in that capacity since December 2021.
- 4. In my capacity as Deputy Director, I am responsible for, among other things, overseeing and managing contracts with third-party providers of homeless solutions, overseeing the expenditure of City funds related to those contracts, and coordinating various projects and tasks related to providing services to the homeless and unsheltered populations.
- 5. In my capacity as Deputy Director, I am also tasked with overseeing and coordinating various City departments for the cleaning of streets within the area the Plaintiffs in this action refer to as "the Zone."
- 6. Before January 2022, the City conducted thorough cleanings ("Enhanced Cleanups") of the area in question. Plaintiffs characterize these Enhanced Cleanups as "sweeps" or "raids," a characterization with which I disagree. The City has never conducted "sweeps" or "raids," to my knowledge.
- 7. These Enhanced Cleanups occurred two to three times per week, depending upon area needs, City staff's and City contractors' capacity, and the cleaning schedule established by the City.

- 8. The City did not conduct unannounced Enhanced Cleanups. Rather, Enhanced Cleanups occurred with prior notice to the unsheltered individuals who resided in the area.
- 9. Specifically, many permanent signs were erected and posted on poles throughout the area that informed individuals of the cleaning schedule, as has been publicized in news media reports. *See*, *e.g.*, Phoenix New Times, *Phoenix Prepares to Restart Controversial Cleanups of Homeless Encampment* (Nov. 15, 2022), <a href="https://www.phoenixnewtimes.com/news/phoenix-prepares-to-restart-controversial-cleanups-of-downtown-homeless-encampment-14879886">https://www.phoenixnewtimes.com/news/phoenix-prepares-to-restart-controversial-cleanups-of-downtown-homeless-encampment-14879886</a> (second image in article).
- 10. These signs were clearly posted and were impossible to miss. There were many such signs prominently located throughout the area; they appeared in distinctive red and white lettering, *see id.*; and were 24 inches by 30 inches in size, the size of a standard speed limit sign. [Attachment 1, Clean Up Notice Graphic]
- 11. Based on my many interactions and conversations with unsheltered individuals in the area both before January 2022 and since then, I know and can attest that the Enhanced Cleanups schedule was also a matter of common knowledge amongst the unsheltered residents of in the area in question.
- 12. Work crews usually arrived to conduct Enhanced Cleanups relatively early in the morning, between 5:00 and 7:00 a.m. This was primarily because people are more likely to be physically present with their belongings in the morning hours and able to secure and remove their belongings so that the Enhanced Cleanups could occur. This was also because work crews begin work early in the day to accomplish their daily tasks, particularly during the warmer months of the year.

- 13. To my knowledge, Enhanced Cleanups never occurred during nighttime hours or in the wee hours of the morning, *e.g.*, at 3:00 a.m., as Plaintiffs allege.
- 14. Because work began early in the morning, individuals would, as Plaintiffs allege, sometimes still be sleeping when work crews arrived to conduct Enhanced Cleanups. To conduct the Enhanced Cleanups, City police and security personnel, and other City employees and contractors responsible for outreach to the homeless community, would announce their presence for the Enhanced Cleanups, and people sometimes would be awakened in the process.
- 15. These Enhanced Cleanings were conducted by geographic area, and crews took the area section by section using various common cleaning elements and heavy equipment (*e.g.*, street sweepers, front loaders, dump trucks, rakes, garbage bags, etc.). Enhanced Cleanings usually lasted about one hour per section.
- 16. To my knowledge, and based on my own observations, people were never given "mere minutes" to gather their personal belongings before Enhanced Cleanups started, as Plaintiffs allege. Rather, in addition to the fact that the Enhanced Cleanup schedule was posted and widely known, City staff and contractors announced their presence and waited for a reasonable time, usually twenty to thirty minutes, for people to collect their belongings and vacate the area.
- 17. Individuals were given the opportunity to take their belongings to a staging area where they could keep their belongings while cleanings were underway. After cleanings were complete, individuals were free to return to the area with their belongings.
- 18. Plaintiff's statement that cleaning crews would "indiscriminately remove and destroy remaining items" is a gross mischaracterization.

- 19. Although items, which could have included personal effects, sometimes were left behind, the reality is that there was often no way to identify to whom they belonged or no way to find the person to whom they belonged. Also, and frequently, they would be strewn amongst a tremendous amount of garbage, food and human waste, and other debris that is unsafe, unsanitary, and unreasonable to expect any person to sift through.
- 20. As one recent example, on December 7, 2022, I was present while the City's homeless liaisons were assisting an unsheltered and incontinent woman of advanced age move her belongings so that she could receive services from a local nonprofit service provider. With her belongings was a heavily soiled adult diaper, the contents of which had transferred onto some of her belongings, including various papers. The resulting damage to those belongings was bad enough that the liaisons and I were unable to identify what some of the papers were. Further, the conditions were so unsanitary that staff was unable to inspect or save those belongings, and they had to be thrown away because of the health hazard they presented. This is but one example, among many that I could provide, of how a person's belongings, personal effects, papers, etc., may have ended up being disposed of during Enhanced Cleanups. I do not know (nor have Plaintiffs explained) the specific conditions under which the personal property identified in the Complaint was allegedly disposed of, if it was in fact disposed of.
- 21. In January 2022, the City ceased conducting Enhanced Cleanups in the area, primarily because many of the unsheltered individuals in the area simply refused to temporarily relocate. The City paused the Enhanced Cleanups to ensure that the City was conducting them in a safe and appropriate manner, both for the residents and for City personnel and contractors.
- 22. Since January 2022, the City has conducted scaled-back cleanups of the area that involve cleaning the streets themselves and collecting trash put for collection in the streets.

- 23. To date, to my knowledge, no unsheltered resident of the area has raised issues with these scaled-back cleanings, notwithstanding that the City has been conducting them for nearly a year.
- 24. In or around Spring 2022, the City began planning to resume Enhanced Cleanups in the area. As part of that that planning process, the City put together a draft plan that delineates roles and responsibilities of various City personnel and City partners in resuming Enhanced Cleanups. [See Attachment 2, HSC Enhanced Clean Up Roles/Responsibilities (the "Enhanced Cleanup Plan" or the "Plan")] The Enhanced Cleanup Plan was offered as part of the record in Freddy Brown et al. v. City of Phoenix, Maricopa County Sup. Ct. Case No. CV2022-010439, and is the plan with which Plaintiffs take issue in this case.
- 25. The Enhanced Cleanup Plan itself is self-explanatory. Additionally, although not specifically included in the Plan, the City intends to now close the streets beginning at 6:00 a.m., and work crews will begin asking people to move their belongings thereafter, sometime around 6:30 a.m. Individuals will have ample time (at least an hour or more) to remove their belongings. Enhanced Cleanups are now scheduled to last until approximately 1:00 p.m. to ensure that people have more than enough time to remove their belongings, although the City expects that the actual cleaning may take much less time and end earlier than 1:00 p.m.
- 26. In December 2022, the City distributed flyers to unsheltered individuals in the area, local service providers, and to news media that the Enhanced Cleanups are expected to resume on December 16, 2022. [See Attachment 3, Notification of Enhanced Cleanings] Prior to distributing flyers, the City held three community town hall style meetings with the unsheltered population in the area to inform and receive feedback regarding the Enhanced Cleanup process.

27. There is nothing in the Plan or in the flyer, and City offered no evidence or testimony in the state court proceeding, that reasonably could be interpreted to mean that the City intends to or will indiscriminately dispose of people's belongings or unconstitutionally remove people from the area. To the contrary, based on all available and competent evidence, the City intends to assist people in removing their belongings to a safe area if needed; assist them in relocating to a safe shelter area, if they so desire; store individuals' personal property; and conduct the Enhanced Cleanups in a manner that is both humane and that comports with constitutional guarantees, as the City has always done.

Pursuant to 28 U.S.C. § 1746, I, Scott Hall, declare under perjury, that the foregoing is true and correct.

- Ask people to move belongings, direct them to a safe place
- Assist individuals with disabilities or otherwise unable to move their own belongings utilizing trucks or other tools necessary
- Assist individuals after the clean up to move their belongings back
- Identify and tag property where there are not individuals present to move property. Notify them that the property will be considered abandoned after 7 days
- Remove property that is considered abandoned after 7 days
- Photograph and log property considered abandoned, store for 30 days
- Provide water to individuals in the heat

#### **CBI Outreach Team:**

- Ask people to move belongings, direct them to a safe place
- Assist individuals with disabilities or otherwise unable to move their own belongings utilizing trucks or other tools necessary
- Engage individuals that are actively moving their belongings to accept services
- Enroll clients that are willing/able to move indoors
- Assist clients with storage of belongings if they are moving indoors
- Provide water to individuals in the heat

#### **Police Department:**

• Present in neighborhood in case of emergency

#### **TEAMS Security:**

- Provide security to Streets Employees as they clean area
- Alert PD in case of emergency

# **Streets (Contracted team):**

- Street Sweeping areas that have been cleared
- Power wash areas that have been cleared
- Avoid areas where property has not been removed
- Move to newly closed off area once it has been cleared
- Vacuum storm drains (as needed)

# Streets (City team):

• Clean entire area Phases 1-4 with 'unenhanced' cleaning protocol

#### **Public Works:**

- Provide 20 recycle bins as moving boxes
- Provide four roll-off bins in area adjacent to designated area
- Be on call to remove and replace full bins

## **Notification of Enhanced Cleanings**

**When**: Beginning Friday, December 16<sup>th</sup>, 7 a.m. – 1 p.m.

Where: Madison Street between 12<sup>th</sup> and 13<sup>th</sup> Avenues.

Who: City of Phoenix, Human Services Campus and Community Bridges, INC. (CBI) staff members

**What**: The City of Phoenix will be cleaning and removing trash, waste and other debris from the area.

**How:** If you are in the area (Madison St. between 12<sup>th</sup> & 13<sup>th</sup> Aves.), you will be asked to temporarily move your belongings to a designated safe area on the Northwest corner of 12<sup>th</sup> Ave. and Madison St. Staff will be available to assist you if you are unable to move your belongings on your own. After the cleaning is complete, you will be able to return to the area. **If you're interested in seeking a shelter option, staff will be able to help transport you to an available indoor location.** 

**Why:** The City of Phoenix is committed to making the area as safe as possible for people experiencing homelessness and the residents and business owners in the area.







## **DECLARATION OF BRIAN FREUDENTHAL**

- I, Brian Freudenthal, do hereby declare as follows:
- 1. I am over the age of eighteen and am competent to testify as to all the matters set forth in this declaration and would so testify if called upon to do so.
- 2. I have personal knowledge of the matters set forth in this declaration. My personal knowledge is based upon my observations and personal participation in the events described below.
- 3. I am the Commander over the Downtown Operations Unit in the Central City Precinct of the Phoenix Police Department (the "Department"). The Downtown Operations Unit encompasses the area that Plaintiffs in this action call "the Zone." I have been the Commander over the Downtown Operations Unit for over a year and have been a Commander for over three years. Prior to my service in this role, I have served for many years as an officer, sergeant, and lieutenant in the same area. As a result, I am intimately familiar with "the Zone" and day-to-day police operations within the DOU.
- 4. I am aware that Plaintiffs allege that the Department indiscriminately cites and/or arrests individuals pursuant to Phoenix City Code Sections 23-30(A) and 23-48.01. I am also aware that Plaintiffs seek to enjoin the City and the Department from citing and/or arresting individuals pursuant to those sections of the City Code.
- 5. Section 23-30, "Camping," provides, in relevant part: "It shall be unlawful for any person to camp in any park or preserve, or in any building, facility, or parking lot or structure, or on any property adjacent thereto, that is owned, possessed and controlled by the City...." See <a href="https://phoenix.municipal.codes/CC/23-30">https://phoenix.municipal.codes/CC/23-30</a>.

- 6. Section 23-48.01, "Prohibited use of public right-of-way," provides: "It shall be unlawful for any person to use a public street, highway, alley, lane, parkway, sidewalk or other right-of-way, whether such right-of-way has been dedicated to the public in fee or by easement, for lying, sleeping or otherwise remaining in a sitting position thereon, except in the case of a physical emergency or the administration of medical assistance."
- 7. The Department logs its arrest and citation data through its Crime Analysis and Research Unit ("CARU"). CARU staff uses its software to generate reports for arrests and citations throughout the City, including in specific areas of the City, as designated by grid.
- 8. Attached to this Declaration are two reports generated and kept in the ordinary course of business by CARU staff:
  - Attachment 1: Arrests made in Grid BA26<sup>1</sup> for violations of Section 23-30 or Section 23-48.01;
  - Attachment 2: Arizona Traffic Ticket and Complaint ("ATTC") citations issued in Grid BA26 that contain at least one charge under Section 23-30 or Section 23-48.01.
- 9. As reflected in Attachment 1 and directly contrary to the allegations in the Complaint the City is not conducting indiscriminate or mass arrests pursuant to its authority under Section 23-30.
- 10. Attachment 1 indicates that in 2018, the Department made 5 arrests and booked 0 individuals into jail pursuant to Section 23-30 in Grid BA26.

<sup>&</sup>lt;sup>1</sup> Grid BA26 encompasses, and is slightly geographically larger than, the area Plaintiffs refer to as "the Zone." In total, Grid BA26 encompasses the area extending from 7<sup>th</sup> to 15<sup>th</sup> Avenues and Van Buren Street to the railroad tracks immediately south of the City center.

- 11. Attachment 1 indicates that in 2019, the Department made 14 arrests and booked 3 individuals into jail pursuant to Section 23-30 in Grid BA26.
- 12. Attachment 1 indicates that in 2021, the Department made 3 arrests and booked 1 individual into jail pursuant to Section 23-30 in Grid BA26.
- 13. There is no data reflected in Attachment 1 for the years 2020 and 2022. This is because, in those years, the Department made zero arrests and booked zero individuals into jail pursuant to Section 23-30 in Grid BA26.
- 14. As reflected in Attachment 2 and directly contrary to the allegations in the Complaint the City is also not indiscriminately citing people pursuant to its authority under Section 23-30.
- 15. Attachment 2 indicates that in 2018, the Department cited 2 individuals pursuant to Section 23-30 in Grid BA26.
- 16. Attachment 2 indicates that in 2019, the Department cited 15 individuals pursuant to Section 23-30 in Grid BA26.
- 17. Attachment 2 indicates that in 2021, the Department cited 3 individuals pursuant to Section 23-30 in Grid BA26.
- 18. There is no data reflected in Attachment 2 for the years 2020 and 2022. This is because, in those years, the Department cited zero individuals pursuant to Section 23-30 in Grid BA26.
- 19. As reflected in Attachment 1 and directly contrary to the allegations in the Complaint the City is not conducting indiscriminate or mass arrests pursuant to its authority under Section 23-48.01.

- 20. Attachment 1 indicates that in 2018, the Department made 75 arrests and booked 22 individuals into jail pursuant to Section 23-48.01 in Grid BA26.
- 21. Attachment 1 indicates that in 2019, the Department made 3 arrests and booked 0 individuals into jail pursuant to Section 23-48.01 in Grid BA26.
- 22. Attachment 1 indicates that in 2020, the Department made 11 arrests and booked 4 individuals into jail pursuant to Section 23-48.01 in Grid BA26.
- 23. There is no data reflected in Attachment 1 for the years 2021 and 2022. This is because, in those years, the Department made zero arrests and booked zero individuals into jail pursuant to Section 23-48.01 in Grid BA26.
- 24. As reflected in Attachment 2 and directly contrary to the allegations in the Complaint the City is also not indiscriminately citing people pursuant to its authority under Section 23-48.01.
- 25. Attachment 2 indicates that in 2018, the Department cited 71 individuals pursuant to Section 23-48.01 in Grid BA26.
- 26. Attachment 2 indicates that in 2019, the Department cited 2 individuals pursuant to Section 23-48.01 in Grid BA26.
- 27. Attachment 2 indicates that in 2020, the Department cited 11 individuals pursuant to Section 23-48.01 in Grid BA26.
- 28. In my many years working with the Downtown Operations Unit, as an officer, sergeant, lieutenant, and now as commander, I have never conducted "sweeps" or "raids" of unsheltered encampments let alone in the manner the Complaint describes. Further, the City has not ever untaken any such "sweeps" or "raids."

29. Any enforcement actions taken by the City are not intended to "criminalize, punish, and scatter [the unsheltered] population based on their status as unsheltered," as the Complaint alleges.

30. Neither I, the Downtown Operations Unit, nor this Department has ever arrested or issued citations to unsheltered individuals *en masse*. Further, I have not, and to my knowledge, neither has any member of the Downtown Operations Unit or this Department, ever used cleanups as a pretext to arrest or cite unsheltered individuals.

31. Neither I, nor any member of the Downtown Operations Unit nor this Department has, to my knowledge, ever knowingly and indiscriminately seized, impounded, or destroyed an unsheltered person's property or personal effects.

32. Although, as set forth in the City's Response, there may have been situations in which property had to be disposed of or cannot be retained for health and safety or other reasons, the allegations of indiscriminate seizure, impoundment, and destruction of property are simply factually inaccurate.

33. Because these purported "sweeps" and "raids" have never occurred, and certainly not as Plaintiffs allege, the allegations that they are "expected to intensify" in light of the City's revised enhanced cleaning plans are also unfounded.

Pursuant to 28 U.S.C. § 1746, I, Brian Freudenthal, declare under perjury, that the foregoing is true and correct.



## **DECLARATION OF GINA MONTES**

- I, Gina Montes, do hereby declare as follows:
- 1. I am over the age of eighteen and am competent to testify as to all the matters set forth in this declaration and would so testify if called upon to do so.
- 2. I have personal knowledge of the matters set forth in this declaration. My personal knowledge is based upon my observations and participation in the events described below.
- I currently serve as City of Phoenix Deputy City Manager and have been in that role since May 2021.
- 4. In my capacity as Deputy City Manager, I am responsible for, among other things, overseeing the City Housing Department, the Human Services Department, and the Office of Homeless Solutions.
- 5. The Office of Homeless Solutions coordinates, tracks, and oversees all homelessness services for the City, acts as a liaison to the community and the City Council on homelessness issues, and implements the policy goals of the City Council as it pertains to homelessness issues.
- 6. The City has developed Strategies to Address Homelessness and in the last fiscal year, dedicated nearly \$50 million dollars to homeless solutions, including shelters, increased affordable housing, and mental health services.
- 7. In June 2022, the Phoenix City Council approved \$107 million in affordable housing and homelessness programs as part of the ARPA [American Rescue Plan Act] Second Tranche Strategic Plan. In October, City Council approved \$12 million in contracts related to homeless solutions as part of that plan.

- 8. Although the City Council has authorized millions of dollars in funding to go towards locating and building shelters and affordable housing, the City has not yet expended the entire amount. There are multiple steps involved in building any type of shelter, including: identification of a suitable location; review of zoning and land use issues; procurement of a design professional to develop plans; public procurement and bidding requirements for construction; assessment of building and life safety codes; and a myriad of other steps to get the project from the conceptual phase to habitable condition. During this process, public outreach is conducted. The process of building a shelter can take substantial time.
- 9. To provide more rapid housing options, the City has used "sprung structures." A sprung structure is a soft-sided structure that can be constructed quickly and cost-effectively, while still having the ability to accommodate air conditioning and other amenities common in more permanent shelter options.
  - 10. In early 2022, the City opened a shelter that houses 200 adults.
- 11. The City continues to develop plans for increasing housing and shelter solutions in 2023. The City is focusing its resources on options that offer relief from the heat. Structured campgrounds, which some cities across the nation are experimenting with, have been considered by the City but are not currently being implemented due to concerns over the high summer temperatures in the City and risks such campgrounds may pose to the unsheltered inhabitants. The campgrounds are also estimated to have high operational costs comparable to the costs of operating traditional shelter facilities. This is concerning because they are considered, at best, an interim solution and do not provide relief from the heat. At this time, the City is focused on increasing permanent and semi-permanent shelter locations rather than creating structured campgrounds.

- 12. The City does not have any policy or practice of diverting unsheltered individuals to the downtown area. In my role overseeing the Office of Homeless Solutions, I can attest that I have never seen the City bus unsheltered individuals into the downtown area, pass out tents, or otherwise tell people to camp near the Human Services Campus ("HSC") or downtown. I also have not observed nor am I aware of any City policy or practice of telling people to camp by the HSC or downtown.
- 13. The City recognizes there is a concentration of unsheltered individuals located downtown near the Human Services Campus, primarily because of the accompanying high concentration of services available there. The City is working to locate housing for these unsheltered individuals and increase shelter capacity. However, there is no easy answer or quick fix to the problems of homelessness.
- 14. While the City is working on increasing shelter space to accommodate the vast growth of homeless individuals over the last few years, the City is also working to improve conditions in the downtown area for its unsheltered residents, property owners, and businesses. The City conducts regular cleanings of the area surrounding the Human Services Campus downtown, but more is needed to address health and safety concerns.
- 15. In order to understand the difficult issues downtown and how to manage the safety and sanitation concerns, I observed homeless encampment cleanups conducted by the City. Between May 2021 through November 2021, I recall observing at least three cleanups of the downtown area near the Human Services Campus which is referred to by Plaintiffs as the "Zone."
- 16. During these cleanups, City employees would typically arrive between 5:00 a.m. and 6:00 a.m. Employees would wake up individuals if they were asleep and let them know

cleaning was about to occur. Cleanings typically started an hour or two later. So, for example, if employees arrived at 5:00 a.m. cleaning would start between 6:00 a.m. and 7:00 a.m. I have never observed a cleanup start in early morning hours as Plaintiffs contend, nor is there any formal City policy or procedure which contemplates 3:00 a.m. cleanups of homeless encampments. Part of the rationale supporting the City's procedure of starting the process at such an early hour and sending outreach teams to wake up individuals in the morning is that people are more likely to be with their belongings in the morning while sleeping. This timing helps to protect individuals from being unintentionally separated from their belongings.

- 17. During the cleanups I observed, people were allowed time to collect their belongings. Street cleaners were on standby and called out only when people were moved into a staging area to allow safe use of vehicles.
- 18. Street cleaners do pick up hazardous materials for disposal during cleanups of homeless encampments. For example, if there are items covered in feces, urine, or drug residue that poses a threat to cleaning crews, the residents at large, and the unsheltered, the hazards will be removed and destroyed. I never observed any destruction of legal documents, identification, or other personal belongings during the cleanups I observed. It is possible that some documents could be destroyed during cleanups if they are not removed, visible, or if they are contaminated by unsafe substances.
- 19. The cleaning process typically lasted until noon or 1:00 p.m. However, if there were delays in moving people or health and safety concerns for the unsheltered residents, cleanings could be delayed. I know paramedics have been called to render medical assistance to the unsheltered and, on at least one occasion, I recall cleaning crews working around someone who was not feeling well on the day the cleaning was scheduled. Allowing people to remain in

place can pose practical challenges in conducting sanitation services, but employees will make case-by-case decisions based on the facts to allow sanitation to occur while minimizing disruption. I did not observe any instances in 2021 where unsheltered individuals were told to immediately wake up, remove their personal belongings in only minutes, and had all of their possessions destroyed. The procedures the City uses require notice of the cleanup and the opportunity to collect belongings, along with other procedural safeguards to protect the unsheltered.

- 20. Enhanced cleanups are scheduled to commence December 16, 2022 for the area around the Human Services Campus downtown. To raise awareness of the cleanups, the City has developed flyers to notify the public and unsheltered living in the area. The City has been distributing these flyers downtown to ensure people know that the cleanup is upcoming and have the opportunity to relocate, remove their belongings, seek services, or take other actions to minimize disruption to their lives.
- 21. The December 16, 2022 enhanced cleanup is viewed as a "pilot program" by the Office of Homeless Solutions. The City recognizes that there are serious public health and safety concerns downtown and requires thorough sanitation services. The plan is to conduct the cleanup, assess how it went, and modify procedures afterwards to improve practices as appropriate.
- 22. On the day of the proposed enhanced clean ups, the City plans to arrive around 5:00 a.m., but the cleanup will not typically begin until around 7:00 a.m. City officials will allow people to remove their belongings and assist unsheltered residents in moving their belongings if necessary. If any person is unable to leave the area due to illness, City employees may seek medical assistance for the individual, delay the cleanup, or simply clean up around the individual

if cleaning can safely proceed. Law enforcement resources have been minimized for the enhanced cleanups downtown.

- 23. During the past year, the City has been reviewing and updating how it interacts with individuals experiencing homelessness. The City has worked to minimize law enforcement interactions and use camping ordinances sparingly. Although there are significant law enforcement resources available in the area surrounding the Human Services Campus downtown, starting in 2020, the City shifted its practices in an attempt to decrease law enforcement contacts with unsheltered residents to minimize conflicts with law enforcement. The goal of the Office of Homeless Solutions is to find housing solutions and offer social services. The City has been working with providers to offer resources to the unsheltered.
- 24. Although the City has worked diligently to minimize law enforcement responses during homeless encampment cleanups, there are times when law enforcement presence is necessary. To minimize the risk of confrontation, the Office of Homeless Solutions has developed protocols for an enhanced cleanup of the Human Services Campus and treatment of property during those cleanups. The City will have law enforcement available if there are any public safety concerns, including threats or violence, but the City intends to request voluntary compliance. If, however, people refuse to temporarily relocate to allow for cleaning, and are otherwise capable of relocating with options for them to move to, then the City may ask for law enforcement assistance to assess options.
- 25. The City has engaged with advocates for the unsheltered, including Elizabeth Venable, who provided a declaration in support of Plaintiff's Motion for Preliminary Injunction.

  Ms. Venable has previously raised concerns to the City Council of the City of Phoenix regarding the City's treatment of unsheltered residents. The City has listened to the concerns and

attempted to address the issues. Indeed, City staff asked Ms. Venable for additional information to assist in investigating her concerns. The City wants to understand what Ms. Venable observed in any specific incidents, including the date, time, and location of any law enforcement activity that allegedly did not comply with the City's policies. However, despite multiple attempts to obtain additional information from Ms. Venable, the City has not been able to collect information from her to launch a meaningful investigation or take any corrective action that may be needed, if indeed the concerns she raised occurred.

26. The City values its residents and takes all concerns of misconduct seriously. If information is provided about violations of law or policy by law enforcement or sanitation services, the City will review those concerns and assess appropriate steps to resolve any issues that are discovered.
