Re: Ending border officials' religious-freedom violations and their practice of trashing migrants' personal belongings

Dear Secretary Mayorkas:

On behalf of the Sikh Coalition, the American Civil Liberties Union (ACLU), the ACLU of Arizona, and the 162 undersigned organizations, we write to express our urgent concern regarding the severe mistreatment of migrants, whose personal belongings, including religious articles of faith, are being confiscated by U.S. Customs and Border Protection (CBP) and are frequently thrown in the trash. Moreover, recent reports reveal that CBP has been denying migrants meals that comply with their religious beliefs. These concerns are not new: many of the undersigned organizations have notified the Department of Homeland Security (DHS) of these egregious and illegal practices over a period of years. We are deeply troubled that CBP has repeatedly failed to take remedial action in response to these complaints, allowing border officials to continue flouting the law with apparent impunity.

Federal law protects the right of all people, including migrants, to practice their faith.³ However, as documented in ACLU and Sikh Coalition letters to CBP and DHS earlier this month,⁴ and in

media reports,⁵ border officials in the Yuma and Tucson Sectors are routinely confiscating and trashing Sikh migrants' turbans. In addition, Tucson border officials also are denying Sikh migrants vegetarian meals; some who have complained have reportedly been ordered to eat meat or starve.⁶ These practices blatantly violate the law and are contrary to the fundamental religious-freedom principles on which our country was founded.

For years, advocates and the media have repeatedly raised concerns about the seizure of religious headwear and other articles of faith, as well as the denial of religious diets by CBP.⁷ These practices not only affect Sikh individuals, but they also harm Muslim, Hindu, Jewish, and Christian migrants, among others.⁸ Furthermore, the unnecessary and cruel confiscation of migrants' personal belongings extends beyond religious items: CBP officials frequently force migrants, including those seeking asylum, to discard nearly all of their belongings, including important medications, identity documents, records relevant to individuals' asylum cases, and items of sentimental value.

Time after time, DHS officials have assured the public and stakeholders that they take these concerns seriously, yet the violations continue. Alarmingly, these abuses have gone on for so long that they appear to have become standard operating procedure at the border, supplanting CBP's own rules—which require religious sensitivity and the safeguarding of migrants' personal property. It is now time for immediate and decisive action, which must include an unambiguous

statement of policy prohibiting this misconduct and detailing strict enforcement against any official or individual who violates that policy. Beyond these initial steps, DHS leadership must undertake a full-scale reckoning of CBP's and other agencies' brazen disregard for migrants' religious freedom and other rights.

All migrants must be treated with dignity, and their rights must be respected. Seizing their religious garb, texts, and other items—and then also dispossessing them of medication, money, documentation, clothing, and other important personal items—increases migrants' vulnerability. It also burdens state and local governments, as well as non-governmental organizations, that work to support migrants' integration upon their release from DHS custody, undercutting a pillar of the border security preparedness plan DHS released in April of this year. ¹⁰ Finally, these practices, combined with other religious-freedom violations by CBP, exacerbate the religious oppression that many migrants previously suffered in their home countries and are now seeking to escape. They should not be subjected to further discrimination in a nation that claims to be a bastion of equality and religious liberty.

These violations cannot be allowed to continue unabated. While we welcome a full investigation of these practices across all border entry points, we urge you to take immediate action *now* to correct these harms and protect the civil rights and civil liberties of migrants. We also stress the importance of full transparency and continuous stakeholder engagement regarding these issues. We look forward to your leadership in ensuring that no migrant, regardless of faith or background, will be subjected to discrimination and abuse at the hands of the U.S. government.
