ACLU Vote Recommendation Opposing SA 400

Senator David Vitter (R-LA) may offer an amendment to S. Con. Res. 8 requiring a valid government-issued photograph ID for voting in federal elections.

The American Civil Liberties Union recommends a NO vote on the Vitter amendment.

<u>Vote NO on the Vitter amendment because a voter ID requirement would deprive</u> <u>Americans of their fundamental right to cast a ballot.</u>

Voting is a fundamental right, protected by more constitutional amendments than any other right Americans enjoy. Requiring voters to obtain and produce a government-issued photo ID in order to vote in federal elections would deny that right to the millions of US citizens who do not have, and in many instances cannot obtain, such identification or afford the back-up documents required to obtain such an ID. Evidence shows that such a requirement would disproportionately prevent voters of color, students, voters with disabilities, low-income voters, and the elderly from exercising their fundamental right to cast a ballot.
