As you know, the Department of Justice has appealed to the Foreign Intelligence Surveillance Court of Review a July 19, 2002 Order of the Foreign Intelligence Surveillance Court. The July 19 Order granted the government's application for a surveillance order, but imposed conditions designed, in the FISC's words, "to protect the privacy of Americans in these highly intrusive surveillances and searches." Because privacy, freedom of expression, and other constitutional issues are central to this appeal, each of the undersigned organizations has an institutional interest in the questions presented. ¹

We are coordinating efforts to file amicus curiae brief(s) in relation to the appeal. It is our understanding that there are no directly applicable procedural rules. In the absence of such rules, we propose to submit our amicus curiae brief(s) by Sept. 20, 2002.
