Suleiman Abdullah Salim was referred for a physical and mental health evaluation by attorneys Amrit Singh of Open Society Justice Initiative, New York and Clara Gutteridge of Reprieve, UK. Mr. Salim's attorneys requested an evaluation of the nature and extent of any injuries and damages resulting from his incarceration by U.S. authorities in Kenya, Djbouti, and Afghanistan. Mr. Salim was informed of the limits of confidentiality in this evaluation, and he consented to be evaluated.

He was interviewed in Swahili with the assistance of a Swahili-speaking physician, Dr, Joan Nyanyuki.

Relevant Background Information: Mr. Salim reported having been born in Zanzibar, Tanzania, on September 25, 1972, one of 10 children. He stated that his father worked in a shop selling car and motorcycle parts, and also fished. He noted that his father drank alcohol to excess, and once spent 2 years in jail on a drinking related offense. His father died in 1999.

Mr. Salim reports that his only significant childhood illness was "tete kuwanga" (chicken pox) which required hospitalization. Mr. Salim reported that he did begin using recreational drugs starting at age 14 or 15 (hashish, petrol, mandrex, cocaine, and dried scorpion with marijuana). He last used drugs in 2003.

Mr. Salim reported he completed 10-11 years in school, but did not complete high school. He has worked various jobs, including as a tradesman and fisherman. Mr. Salim was married two weeks prior to his arrest in Somalia. He does not know the current whereabouts of his wife. Mr. Salim is Muslim, and describes himself as "slightly" religious. Before his arrest, Mr. Salim described his health as good, and after his release he described his health as poor, although he has noted improvement. Prior to his arrest, Mr. Salim described that he had no mental health problems.

He has not been able to work since his release from U.S.custody and return to Zanzibar in July 2008.

Description of Arrest: Mr. Salim reports he was captured on approximately March 15th or 16th 2003 in Somalia, where he was living. He reports that while driving a land
