Based on the Court's Opinions and Orders (#110, #136) issued August 28, 2013, and June 24, 2014, respectively, granting partial summary judgment in Plaintiffs' favor; the Court's Case-Management Order (#152) issued October 3, 2014; and Defendants' October 10, 2014, disclosure that the subset of Plaintiffs listed below are not currently on the No-Fly List, the Court ENTERS Judgment in favor of Plaintiffs Ayman Latif, Elias Mustafa Mohamed, Nagib Ali Ghaleb, Abdullatif Muthanna, Ibraheim Y. Mashal, Salah Ali Ahmed, and Mashaal Rana on Claims One and Three of Plaintiffs' Third Amended Complaint consistent with the Court's Orders (#110, #136, #152). This Judgment is based solely on the Court's previous orders and does not constitute any new adjudication of any of these named Plaintiffs' rights.

Based on the parties' agreement that these named Plaintiffs do not currently present the Court with a live case or controversy as to Claim Two, the Court DISMISSES without prejudice Claim Two as to Plaintiffs Ayman Latif, Elias Mustafa Mohamed, Nagib Ali Ghaleb, Abdullatif Muthanna, Ibraheim Y. Mashal, Salah Ali Ahmed, and Mashaal Rana.

Any claim by these named Plaintiffs for attorneys' fees and/or costs is deferred to the conclusion of this action as to all Plaintiffs. This Judgment does not adjudge prevailing-party status or any other issue pertinent to attorneys' fees. Upon

entry of a final judgment as to all claims and all parties, any party seeking an award of attorneys' fees and/or costs may file a motion seeking such an award pursuant to Federal Rule of Civil Procedure 54(d).
