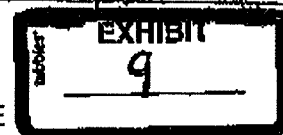

Mr. Garbi told me that he has been fighting to keep me as his neighbor. He was told that I was a bad influence and that I simply "knew too much". They were very agitated when he told them that I when he ~~also~~ advised him to accept seeing his lawyer Rausch. He ~~or~~ simply sought my advice and I told him to see him. His <sup>JTF</sup> team told him never to listen to me. They are fighting tooth and nail to kick me out or at least to eliminate my "bad influence".

Let me give you some context. When I was moved about six months ago ~~with~~ without my consent nor even informing me, I was deprived of my so called comfort item. His ~~to~~ prosecuting team offered to help me on condition to ask the court to lift its order regarding my interrogation. I was so desperate so I accepted. I wrote a letter to his leading interrogator Mr. [REDACTED] and asked him to contact you and arrange whatever ~~arrange~~ I wrote you about this. ~~Also~~ Whenever my co detainee asked me what to do I always told him what I would do, i.e. completely

sticking to my deal and never look back. That happened on many occasions, when not asked I didn't volunteer. About two months ago Ahmed ~~asked~~ told me that Ramzi called to see him and he didn't know what to do. I told him I would see him if it were me but that I didn't know what he should do. After he met both Ramzi and his JTF team he told me that the latter was upset ~~with~~ and once more he sought my advice about what to do to repair the spat. Again I was shocked ~~by~~ I didn't know the existence of bad blood. As a matter of fact I felt bad and wished I didn't respond to ~~offer~~ offer him any opinion. But since I already did I felt to have to repair. I told him in that case you should follow the advice of your interrogators
